The case was discussed in 666th SEIAA meeting dtd 17.03.2021 and it has been recorded that

" The prior EC was issued to Shri Ritesh Amole S/o Shri Laxman Amole R/o Village - Khami, Tehsil - Barghat, District - Seoni (MP) by DEIAA, Dist. - Jabalpur vide L.No. 139/DEIAA/17 dated 08.11.2017 for an area of 2.0 ha. for production capacity of 14594 cum per annum at Khasra No. 29 at Village - Badiyakheda, Tehsil - Jabalpur, Dist. - Jabalpur (MP).

Applicant Shri Deepchand Patel, 143, Singaldeep, Indrana, Dist. - Jabalpur, MP - 482001 (MP) has submitted the following documents in support of his request:

- d) Copy of Environmental Management Plan of Shri Deepchand Patel, 143, Singaldeep, Indrana, Dist. Jabalpur, MP - 482001 (MP).
- e) Copy of Approved Mining Plan of Shri Deepchand Patel, 143, Singaldeep, Indrana, Dist. Jabalpur, MP 482001 (MP).
- f) Lease transfer letter issued by Office of the Collector (Mining Division) to Shri Deepchand Patel, 143, Singaldeep, Indrana, Dist. Jabalpur, MP - 482001 (MP) vide Letter No. 864/ khanij/Q.L./2019-20 dated 04.07.2019.

As per the notification issued by MoEF&CC on 14.09.2006, the policy on transferability of EC is as follows:-

11. Transferability of Environmental Clearance (EC):

Case no. 8313/2021 1 of 2

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

After detailed discussions on the MoEF&CC Notification regarding transferability and perusal of the above information, it has been decided to transfer the Prior EC issued by DEIAA, Dist. - Jabalpur on 08.11.2017 in the name of "Shri Ritesh Amole S/o Shri Laxman Amole R/o Village Khami, Tehsil Barghat, District Seoni (MP)" is hereby transferred to "Shri Deepchand Patel, 143, Singaldeep, Indrana, Dist. Jabalpur, MP - 482001 (MP)" for Stone Quarry in an area of 2.0 ha. for production capacity of 14594 cum per annum at Khasra No. 29 at Village - Badiyakheda, Tehsil - Jabalpur, Dist. Jabalpur (MP) on the same terms & conditions and validity period under which the prior Environmental Clearance was initially granted".

Hence, it was decided to transfer the Prior EC in the name of Shri Deepchand Patel, 143, Singaldeep, Indrana, Dist. - Jabalpur, MP - 482001 (MP) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
