11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued on 11.04.2017 in the name of "M/s Arcons Infra & Construction Pvt.Ltd., Prop. Shri Rajesh Agarwal, Nagpur Road District Chhindwara (MP) is hereby transferred to Shri Chetan Chadda, Sausar, Dist. Chhindwara, (MP) – 480106 for Stone Quarry in an area of 1.594 ha for production capacity of 18458 cum per annum at Khasra No. 3/3 at Village - Khaperkheda, Tehsil - Sausar, Dist. Chhindwara (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly.

Hence, it was decided to transfer the Prior EC in the name of Shri Chetan Chadda, Sausar, Dist. Chhindwara, (MP) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
