Chhatarpur (MP) by Shri Ravikant Chaurasia S/o Shri Deendayal Chaurasia R/o Matwanapura Mahoba UP.

- (4) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.
 - Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued on' 4.3.2017 in the name of " Shri Ravikant Chaurasia S/o Shri Deendayal Chaurasia R/o Matwanapura Mahoba UP., is hereby transferred to M/s Jai Shri Krishna Granite, Shri Sapan Agarwal, Partnerr, Gram-Didwara, Tehsil - Lavkushnagar, Dist. Chhatarpur - for Stone Quarry in an area of 4.0 ha. for production capacity of 174000 cum per annum at Khasra No. 1215/1 at Village -Didwara, Tehsil - Lavkushnagar, Dist.
