Sub:- Case No. 8531/2021 Prior Environment Clearance for **Stone Quarry** in an area of 3.0 ha. for production capacity of 18000 cum per annum at Khasra No. 207/1 at Village - Gajna, Tehsil - Nainpur, Dist. Mandla (MP) by M/s Maa Narmada Stone Crusher, Partner Shri Himmat Singh Thakur, Village - Gajna, Tehsil - Nainpur, Dist. Mandla, MP.

The case was discussed in 674th SEIAA meeting dtd 07.04.2021 and it has been recorded that

- (1) " It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry in an area of 3.0 ha. for production capacity of 18000 cum per annum at Khasra No. 207/1 at Village - Gajna, Tehsil - Nainpur, Dist. Mandla (MP) by M/s Maa Narmada Stone Crusher, Partner Shri Himmat Singh Thakur, Village - Gajna, Tehsil - Nainpur, Dist. Mandla, MP.
- (2) The Prior Environmental Clearance letter was issued by DEIAA vide L.No. 883/DEIAA/18 dated 09.07.18 in the name of M/s Ojas Minerals, Prop. Shri Mahendra Sihare S/o Late Shri Hajari Lal Sihare R/o Bijhiya Mandla District Mandla (MP).
- (3) It is noted that in support of his request the PP has submitted the following documents
 - i. No Objection Certificate in the form of Notarised Affidavit submitted by M/s Ojas Minerals, Prop. Shri Mahendra Sihare S/o Late Shri Hajari Lal Sihare R/o Bijhiya Mandla District Mandla (MP) for transfer of prior EC in the name of M/s Maa Narmada Stone Crusher, Partner Shri Himmat Singh Thakur, Village - Gajna, Tehsil - Nainpur, Dist. Mandla, MP.
 - ii. Notarised affidavit of M/s Maa Narmada Stone Crusher, Partner Shri Himmat Singh Thakur, Village - Gajna, Tehsil - Nainpur, Dist. Mandla, MP mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued..
 - iii. Copy of Prior EC issued by DEIAA vide letter No. 883/DEIAA/18 dated 09.07.2018.
 - iv. Copy of Environmental Management Plan of M/s Maa Narmada Stone Crusher, Partner Shri Himmat Singh Thakur, Village - Gajna, Tehsil - Nainpur, Dist. Mandla, MP.
 - v. Copy of Approved Mining Plan of M/s Maa Narmada Stone Crusher, Partner Shri Himmat Singh Thakur, Village - Gajna, Tehsil - Nainpur, Dist. Mandla, MP.
 - vi. Lease transfer letter issued by Office of Collector (Mining Division), Mandla to M/s Maa Narmada Stone Crusher, Partner Shri Himmat Singh Thakur, Village - Gajna, Tehsil - Nainpur, Dist. Mandla, MP vide letter No. /Khanij-1/2019/1068 dated 09.07.2019.
- (4) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

- (1) In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA on 09.07.18 in the name of "M/s Ojas Minerals, Prop. Shri Mahendra Sihare S/o Late Shri Hajari Lal Sihare R/o Bijhiya Mandla District Mandla (MP) is hereby transferred to M/s Maa Narmada Stone Crusher, Partner Shri Himmat Singh Thakur, Village - Gajna, Tehsil - Nainpur, Dist. Mandla, MP for Stone Quarry in an area of 3.0 ha. for production capacity of 18000 cum per annum at Khasra No. 207/1 at Village - Gajna, Tehsil - Nainpur, Dist. Mandla (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. **All concerned** be informed accordingly."

In view of above, prior EC issued to M/s Ojas Minerals, Prop. Shri Mahendra Sihare S/o Late Shri Hajari Lal Sihare R/o Bijhiya Mandla District Mandla (MP) by DEIAA vide letter No. 883/DEIAA/18 dated 09.07.2018 is hereby transferred to M/s Maa Narmada Stone Crusher, Partner Shri Himmat Singh Thakur, Village - Gajna, Tehsil - Nainpur, Dist. Mandla (MP) for Stone Quarry in an area of 3.0 ha. for production capacity of 18000 cum per annum at Khasra No. 207/1 at Village - Gajna, Tehsil - Nainpur, Dist. Mandla (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
