Sub:- Case No. 8538/2021 Prior Environment Clearance for **Stone Quarry** in an area of 1.150 ha. for production capacity of 11400 cum per annum at Khasra No. 776 at Village - Tatarpur, Tehsil - Bhandar, Dist. Datia (MP) by Shri Ramnaresh Singh Parmar, Panchwati Colony, Bahodapur, Dist. Gwalior, MP - 474010.

The case was discussed in 674th SEIAA meeting dtd 07.04.2021 and it has been recorded that

- (1) " It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry in an area of 1.150 ha. for production capacity of 11400 cum per annum at Khasra No. 776 at Village - Tatarpur, Tehsil - Bhandar, Dist. Datia (MP) by Shri Ramnaresh Singh Parmar, Panchwati Colony, Bahodapur, Dist. Gwalior, MP - 474010.
- (2) The Prior Environmental Clearance letter was issued by DEIAA vide L.No. Q/khani/3-6/(DEIAA)/61/2016/63-11 dated 07.10.16 in the name of **Smt. Madhu Bai W/o Shri Manoj Goyal R/o Jagjeevan Nagar, Kumharpura, District Gwalior (MP)**.
- (3) It is noted that in support of his request the PP has submitted the following documents
 - i. No Objection Certificate in the form of Notarised Affidavit submitted by **Smt. Madhu Bai W/o Shri Manoj Goyal R/o Jagjeevan Nagar, Kumharpura, District Gwalior (MP)** for transfer of prior EC in the name of **Shri Ramnaresh Singh Parmar, Panchwati Colony, Bahodapur, Dist. Gwalior, MP - 474010**.
 - ii. Notarised affidavit of **Shri Ramnaresh Singh Parmar, Panchwati Colony, Bahodapur, Dist. Gwalior, MP - 474010** mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued..
 - iii. Copy of Prior EC issued by DEIAA vide L.No. Q/khani/3-6/(DEIAA)/61/2016/63-11 dated 07.10.16.
 - iv. Copy of Environmental Management Plan of **Shri Ramnaresh Singh Parmar, Panchwati Colony, Bahodapur, Dist. Gwalior, MP - 474010**.
 - v. Copy of Approved Mining Plan of **Shri Ramnaresh Singh Parmar, Panchwati Colony, Bahodapur, Dist. Gwalior, MP - 474010**.
 - vi. Lease transfer letter issued by **Office of Collector (Mining Division), Datia to Shri Ramnaresh Singh Parmar, Panchwati Colony, Bahodapur, Dist. Gwalior, MP - 474010** vide letter No. Q/khani/3-6/08/2016/194-5 dated 25.02.2019.
- (4) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity

period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

- (1) In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA on 07.10.16 in the name of "Smt. Madhu Bai W/o Shri Manoj Goyal R/o Jagjeevan Nagar, Kumharpura, District Gwalior (MP) is hereby transferred to Shri Ramnaresh Singh Parmar, Panchwati Colony, Bahodapur, Dist. Gwalior, MP - 474010 for Stone Quarry in an area of 1.150 ha. for production capacity of 11400 cum per annum at Khasra No. 776 at Village - Tatarpur, Tehsil - Bhandar, Dist. Datia (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly."

In view of above, prior EC issued to Smt. Madhu Bai W/o Shri Manoj Goyal R/o Jagjeevan Nagar, Kumharpura, District Gwalior (MP) by DEIAA vide letter No. Q/khani/3-6/(DEIAA)/61/2016/63-11 dated 07.10.16 is hereby transferred to Shri Ramnaresh Singh Parmar, Panchwati Colony, Bahodapur, Dist. Gwalior, MP - 474010 for Stone Quarry in an area of 1.150 ha. for production capacity of 11400 cum per annum at Khasra No. 776 at Village - Tatarpur, Tehsil - Bhandar, Dist. Datia (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
