Datia (MP) by M/s Maa Pitambra Devi Stone Crusher LLP, Partner, Shri Manoj Kumar Singh, 8B/KK 25, Krishanpuram Devnagar, Dist. Agra, UP.
The case was discussed in 674th SEIAA meeting dtd 07.04.2021 and it has been recorded that

- (1) " It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry in an area of 4.0 ha. for production capacity of 45000 cum per annum at Khasra No. 523 at Village - Bilhari Kalan, Tehsil - Datia, Dist. Datia (MP) by M/s Maa Pitambra Devi Stone Crusher LLP, Partner, Shri Manoj Kumar Singh, 8B/KK 25, Krishanpuram Devnagar, Dist. Agra, UP.
- (2) The Prior Environmental Clearance letter was issued by DEIAA vide L.No. Q/khani/3-6/(DEIAA)/36839/2015/34-11 dated 10.06.16 in the name of **Shri Satish Chahar S/o Shri Govind Singh Chahar R/o 306, Kaveri Gold Apartment, Khadari District Agar Malwa (MP).**
- (3) It is noted that in support of his request the PP has submitted the following documents

No Objection Certificate in the form of Notarised Affidavit submitted by **Shri Satish Chahar S/o Shri Govind Singh Chahar R/o 306, Kaveri Gold Apartment, Khadari District Agar Malwa (MP)** for transfer of prior EC in the name of **M/s Maa Pitambra Devi Stone Crusher LLP, Partner, Shri Manoj Kumar Singh, 8B/KK 25, Krishanpuram Devnagar, Dist. Agra, UP.**
 - ii. Notarised affidavit of **M/s Maa Pitambra Devi Stone Crusher LLP, Partner, Shri Manoj Kumar Singh, 8B/KK 25, Krishanpuram Devnagar, Dist. Agra, UP** mentions that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued..
 - iii. Copy of Prior EC issued by DEIAA vide L.No. Q/khani/3-6/(DEIAA)/36839/2015/34-11 dated 10.06.16.

 - vi. Lease transfer letter issued by **Office of Collector (Mining Division), Datia** to **M/s Maa Pitambra Devi Stone Crusher LLP, Partner, Shri Manoj Kumar Singh, 8B/KK 25, Krishanpuram Devnagar, Dist. Agra, UP** vide letter No. 770/khani/3-6/38/2012 dated 21.09.2020.
- (4) It is noted that in EIA Notification 2006 as per **Para-11 Transferability of Environmental Clearance (EC)** there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the

transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

- (1) In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA on 10.06.16 in the name of " **Shri Satish Chahar S/o Shri Govind Singh Chahar R/o 306, Kaveri Gold Apartment, Khadari District Agar Malwa (MP)** is hereby transferred to **M/s Maa Pitambra Devi Stone Crusher LLP, Partner, Shri Manoj Kumar Singh, 8B/KK 25, Krishanpuram Devnagar, Dist. Agra, UP for Stone Quarry** in an area of 4.0 ha. for production capacity of 45000 cum per annum at Khasra No. 523 at Village - Bilhari Kalan, Tehsil - Datia, Dist. Datia (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. **All concerned** be informed accordingly."

In view of above, prior EC issued to **Shri Satish Chahar S/o Shri Govind Singh Chahar R/o 306, Kaveri Gold Apartment, Khadari District Agar Malwa (MP)** by DEIAA vide letter No. Q/khani/3-6/(DEIAA)/36839/2015/34-11 dated 10.06.16 is hereby transferred to **M/s Maa Pitambra Devi Stone Crusher LLP, Partner, Shri Manoj Kumar Singh, 8B/KK 25, Krishanpuram Devnagar, Dist. Agra, UP for Stone Quarry** in an area of 4.0 ha. for production capacity of 45000 cum per annum at Khasra No. 523 at Village - Bilhari Kalan, Tehsil - Datia, Dist. Datia (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
