- (1) "It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry in an area of 1.60 ha. for production capacity of 8460 cum per annum at Khasra No. 360/1 at Village - Basaahari, Tehsil - Khurai, Dist. - Sagar (MP) by Shri Pushpendra Patel S/o Shri Dulichand Patel, Village - Mazugwa, Tehsil & Dist. - Sagar - 470021.
- (2) The Prior Environmental Clearance letter was issued by DEIAA vide L.No. 128 DEIAA/2017 dated 27.03.2017 in the name of M/s Badkul Enterprises, Partner Shri Ajad Kumar Jain R/o Pathak Ward, Distt. – Sagar (MP).
- (3) It is noted that in support of his request the PP has submitted the following documents
  - No Objection Certificate in the form of Notarised Affidavit submitted by M/s Badkul Enterprises, Partner Shri Ajad Kumar Jain R/o Pathak Ward, Distt. - Sagar (MP) for transfer of prior EC in the name of Shri Pushpendra Patel S/o Shri Dulichand Patel, Village - Mazugwa, Tehsil & Dist. -Sagar - 470021 (MP).
  - Notarised affidavit of Shri Pushpendra Patel S/o Shri Dulichand Patel, Village Mazugwa, Tehsil & Dist. - Sagar (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
  - Copy of Prior EC issued by DEIAA vide letter no.128 DEIAA/2017 dated 27.03.2017. iii.
  - Copy of Environmental Management Plan of Shri Pushpendra Patel S/o Shri Dulichand Patel, iv. Village - Mazugwa, Tehsil & Dist. - Sagar (MP).
  - Copy of Approved Mining Plan of Shri Pushpendra Patel S/o Shri Dulichand Patel, Village -Mazugwa, Tehsil & Dist. - Sagar (MP).
  - Lease transfer order issued by Office of Collector (Mining Division), Sagar to Shri Pushpendra vi. Patel S/o Shri Dulichand Patel, Village - Mazugwa, Tehsil & Dist. - Sagar (MP) vide letter No. 636/Khanij/2020 dated 23.11.2020.
- (4) It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity

on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA on 27.03.2017 in the name of "M/s Badkul Enterprises, Partner Shri Ajad Kumar Jain R/o Pathak Ward, Distt. — Sagar (MP) is hereby transferred to Shri Pushpendra Patel S/o Shri Dulichand Patel, Village - Mazugwa, Tehsil & Dist. — Sagar — 470021 for Stone Quarry in an area of 1.60 ha. for production capacity of 8460 cum per annum at Khasra no. 360/1 Village - Basaahari, Tehsil - Khurai, Dist. — Sagar (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly."

In view of above, prior EC issued to M/s Badkul Enterprises, Partner Shri Ajad Kumar Jain R/o Pathak Ward, Distt. – Sagar (MP) by DEIAA vide L.No. 128 DEIAA/2017 dated 27.03.2017 is hereby transferred to Shri Pushpendra Patel S/o Shri Dulichand Patel, Village - Mazugwa, Tehsil & Dist. - Sagar – 470021 for Stone Quarry in an area of 1.60 ha. for production capacity of 8460 cum per annum at Khasra no. 360/1 Village - Basaahari, Tehsil - Khurai, Dist. – Sagar (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
