- The Prior Environmental Clearance letter was issued by DEIAA vide L.No. 74 DEIAA/2016 dated 03.09.2016 in the name of Shri Ankit Mishra S/o Shri Jagdev Mishra R/o P-279, Shivnagar, Damoh Naka, District - Jabalpur (MP).
- (3) It is noted that in support of his request the PP has submitted the following documents

 - Notarised affidavit of M/s Nayyar Goods Transport, House No. 785, Gupteswar Ward, Dist. -Jabalpur (MP) - 482001 mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued.
 - Copy of Prior EC issued by DEIAA vide letter no. L.No. 74 DEIAA/2016 dated 03.09.2016. iii.

 - It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC.

Para-11 :- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity

on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA on 03.09.2016 in the name of " Shri Ankit Mishra S/o Shri Jagdev Mishra R/o P-279, Shivnagar, Damoh Naka, District - Jabalpur (MP) is hereby transferred to M/s Nayyar Goods Transport, House No. 785, Gupteswar Ward, Dist. - Jabalpur (MP) - 482001 for Stone Quarry in an area of 1.00 ha. for production capacity of 14221 cum per annum at Khasra no. 74 Village - Dhadhra, Tehsil - Jabalpur, Dist. - Jabalpur (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted.
