1. " It is noted that the PP had applied in Form-7 for transfer of Prior Environmental Clearance for stone Quarry (Opencast Semi-mechanized Method) in an area of 3.250 ha. for production capacity of 42684 cum per annum at Khasra No. 5, at Village - Badaiyakheda, Tehsil - Jabalpur, Dist. Jabalpur (MP) by Shri Aditya Dubey S/o Late Shree Dinesh Prasad Dubey 621Dakshin Miloniganj, Jabalpur (MP)
2. The Prior Environmental Clearance letter was issued by DEIAA Jabalpur vide L.No. 137 dated 08.11.2017 in the name of Shri Aditya Dubey S/o Late Shree Dinesh Prasad Dubey 621Dakshin Miloniganj, Jabalpur (MP)
3. It is noted that in support of his request the PP has submitted the following documents:
 - i. No Objection Certificate in the form of Notarised Affidavit submitted by M/s Baglamukhi Stone Crusher, Partner Shree Rajeev Jain R/o D-9 Gandhi Nagar District- Gwalior (M.P.), for transfer of prior EC in the name of Shree Lalchand Amule S/o Shree Yamuna Prasad Amule R/o Village Khami, Barghat Seoni Dist - Seoni (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all the standard and specific conditions stipulated in the prior EC issued..
 - ii. Notarised affidavit of Shree Lalchand Amule S/o Shree Yamuna Prasad Amule R/o Village Khami, Barghat Seoni District Seoni (MP) commitment to comply all the standard and specific conditions stipulated in the prior EC .
 - iii. Copy of Prior EC issued by DEIAA Jabalpur vide L.No. 137 dated 08.11.2017
 - iv. Copy of Environmental Management Plan of Shree Lalchand Amule S/o Shree Yamuna Prasad Amule R/o Village Khami, Barghat Seoni District Seoni (MP)
 - v. Copy of Approved Mining Plan of M/s Shree Lalchand Amule S/o Shree Yamuna Prasad Amule R/o Village Khami, Barghat Seoni District Seoni (MP)

- i. Lease transfer order issued by Office of the Collector (Mining Division), Jabalpur to Shree Lalchand Amule S/o Shree Yamuna Prasad Amule R/o Village Khami, Barghat Seoni District Seoni (MP) vide letter No. 37/Khanij/10 Q.L/2017 dated 10.01.2020
- ii. It is noted that in EIA Notification 2006 as per Para-11 Transferability of Environmental Clearance (EC) there is a provision of transferring the EC:

Para - 11. Transferability of Environmental Clearance (EC):

A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases

In context of above it seems that PP has submitted adequate documents to make the change in the name of PP as per EIA Notification 2006 (Para-11). Hence, prior EC issued by DEIAA Jabalpur vide letter no 137 on 08.11.2017 in the name of " Shri Aditya Dubey S/o Late Shree Dinesh Prasad Dubey 621 Dakshin Miloniganj, Jabalpur (MP) is hereby transferred to Shree Lalchand Amule S/o Shree Yamuna Prasad Amule R/o Village Khami, Barghat Seoni District Seoni (MP) for Stone Quarry in an area of 3.250 ha. for production capacity of 42684 cum per annum at Khasra No. 5, at Village - Badaiyakheda, Tehsil - Jabalpur, Dist. Jabalpur (MP)." on the same terms & conditions and validity period under which the prior environmental clearance was initially granted. All concerned be informed accordingly".

Hence, it was decided to transfer the Prior EC in the name of Shree Lalchand Amule S/o Shree Yamuna Prasad Amule R/o Village Khami, Barghat Seoni District - Seoni (MP) with the same terms & conditions under which the Prior Environmental Clearance was initially granted, and for the same production capacity and validity period.
