Sub: - Case No. 1705/2013, Prior Environmental Clearance for Kandaka Limestone Mine (Open cast mechanized mining method) in an area of 5.00 ha area for expansion in production capacity from 5,000 cum/year to 5,00,000 M.T/year at Khasra No. 142/2 at Village Kandaka, Tehsil Jawad, Distt. Neemuch, M. P. by Shri Raghuraj Singh Chourdiya, S/o Shri Fateh Singh Chourdiya, Rajmandir Complex, Neemuch (M.P.).

This has reference to your letter received in SEIAA office on 11.07.2013 and subsequent letters seeking Prior Environmental Clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of provisions under the EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application viz., the Form - I, Pre-Feasibility Report, ToR and subsequently submission of EIA, Public Hearing and the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the

II. It has been noted that the proposal is for Kandaka Limestone Mine in an area of 5.0 ha. The mining lease area is located in Khasra Nos. 142/2 at Village Kandaka, Tehsil Jawad, Distt. Neemuch Mining site lies between Latitude 24°32'23.4" N to 24°32'31.1" N and Longitude 74°48'49.8" E to 74°48'57.3" E. The nearest village Jawad is located at the distance of 8 km. There is no National Park/Sanctuary within 10 Km radius. There is no forest boundary within 250m. from mining site.

The proposed project is for expansion in production capacity from 5000 cum/year to 5,00,000 MT/year. The mining will be carried out by Opencast Mechanized Mining Method. The water requirement is 15.KLD (5 KLD for Dust Suppression+ 3 KLD for Green Belt +1 KLD for Domestic purpose + 6 for KLD Allied mining activities). The water met from hand pump & tube well will be used for domestic purpose, dust suppression and green belt development. 1650 trees would be planted in an area of 1.65 ha at the end of lease period. The public hearing was conducted at village Kanka on 05.11.2015.

- III. The project has been considered in accordance with the provisions of the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14th September 2006.
- IV. Based on the information submitted, as at Para (II) above and others the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 320th meeting dtd. 21.04.2016 and decided to accept the recommendations of 09th SEAC-II meeting dtd. 24.02.2016.

Hence, Prior Environmental Clearance is granted for Kandaka Limestone Mine (Open cast mechanized mining method) in an area of 5.00 ha area for expansion in production capacity from 5,000 cum/year to 5,00,000 M.T/year at Khasra No. 142/2 at Village Kandaka, Tehsil Jawad, Distt. Neemuch, M. P for the lease period to Shri Raghuraj Singh Chourdiya, S/o Shri Fateh Singh Chourdiya, Rajmandir Complex, Neemuch (M.P), subject to the compliance of following specific conditions as recommended by SEIAA & SEAC and subsequent Standard Conditions.

A. Specific Conditions

- No transportation through the village, they will use the bypass road of the village. 1.
- 2. Complete lease area to be fenced.
- Controlled blasting to be done in only day time by pre intimation to the nearby villagers.



- Plantation to be done in 7.5 on periphery in 3 rows just after completion of fencing.
- Top soil shall be reserved for use in plantation.
- For consolidation of dumps retaining wall and toe wall should be properly constructed.
- A separate establishment with proper facility of toilet, drinking water, First –aid, rest room etc. to be provided within lease area for ladies, children, visitors, doctors, etc.
- 8. PP shall under take CSR activities in consultation with the District Administration. The identification of activities and its implementation shall be monitored by the District Administration. A complete village will have to be adopted by PP and provide demand driven activities like water supply, sanitation, up-gradation of internal village roads etc.
- No crusher unit within the mining lease area.
- To avoid dust emissions, continuous water spray on the transportation route to be undertaken by the PP.
- PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- 12. All the commitments made in the public hearing are to ne complied by the PP.
- Transportation of material shall be done in covered vehicles.
- Necessary consents shall be obtained from MPPCB and the air / water pollution control
 measures have to be installed as per the recommendation of MPPCB.
- Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.
- Curtaining of site shall be done through thick plantation all around the boundaries of the lease area.
- 17. Two additional settling tanks are to be provided in the northern and southern side of the area so that only supernatant mine discharge should meet the nearby natural drain.
- 18. No mining operations be carried out within the statutory safety zone for electrical line passing through the ML area upto it's shifting. Garland drain and check-dams shall be constructed all around the dumps to prevent and flow from the mining site.
- The proposed plantation should be carried out along with the mining and PP would maintain the plants for five years including casualty replacement.
- Appropriate activities shall be taken up for social up-liftment of the Region. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 21. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations

B. Standard Conditions

- All activities / mitigative measures proposed by PP in Environmental Impact Assessment and approved by SEAC must be ensured.
- All activities / mitigative measures proposed by PP in Environmental Management Plan and approved by SEAC must be ensured.
- All parameters listed in Environmental Monitoring Plan approved by SEAC must be monitored at approved locations and frequencies.
- Blast vibrations study shall be conducted and submitted to the Regional Office, MoEF, Gol, Bhopal and MP PCB within six months. The study shall also provide measures for prevention of blasting associated impact on nearby houses and agricultural fields.
- Controlled blasting techniques with sequential drilling shall be adopted. The blasting shall be carried out in the day time only.
- Slope of the mining bench and ultimate pit limit shall be as per the mining scheme approved by Indian Bureau of Mines.

- Regional Office, MoEF, Gol, Bhopal and MP PCB within 5 years in advance of final mine closure for approval.
- No change in the calendar plan including excavation, quantum of mineral and waste shall be made.
- Mining will be carried out as per the approved mining plan. In case of any violation of mining plan, the Environmental Clearance given by SEIAA will stand cancelled.
- Adequate buffer zone shall be maintained between two consecutive mineral bearing deposits.
- The transportation of the minerals extracted from the mining area shall be limited to day hours time only.
- Maintenance of near by local roads through which transportation of minerals are undertaken shall be carried out by the company regularly at its own expenses. The roads shall be black topped.
- 13. Measures for prevention and control of soil erosion and management of silt shall be undertaken. Protection of dumps against erosion shall be carried out with geo textile matting or other suitable material, and thick plantations of native trees and shrubs shall be carried out at the dump slopes. Dumps shall be protected by retaining walls.
- 14. Trenches / garland drains shall be constructed at foot of dumps and coco filters installed at regular intervals to arrest silt from being carried to water bodies. Adequate number of check dams and gully plugs shall be constructed across seasonal/ perennial Nallahs, if carried out.
- The project proponent will ensure necessary protection measures around the mine pit, waste dumps and garland drain.
- 16. Top soil / solid waste shall be stacked properly with proper slope and adequate safeguards and shall be utilized for backfilling (wherever applicable) for reclamation and rehabilitation of mined out area. Top soil shall be separately stacked for utilization later for reclamation and shall not be stacked along with over burden.
- 17. Over burden (OB) shall be stacked at earmarked dump site(s) only and shall not be kept active for long period. The maximum height of the dump shall not exceed 20 m, each stage shall preferably be of maximum 10 m and overall slope of the dump shall not exceed 35°. The OB dump shall be backfilled and shall be scientifically vegetated with suitable native species to prevent erosion & surface run off.
- Monitoring and management of rehabilitated areas shall continue until the vegetation becomes self-sustaining. Compliance status shall be submitted to the Regional Office, MoEF, Gol, Bhopal and MP PCB on six monthly basis.
- 19. Green belt development shall be carried out considering CPCB guidelines including selection of plant species and in consultation with the local DFO / Agriculture Deptt. Herbs & shrubs shall also form a part of afforestation programme besides tree plantation. The company shall involve local people for plantation programme. Details of year wise afforestation programme including rehabilitation of mined out area shall be submitted to the Regional Office, MoEF, Gol, Bhopal and MP PCB every year.
- 20. Vehicular emissions shall be kept under control and regularly monitored. Vehicles used for transportation of minerals and others shall have valid permissions as prescribed under Central Motor Vehicle Rules, 1989 and its amendments. The vehicles transporting minerals shall be covered with a tarpaulin or other suitable enclosures so that no dust particles / fine transportation shall be committed. The trucks transporting minerals shall not pass through wild life sanctuary, if any in the study area.
- 21. Four ambient air quality-monitoring stations shall be established in the core zone as well as in the buffer zone for RSPM, SPM, SO₂, NO_x monitoring. Location of the stations should be decided based on the meteorological data, topographical features and environmentally and ecologically sensitive targets and frequency of monitoring should be undertaken in consultation with the State Pollution Control Board. The monitored data for criteria



- Data on ambient air quality (RPM, SPM, S0₂, NO_x) should be regularly submitted to the Regional office, MoEF, Gol, Bhopal and the State Pollution Control Board / Central Pollution Control Board once in six months.
- Ambient air quality at the boundary of the mine premises shall confirm to the norms prescribed in MoEF notification no. GSR/826(E) dtd. 16.11.09.
- 24. Fugitive dust emissions from all the sources shall be controlled. Water spraying arrangement on haul roads, loading and unloading and at transfer points shall be provided and properly maintained. The dust emission shall be monitored regularly as per norms and records to be submitted to the Regional Office, MoEF, GoI, Bhopal and MP PCB regularly.
- 25. Measures shall be taken for control of noise levels below 75 dBA in the work environment. Workers engaged in operations of HEMM, etc., shall be provided with ear plugs / muffs and health records of the workers shall be maintained.
- 26. Rain water harvesting shall be undertaken to recharge the ground water source. Status of implementation shall be submitted to the Regional Office, MoEF, Gol, Bhopal and MP PCB within six months and thereafter every year from the next consequent year.
- 27. Regular monitoring of ground and surface water sources for level and quality shall be carried out by establishing a network of existing wells and constructing new piezometers during the mining operation. The monitoring shall be carried out four times in a year i.e. pre-monsoon (April-May), monsoon (August), post-monsoon (November) and winter (January) and the data thus collected shall be regularly sent to Regional Office, MoEF, Ground Water Board.
- 28. The waste water from the mine if any, shall be treated to conform to the standards prescribed under GSR 422 (E) dated 19th May, 1993 and 31st December, 1993 or as amended from time to time. The oil and grease trap shall be installed for the effluents generated from the workshop, if any, before discharging into the natural stream. The discharged water from the tailing dam, if any shall be regularly monitored and report submitted to the Regional Office, Ministry of Environment & Forests, Gol, Bhopal, Central Pollution Control Board, and the State Pollution Control Board.
- 29. Hydro-geological study of the area shall be reviewed by the project proponent annually. In case adverse effect on ground water quality and quantity is observed mining shall be stopped and resumed only after mitigating steps to contain any adverse impact on ground water is implemented.
- 30. Occupational health check up for the workers including identification of work related health hazards, training on malaria eradication, HIV, and health effects on exposure to mineral dust etc. shall be carried out. Periodic monitoring for exposure to respirable mineral dust on the workers shall be conducted and records maintained including health records of the workers. Awareness programme for workers on impact of mining on their health and precautionary measures like use of personal equipments etc. shall be carried out periodically. Review of impact of various health measures shall be conducted followed by asked. Necessary funds for this also should be earmarked.
- Project Proponent shall ensure appropriate arrangement for shelter and drinking water for the mine workers.
- 32. Persons working in dusty areas shall be provided with protective respiratory devices and they shall also be imparted adequate training and information on safety and health aspects.
- 33. Commitment towards CSR have to be followed strictly.
- 34. Special measures shall be adopted to prevent the nearby settlements from the impacts of mining activities.
- 35. The Project Proponent shall inform to the Regional Office, MoEF, Gol, Bhopal and MP PCB regarding date of financial closures and final approval of the project by the concerned authorities and the date of start of land development work.
- 36. The necessary funds as per mandate shall kept for environmental protective measures

- PCB. Wise expenditure shall be reported to the Regional Office, MoEF, Gol, Bhopal and MP
- 37. The Regional Office, MoEF, Gol, Bhopal and MP PCB shall monitor compliance of the stipulated conditions. A complete set of documents including Environment Impact Assessment Report, Environmental Management Plan, Public hearing and other relevant documents should be given to Regional Office, MoEF, Gol, Bhopal and MP PCB.
- 38. A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of the Local Bodies, Panchayat and Municipal Bodies, as applicable, in addition to the relevant officers of the Government who in turn has to display the same for 30 days from the date of receipt.
- 39. The Project Proponent shall advertise at least in two local newspapers widely circulated, one of which shall be in the vernacular language of the locality concerned, within 7 days of the issue of the clearance letter informing that the project has been accorded environmental clearance and a copy of the clearance letter is available with the State Pollution Control Board and also at web site of the State Level Environment Impact Assessment Authority (SEIAA) website at www.mpseiaa.nic.in and a copy of the same shall be forwarded to the Regional Office, MoEF, Gol, Bhopal.
- 40. The project proponent has to strictly follow directions/guideline issued by the MoEF, Gol, CPCB and other Govt. agencies from time to time.
- 41. Action plan with respect to suggestion/improvement and recommendations made and agreed during public hearing consultation shall be submitted to the Regional Office, MoEF, Gol, Bhopal, MP PCB and to the competent authority of the State Govt. within six months.
- 42. The Project Proponent has to submit half yearly compliance report of the stipulated prior environmental clearance terms and conditions in hard and soft copy to the Regulatory Authority on 1st June and 1st December of each calendar year.
- 43. The SEIAA of M.P. reserves the right to add additional safeguard measures subsequently, if found necessary, and to take action including revoking of the environment clearance under the provisions of the Environmental (Protection) Act, 1986, to ensure effective implementation of the suggested safeguard measures in a time bound and satisfactory manner.
- 44. These stipulations would be enforced among others under the provisions of Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and control of Pollution) Act 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1991 and EIA Notification, 2006.
- 45. The Ministry or any other competent authority may alter/modify the conditions or stipulate any further condition in the interest of environment protection.
- 46. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- Any appeal against this prior environmental clearance shall lie with the Green Tribunal, if necessary, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
- 48. All other statutory clearances such as the approvals for storage of diesel from Chief Controller of Explosives, Fire Department, Civil Aviation Department, Forest Conservation Act, 1980 and Wildlife (Protection) Act, 1972 etc. shall be obtained, as applicable by project proponents from the respective competent authorities.
- 49. The proponent shall upload the status of compliance of the stipulated EC conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the Regional Office of MoEF, the respective Zonal Office of CPCB and the SPCB. The criteria pollutant levels namely; SPM, RSPM, SO₂, NOx (ambient levels as well as stack emissions) or critical sectoral parameters, indicated for the project shall be monitored and displayed at a convenient location near the main gate of the company in the public domain.
