Sub: Case No. 4240/2015 Prior Environmental Clearance for Metal Stone Quarry (Opencast manual/Semi- Mechanized Method) in an area of 2.0 ha. for production capacity of 1,15,000 m3/year at Khasra No. 02 (P) at Village – Manegaon, Tehsil -Jabalpur, District-Jabalpur (M.P) by M/s Bhasin Real Estate, Shri Gaurav Bhanot, R/o 1101 Bhanot House, Gorakhpur Jabalpur, District- Jabalpur (MP) – 482001

This has reference to your letter received in SEIAA office on 31.10.2015 and subsequent letters seeking Prior Environmental Clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of provisions under the EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application viz., the Form – I, Appendix-1 Mining Plan & EMP, the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC-II) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

- II. There is no National Park/Sanctuary within 10 Km radius. There is no human settlement/ waterbody within 500 m. from mining site. There is no Forest boundary within 250m distance from mining site.
- III. The project has been considered in accordance with the provisions of the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14th September 2006.
- IV. Based on the information submitted, as at Para (II) above and others the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 337<sup>th</sup> meeting dtd 03.06.2016 and decided to accept the recommendations of 26<sup>rd</sup> SEAC-II meeting dtd. 24.05.2016.

Considering the recommendation of 26th SEAC-II meeting dtd. 24.05.2016, Prior Environmental Clearance is granted for Metal Stone Quarry (Opencast manual /Semi- Mechanized Method) in an area of 2.0 ha. for production capacity of 1,15,000 m3/year at Khasra No. 02 (P) at Village – Manegaon, Tehsil -Jabalpur , District- Jabalpur (M.P) for the lease period to M/s Bhasin Real Estate, Shri Gaurav Bhanot, R/o 1101 Bhanot House, Gorakhpur Jabalpur, District- Jabalpur (MP) – 482001, subject to the compliance of following specific conditions as recommended by SEIAA & SEAC and subsequent Standard Conditions.

## A. Specific Conditions

- 1. PP shall not start mining activity before execution of lease agreement.
- 2. The depth of the pit shall be as per the Approved Mining Plan.



- Adequate plantation should be carried out along the haul road and road connecting to the main road.
- Mechanical Spraying of water on existing metal haul road and transportation road through fix types of sprinklers.
- Controlled blasting was suggested under the supervision of certified blasters as per DGMS norms.
- Sufficient warning by signal is given over the entire area falling within the danger zone and it must be ensured that all persons within such area have taken proper shelter.
- Wet drilling for blasting is to be done in hand holes & as well as jack hammer drilling.
- 8. Suitable air respirators should be provided to the drillers.
- The metal road (till it is converted in tar road) should be maintained by the PP for smooth operations of vehicles.
- 10. Garland drains with settling pit of suitable capacity should be provided to avoid any runoff in nearby fields and the surface runoff should be collected in a nearby mined out pit which also belongs to the same PP for gardening and sprinkling
- 11. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 12. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
- 13. Transportation of material shall be done in covered vehicles.
- 14. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
- 15. Curtaining of site shall be done using appropriate media.
- 16. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement.
- 17. Transportation shall not be carried out through forest area.
- Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 19. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 20. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded and in extream summer season hourly road wetting be done.
- 21. PP should also maintain a log book containing annual details of tree plantation and causality replacement.
- 22. Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.

## B. Standard Conditions

- Controlled blasting techniques, as and when required, shall be carried out in the day time only.
- Mining will be carried out as per the approved Mining Plan. In case of any violation of Mining Plan the Environmental Clearance given by SEIAA will stand cancelled.
- Effective safeguard measures, such as regular water sprinkling shall be carried out in critical areas prone to air pollution and having high levels of particulate matter such as loading and unloading point and all transfer points.
- 4. Where the quarry is in a hilly terrain and where some part of the hill is already cut for quarrying, further hill cutting shall not be done. In such cases, deepening the existing operational area may be preferably done.



- Precise mining area will be jointly demarcated at site by officials of Mining/Revenue department prior to mining operations for all proposals under consideration.
- The lease holder shall obtain necessary prior permission of the competent authorities for drawal of requisite quantity of water (surface water and groundwater), if required for the project.
- Parking of vehicles should not be made on public places.
- Special Measures shall be adopted to prevent the nearby settlements from the impacts of mining activities. Maintenance of roads through which transportation of minor minerals is to be undertaken, shall be carried-out regularly.
- Measures for prevention and control of soil erosion and management of silt shall be undertaken.
- Trenches / garland drains shall be constructed at foot of dumps to arrest silt from being carried to water bodies.
- The project proponent will ensure necessary protection measures around the mine pit, waste dumps and garland drain.
- 12. Top soil / solid waste shall be stacked properly with proper slope and adequate safeguards and shall be utilized for backfilling (wherever applicable) for reclamation and rehabilitation of mined out area.
- 13. Plantation programme shall be carried out as per EMP. Self sustenance of the vegetation should be ensured. No tree-felling shall be done in the leased area, except only with the permission from competent authority.
- 14. The vehicles transporting minerals shall be covered with a tarpaulin or other suitable enclosures so that no dust particles / fine matters escape during the course of transportation.
- Project Proponent shall ensure appropriate arrangement for shelter and drinking water for the mine workers.
- 16. Persons working in dusty areas shall be provided with protective respiratory devices and they shall also be imparted adequate training and information on safety and health aspects.
- 17. Dispensary facilities for first-aid shall be provided at site.
- 18. A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of the Local Bodies, Panchayat and Municipal Bodies, as applicable, in addition to the relevant officers of the Government
- 19. The Ministry or any other competent authority may alter/modify the conditions or stipulate any further condition in the interest of environment protection.
- Concealing factual data or submission of false/fabricated data and failure to comply
  with any of the conditions mentioned above may result in withdrawal of this clearance
  and attract action under the provisions of Environment (Protection) Act, 1986.
- 21. Any appeal against this prior environmental clearance shall lie with the Green Tribunal, if necessary, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
