With reference to above, the proposal has been appraised as per prescribed procedure & provisions under the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14<sup>th</sup> September 2006 and its amendment, on the basis of the mandatory documents enclosed with the application viz., Form I, Form IA, Conceptual Plan, drawings, ppt & the additional clarifications furnished in response to the observations by the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

(i). The proposed project is a building construction of Hospital Building with 200 beds along with guest house having total built up area 42207.76 sq.m. The project comes under category (B) for project activity 8(a) of schedule of EIA Notification, 2006 because total construction is between 20,000 sq.m & 1,50,000 sq. m and plot area is less than 50 ha.

- (ii). As per Joint Director Town & Country Planning, Indore (6458 dtd 25.08.2014) the total land area is 18071.09 sq.m. at Village-Chitawad, Tehsil & District-Indore (MP). As per Khasra Panchsala the land (13830 sq.m.) is in the name of M/s Vishesh Diagnostics Pvt. Ltd. through Managing Director Shri Rajesh Kasliwal and Plot No. 2, ring Road, Yojna No. 94, Sector-1 allotted by IDA in favour of M/s Vishesh Diagnostics Pvt. Ltd. through Managing Director Shri Rajesh Kasliwal.
- (iii). The source of water supply is Indore Municipal Corporation (letter dtd. 20.11.2015. The total water requirement is 270 KLD (fresh water 145 KLD). The waste water generation is 162.5 KLD and STP capacity is 155 KLD. The available treated water is 131 KLD which is proposed to be 125 KLD recycled and remaining 06 KLD is proposed to be disposed in sewer line. PP has submitted letter (dtd. 20.11.2015) from Nagar Nigam, Indore for disposal of extra treated waste water.
- (iv). The MSW (0.25 TPD) shall be generated which is proposed to be segregated at source and the biodegradable and non-recyclable/ non biodegradable waste will be stored and collected separately. Colored collection bins shall be provided in proper numbers. Final disposal through Municipal Corporation Indore. PP has submitted NOC from Indore Municipal Corporation letter (dtd. 09.11.2015) for disposal of solid waste.
- (v). Bio Medical waste approximately 0.06 ton per day will be generated. PP has proposed the Bio Medical waste shall be collected and stored in coloured coded bins and disposed as per the BMW (Management & Handling) Rules 1998 and its amendment. PP has submitted letter dtd. 01.03.2016 from Hoswin Incinerators Pvt. Ltd. Indore for disposal of BMW.
- (vi). The maximum height of the building is stilt + 24 m. PP has provided Front MOS 9.0 m and side / rear MOS 6.0 m.
- (vii). PP has proposed to provide latest analog addressable fire alarm system with use of photo electric heat and multi criteria detectors. This system is capable of pin pointing the source of fire immediately since its detection also gives the exact location of its placements. This fire alarm system will also have inbuilt voice evacuation system.
- (viii). PP has proposed to provide 312 ECS (Basement-1 area 3226.0 sq.m.& basement-2 area 7717 sqmt. & open parking).
- (ix). The total power requirement is 2343 KW. The source of electricity is Madhya Pradesh Kshetra Vidyut Vitran Company Limited. PP has also provided power back up 2 x 1250 KVA. For control of energy PP has proposed Solar lighting is proposed for open spaces, LED lighting, chiler water system using screw chiler Solar-PV (2% of power will utilize) etc.
- (x). PP has proposed to provide roof top rain water harvesting system with 04 nos. of recharging pits.
- (xi). PP has proposed an area of 2168.53 sq.m (12%) to be developed as green area including 550 no. of species. PP has submitted 15 nos. of trees already exists in the project site which is proposed to be developed as landscape area.

Based on the information submitted at Para i to xi above and others, the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 322<sup>nd</sup> meeting held on 23.04.2016 and decided to accept the recommendations of SEAC meetings 272<sup>nd</sup> dtd 31.03.2016.

Hence, Prior Environmental Clearance is accorded under the provisions of EIA notification dtd. 14<sup>th</sup> September 2006 & its amendments to the proposed proposed Nursing Home & Hospital at Khasra No. 89/1/1, 89/1/2, 89/1/3, 90/1, 91/2, 91/3, 92/2/1, 97/2, & Plot No. 2, Ring Road, Yojna No. 94, Sector-1, Village-Chitawad, Tehsil & District-Indore (MP), Land Area -18071.09 sq.m., Built-up Area-42207.76 sq.m. by Shri Rajesh Kasliwal, Managing Director, M/s Vishesh Diagnostics Pvt. Ltd., A.B. Road, Geeta Bhawan Chouraha, Indore (MP)-452001 with following Specific Conditions as recommended by SEIAA & SEAC in its meetings along with the Standard Conditions enclosed at **Annex-I**.

## A. Specific Conditions as recommended by SEIAA

- (1) The entire demand of water should be met through Municipal Corporation; Indore there should be no extraction of ground water.
- (2) PP should ensure linkage with municipal sewer line for disposal of waste water.
- (3) Municipal Solid Waste:
  - (a) Provide compactors for MSW
  - (b) Ensure three bin systems for segregated collection of waste.
  - (c) Ensure linkage with Municipal Corporation for final disposal of MSW.
- (4) PP should ensure the disposal of Bio-Medical Waste as per the Bio Medical Waste (Handling & Management) Rules 1998 and its amendments.
- (5) PP should ensure road width at least 18 m; Front MOS 9 m and side / rear MOS 6 m. road width; MOS and Open spaces as per MPBVR 2012 rule 42 (1) for building height upto 24m.
- (6) For firefighting:
  - (a) PP should ensure connectivity to the fire station from the project site.
  - (b) As per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Nagar Nigam, Indore) incorporating all the fire fighting measures recommended in National Building Code Part – IV point no. 3.4.6.1. The occupancy permit shall be issued by Nagar Nigam only after ensuring that all fire fighting measures are physically in place.
- (7) PP should ensure the rain water harvesting. In addition, PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.
- (8) PP should ensure installation of photovoltaic cells (solar energy) for lighting in common areas, LED light fixtures, and other energy efficient equipments.

- (9) PP should ensure car parking as per Rule no. 84 (1) Table Clause 1 (3) S. No. 3 of MPBVR 2012.
- (10) PP should ensure to provide special facilities for physically handicapped persons and BPL families and also provide preference during the treatment.
- (11) Green belt :-
  - (a) PP should ensure plantation to the 2168.53 sq.m (12%) as per the proposed landscape plan. Plantation should be done in two rows all along the periphery of the project area including Avenue plantation along the roads, trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar etc. along with ornamental varieties.
  - (b) PP should ensure to develop the existing green area as landscape by including further facilities for public use.
  - (c) PP should ensure to develop front area of the building as an additional green belt.
  - (d) Every effort should be made to protect the existing trees on the plot.
- (12) The grant of Environmental Clearance should be subject to statutory permission of National Board of Wild Life. PP should obtain wild life clearance from NBWL and submit copy to MPSEIAA.

# B. Specific Conditions as recommended by SEAC

- (13) Fresh water requirement for the project shall not exceed 145 KLD..
- (14) The excess treated water will be used for watering of municipal road side green area or efforts shall be made to supply this water to the construction sites for use in the construction works.
- (15) Peripheral plantation all around the project boundary shall be carried out using tall saplings of minimum 2 meters height of species which are fast growing with thick canopy cover preferably of perennial green nature. As proposed in the landscape plan & EMP a minimum of 550 numbers of trees will be planted in the premises. PP will also make necessary arrangements for the causality replacement and maintenance of the plants.
- (16) STP sludge shall be filter-pressed and the de-watered sludge shall be disposed off with the MSW.
- (17) Power back-up for un-interrupted operations of STP shall be ensured.
- (18) CFL/LED should be preferred over of tube lights.
- (19) Installation of solar photovoltaic cells for lighting system for common areas of basement should be provided and should explore the possibility of using solar lightning in OPDs.
- (20) Fund should be exclusively earmarked for the implementation of EMP.
- (21) MSW storage area should have 48 hours storage capacity.

- (22) Dual plumbing should be provided for guest house building and IPD section of the hospital.
- (23) Fire alert system should be linked with the district alert system.
- (24) PP should explore the possibility for "Green Building Ratings".
- (25) Provision for physically challenged persons be made so that they easily excess pathway/derive way for their vehicles.
- (26) Provisions shall be made for the housing of construction labour within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile toilets, mobile STP, safe drinking water, medical health care, crèche etc. The housing may be in the form of temporary structure to be removed after completion of the period.
- (27) PP will obtain other necessary clearances/NOC from concerned authorities.

Annex-I

Standard Conditions related to under item 8 (a) & 8 (b) of the schedule of EIA notification, 2006 (Building/ construction projects / area development projects & township)

#### A. Construction Phase

- The construction site shall be provided with adequately barricades of at least 3 m height on its periphery with adequate signage.
- 2 All required sanitary and hygienic measures should be in place before starting any construction work and are to be maintained throughout the project phase.
- 3. Provision shall be made for the housing of construction labour within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile foilets, safe drinking water, medical health care, creche etc. The housing may be in the form of temporary structures to be removed after the completion of the project.
- 4. Occupational health and safety measures for the workers including identification of work related health hazards, training on malaria eradication, HIV, and health effects on exposure to dust etc. shall be carried out. Periodic monitoring for exposure to respirable dust on the workers shall be conducted and records maintained including health records of the workers. Awareness programme for workers on impact of dust on their health and precautionary measures like use of personal equipments etc. shall be carried out periodically.
- 5. A First Aid Room will be provided in the project both during construction and operation of the project.
- 6. All the topsoil excavated during construction activities should be stored for use in horticulture/landscape development within the project site.
- 7. Disposal of muck during construction phase should not create any adverse effect on the neighbouring communities and be disposed taking the necessary precautions for general safety and health aspects of people, only in approved sites with the approval of competent authority.
- 8. Soil and ground water samples will be tested to ascertain that there is no threat to ground water quality by leaching of heavy metals and other toxic contaminants.
- Construction spoils, including bituminous material and other hazardous materials, must not be allowed to contaminate water courses and the dump sites for such material must be secured so that they should not leach into the ground water.

10. Any hazardous waste generated during construction phase, should be disposed off as per applicable rules and norms with necessary approvals of the M.P. Pollution Control Board.

- 11. The diesel generator sets (if any) to be used during construction phase should be low sulphur diesel type and should conform to Environment (Protection) Rules prescribed for air and noise emission standards.
- 12. The diesel required (if any) for operating DG sets shall be stored in underground tanks and if required, clearance from Chief Controller of Explosives shall be taken.
- 13. Wastewater generated from temporary leabour tents will be diverted to the sewer network
- 14. No water logging should take place at any point during construction phase.
- 15. If the project site is located within the 100 km of Thermal Power Stations, then fly ash should be used as building material in the construction as per the provisions of Fly ash Notification of September, 1999 and amended as on 27th August, 2003.
- As far as possible ready mixed concrete should be used in construction work.
- 17. Vehicles hired for bringing construction material to the site should be in good condition and should have a pollution check certificate and should conform to applicable air and noise emission standards and should be operated only during non-peak hours.
- 18. Ambient noise levels should conform to residential standards both during day and night. Incremental pollution loads on the ambient air and noise quality should be closely monitored during construction phase. Adequate measures should be made to reduce ambient air and noise level during construction phase, so as to conform to the stipulated standards by CPCB/ MPPCB.
- 19. Storm water control and its use should be as per CGWB and BIS standards for various
- 20. Water demand during construction should be reduced by use of pre-mixed concrete, curing agents and other best practices referred.
- 21. Care shall be taken during the wet drilling activities.
- 22. Spread of contaminated water should be prevented by installing temporary barriers of
- To prevent surface and ground water contamination by oil/grease, leak proof containers shall be used for storage and transportation of oil/grease. The floors of oil/grease handling area will be kept effectively impervious.
- 24. On-site burning of waste material will not be permitted.
- 25. Ground water should not be used during construction phase. Private tanker water suppliers may be asked to supply water during construction phase.
- 26. Commitment towards CSR have to be followed strictly.

27. Fixtures for showers, toilet flushing and drinking should be of low flow either by use of aerators or pressure reducing devices or sensor based control.

- 28. Wherever possible, the area around the STP / ETP should be surrounded with dense green belt.
- To reduce the electricity consumption and load on air conditioning, high quality double glass with special reflective coating in windows should be promoted.
- Roof should meet prescriptive requirement as per Energy Conservation Building Code by using appropriate thermal insulation material to fulfill requirement.
- 31. Opaque wall should meet prescriptive requirement as per Energy Conservation Building Code which is proposed to be mandatory for all air-conditioned spaces while it is aspirational for non-air conditioned spaces by use of appropriate thermal insulation material to fulfill requirement.
- 32. Approval of the competent authority shall be obtained for structural safety of the buildings due to earthquake, adequacy of fire fighting equipments, etc. as per National Building Code including protection measures from lightening etc.

### B. Operation Phase

- 1. The installation of the Sewage Treatment Plant (STP) as submitted by PP in the office of SEIAA should be certified by an independent expert and a report in this regard should be submitted to the Regional office of the Ministry of Environment & Forest, Gol before the project is commissioned for operation. Treated effluent discharge from STP shall be recycled/reused to the maximum extent possible. Treated effluent shall conform to the norms and standards of the M.P. Pollution Control Board. Necessary measures should be made to mitigate the odour problem from STP.
- Treated waste water should not be used for air conditioning.
- Treatment of 100% grey water by decentralized treatment should be done.
- The bio-medical waste (if applicable) generated should be disposed off as per the provisions of Bio-medical waste (Management and Handling) Rules 1988 as amended till date.
- Provision of separate entrance / exit gate should be made for collection of segregated bio-medical waste (if applicable) from the storage area.
- The solid waste generated should be properly collected and segregated. Wet garbage should be composted and dry/inert solid waste should be disposed off to the approved sites for land filling after recovering recyclable material as per CPCB norms.
- 7. Diesel power generating sets if proposed as source of back up power for elevators and common area illumination during operation phase should be of enclosed type and confirm to rules made under the Environment (Protection) Act, 1986. The height of stack of DG sets should be equal to the height needed for the combined capacity of all proposed DG sets. Low sulphur diesel must be used. The location of the DG sets may be decided with in consultation with Madhya Pradesh Pollution Control Board.

- 8. No water logging should take place at any point during operation phase.
- The Project Proponent shall explore the possibility of using solar energy wherever possible.
- 10. Provision for plantation has to be made as per Madhya Pradesh Bhumi Vikas Niyam, 1984.
  - Any hazardous waste generated during operation phase, should be disposed off as per applicable rules and norms with necessary approvals of the M.P. Pollution Control Board.
- Noise should be controlled to ensure that it does not exceed the prescribed standards of CPCB.
- Weep holes in the compound walls shall be provided to ensure natural drainage of rain water in the catchment area during the monsoon period.
- 14. Rain water harvesting for roof run- off and surface run- off, should be implemented. Before recharging the surface run off, pre-treatment must be done to remove suspended matter, oil and grease. The bore well for rainwater recharging should be kept at least 5 mts. above the highest ground water table.
- The ground water level and its quality should be monitored regularly in consultation with Central Ground Water Authority.
- 16. Traffic congestion near the entry and exit points from the roads adjoining the proposed project site must be avoided. Parking should be fully internalized and no public space should be utilized.
- 17. A Report on the energy conservation measures confirming to energy conservation norms finalize by Bureau of Energy Efficiency should be prepared incorporating details about building materials & technology, R & U Factors etc and submit to the Regional office of Ministry of Environment & Forest, Gol in three months time.
- 18. Energy conservation measures like installation of CFLs/TFLs for the lighting the areas outside the building should be integral part of the project design and should be in place before project commissioning. Used CFLs and TFLs should be properly collected and disposed off/sent for recycling as per the prevailing guidelines/ rules of the regulatory authority to avoid mercury contamination. Use of solar panels may be done to the extent possible.
- 19. The building should have adequate distance between them to allow movement of fresh air and passage of natural light, air and ventilation.
- The area earmarked for the parking shall be used for parking only. No other activity shall be permitted in this area.
- Ozone Depleting Substances (Regulation & Control) Rules shall be followed while designing the air conditioning system (if any) of the project.

### C. Others

- All activities / mitigative measures proposed by PP in Environmental Impact Assessment (if applicable) and approved by SEAC must be ensured.
- All activities / mitigative measures proposed by PP in Environmental Management Plan and approved by SEAC must be ensured.
- All parameters listed in Environmental Monitoring Plan approved by SEAC must be monitored at approved locations and frequencies.
- Project Proponent has to strictly follow the direction/guidelines issued by MoEF; CPCB and other Govt. agencies from time to time.
- The funds earmarked for environmental protection measures shall be kept in separate account and shall not be diverted for other purpose. Year wise expenditure shall be reported to the MoEF, GoI, and its Regional Office located at Bhopal.
- The Ministry or any other competent authority may alter/modify the conditions or stipulate any further condition in the interest of environment protection.
- The Environmental Clearance shall be valid for a period of five years from the date of issue of this letter.
- The project proponent shall also submit six monthly reports on 1<sup>st</sup> June and 1<sup>st</sup> December
  of each calendar year on the status of compliance of the stipulated EC conditions
  including results of monitored data to the regulatory Authority in hard and soft copies.
- The Regional Office, MoEF, Gol, Bhopal and MPPCB shall monitor compliance of the stipulated conditions. A complete set of documents including Environment Impact Assessment Report. Environmental Management Plan and other documents information should be given to Regional Office of the MoEF, Gol at Bhopal and MPPCB.
- 10. The Project Proponent shall inform to the Regional Office, MoEF, Gol, Bhopal and MP PCB regarding date of financial closures and final approval of the project by the concerned authorities and the date of start of land development work.
- In the case of expansion or any change(s) in the scope of the project, the project shall again require prior Environmental Clearance as per EIA notification, 2006.
- 12. The SEIAA of M.P. reserves the right to add additional safeguard measures subsequently, if found necessary, and to take action including revoking of the environment clearance under the provisions of the Environmental (Protection) Act, 1986, to ensure effective implementation of the suggested safeguard measures in a time bound and satisfactory manner.
- 13. - 14. These stipulations would be enforced among others under the provisions of Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and control of Pollution) act 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1,991 and EIA Notification, 2006.
- 15. The proponent shall upload the status of compliance of the stipulated EC conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the Regional Office of MoEF, the respective Zonal Office of CPCB and the SPCB. The criteria pollutant levels namely; SPM, RSPM, SO<sub>2</sub>, NOx (ambient levels as well as stack emissions) or critical sectoral parameters, indicated for the project shall be monitored and displayed at a convenient location near the main gate of the company and in the public domain.
- 16. The environmental statement for each financial year ending 31<sup>st</sup> March in Form-V as is mandated to be submitted by the project proponent to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently, shall also be put on the website of the company along with the status of compliance of EC conditions and shall also be sent to the Regional Office of MoEF.
- 17. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- 18. A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of the Local Bodies, Panchayat and municipal bodies as applicable in addition to the relevant officers of the Government who in turn has to display the same for 30 days from the date of receipt.
- 19. The Project Proponent shall advertise at least in two local newspapers widely circulated, one of which shall be in the vernacular language of the locality concerned, within 7 days of the issue of the clearance letter informing that the project has been accorded environmental clearance and a copy of the clearance letter is available with the State Pollution Control Board and also at website of the State Level Environment Impact Assessment Authority (SEIAA) at www.mpseiaa.nic.in and a copy of the same shall be forwarded to the Regional Office, MoEF, Gol, Bhopal.

 Any appeal against this prior environmental clearance shall lie with the Green Tribunal, if necessary, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
