Sub:- Case No. - 5429/2016 Prior Environment Clearance for Kailwas Laterite Mine (Opencast Mechanized Method) in an area of 13.57 Ha., for production capacity of 3,39,168 TPA, at Khasra no. 01, Vill.-Kailwas, Teh.-Majholi, District-Jabalpur (M.P.) by Shri Rituraj Verma R/o Adhartal, Jabalpur (M.P.).

This has reference to your letter received in SEIAA office on 23.09.2016 and subsequent letters seeking Prior Environmental Clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of provisions under the EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application viz., the Form – I, Appendix-1 Mining Plan & EMP, the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

II. It has been noted that the proposal is for Kailwas Laterite Mine in an area of 13.57 ha. The mining lease area is located at khasra no. 01 at Village- Kailwas, Teh.-Majholi, District-Jabalpur. The nearest village Deonagar is located at the distance of 2.8 km E & the nearest water body is Hevan River is located at the distance of 4.2 km NE There is no National Park/Sanctuary within 10 Km radius. There is no forest boundary within 250 m from mining site.

The proposed project is for production capacity of 3,39,168 TPA. The mining will be carried out by Open cast mechanized method. The water requirement is 24 KLD. The water met from tankers will be used for domestic purpose, dust suppression and green belt development. An area of 13.57 ha area shall be covered under plantation and 10000 sapling shall be planted.

- III. The project has been considered in accordance with the provisions of the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14<sup>th</sup> September 2006.
- IV. Based on the information submitted, as at Para (II) above and others the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 466<sup>th</sup> meeting dtd. 25.01.2018 and decided to accept the recommendations of 60<sup>th</sup> SEAC -II meeting dtd. 24.11.2016.

Hence, Prior Environmental Clearance is granted for Kailwas Laterite Mine (Opencast Mechanized Method) in an area of 13.57 Ha., for production capacity of 3,39,168 TPA, at Khasra no. 01, Vill.-Kailwas, Teh.-Majholi, District-Jabalpur (M.P.) for the lease period to Shri Rituraj Verma R/o Adhartal, Jabalpur (M.P.), subject to the compliance of following specific conditions as recommended by SEIAA & SEAC and subsequent Standard Conditions.

## A. SPECIFIC CONDITIONS

Before commencing any mining activity fencing shall be carried out all around the lease area.
 Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.

- Plantation programme me as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- 4. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- 5. Before commencing the mining activity, site demarcation should be done leaving 100 m. from the habitation and 50 m. from the village road as a "no mining zone" and it will be maintained as buffer zone. The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Jabalpur
- PP will plan 3 years old 2000 trees samplings of suitable indigenous fast grow tree species and develop 25m. vide plantation zone towards the south western boundary near habitation site and in barrier zone/no mining zone during first year.
- 7. PP shall ensure to construct and maintained 70 m. Cement Concrete approach road and also maintain 5.5 km. pakka road upto junction of NH from the mine site. Plantation will be carried out on both side of the approach road. PP shall also ensure maintenance of PMGSY road and PWD road in consultation with competent authority.
- PP has committed installation of 01 bore well within the mine site for irrigation of plantation, control on dust pollution and drinking purposes, and additional water requirement shall be fulfilled by water tanker with written consent of Gram Panchayat/Local villagers.
- The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- No overburden will be dumped outside the mine lease area.
- Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB.
- 12. PP shall ensure generation of employment opportunities nearby Village on priority bases.
- Payments of wages to the workers shall be done in consonance with the provisions in the labours laws.
- 14. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- 15. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields
- 16. Mining shall be limited to the area as shown in surface plan and as per the approved mining
- PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- 18. PP shall ensure proper implementation of plantation, dust suppression, construction of CC approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- PP must ensure implementation of the following activities with separate budget provision should be kept under CSR.
  - a) PP shall ensure social welfare, skill development activities and sanitation programme at nearby village for woman & girls.
  - Donation of Blankets for needy under Kailwas.
  - PP shall constructed 25 Nos. of toilets & Bathroom at Village Kailwas for SC/ ST Families.
  - d) Health awareness & camp organize at nearby villages
  - e) 2 Big carpets for Gram Panchayat Kailwas.
  - One Cricket Kit for Village children.

The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Grampanchayat.

- 20. PP has committed a budget provision Rs 25.00 lakhs for the CSR activities vide letter dated 17.11.2017.
- 21. PP should ensure to submit half yearly compliance report and CSR activity report with photographs of plantation in MP-SEIAA.
- 22. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC
- Transportation of material shall be done in covered vehicles.
- 24. Necessary consents shall be obtained from MPPCB and the air / water pollution control measures have to be installed as per the recommendation of MPPCB.
- 25. Permission / NOC shall be obtained from Gram Panchayat for lifting water from the village resources and shall be furnished to MPPCB while obtaining necessary consents under the provisions of Air / Water consents.
- 26. Curtaining of site shall be done through thick plantation all around the boundaries of the lease
- 27. The OB should be properly stacked inside the ML area in barrier zone and disposed off as per the submitted plan.
- Peripheral drains should be provided all around the OB dumps.
- 29. Fixed types of water sprinklers should provided on the internal haul roads.
- Production of Laterite shall be as per the mining plan not exceeding 3,05,251 TPA.
- 31. The proposed plantation should be carried out along with the mining and PP would maintain the plants for five years including casualty replacement.
- 32. Appropriate activities shall be taken up for social up-liftment of the Region. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 33. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 34. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.
- 35. PP will comply with all the commitments made in by the letter dated 24/11/2016.

## B. STANDARD CONDITIONS

- 1. Controlled blasting techniques, as and when required, shall be carried out in the day time
- 2. Mining will be carried out as per the approved Mining Plan. In case of any violation of Mining Plan the Environmental Clearance given by SEIAA will stand cancelled.
- 3. Effective safeguard measures, such as regular water sprinkling shall be carried out in critical areas prone to air pollution and having high levels of particulate matter such as loading and unloading point and all transfer points.
- 4. Where the quarry is in a hilly terrain and where some part of the hill is already cut for quarrying, further hill cutting shall not be done. In such cases, deepening the existing operational area may be preferably done.
- 5. Precise mining area will be jointly demarcated at site by officials of Mining/Revenue department prior to mining operations for all proposals under consideration.
- 6. The lease holder shall obtain necessary prior permission of the competent authorities for drawal of requisite quantity of water (surface water and groundwater), if required for the
- Parking of vehicles should not be made on public places.
- 8. Special Measures shall be adopted to prevent the nearby settlements from the impacts of mining activities. Maintenance of roads through which transportation of minor minerals is to be undertaken, shall be carried-out regularly.

- 9. Measures for prevention and control of soil erosion and management of silt shall be undertaken.
- 10. Trenches / garland drains shall be constructed at foot of dumps to arrest silt from being carried to water bodies.
- 11. The project proponent will ensure necessary protection measures around the mine pit, waste dumps and garland drain.
- 12. Top soil / solid waste shall be stacked properly with proper slope and adequate safeguards and shall be utilized for backfilling (wherever applicable) for reclamation and rehabilitation of mined out area.
- 13. Plantation programme shall be carried out as per EMP. Self sustenance of the vegetation should be ensured. No tree-felling shall be done in the leased area, except only with the permission from competent authority.
- 14. The vehicles transporting minerals shall be covered with a tarpaulin or other suitable enclosures so that no dust particles / fine matters escape during the course of transportation.
- 15. Project Proponent shall ensure appropriate arrangement for shelter and drinking water for the mine workers.
- 16. Persons working in dusty areas shall be provided with protective respiratory devices and they shall also be imparted adequate training and information on safety and health aspects.
- Dispensary facilities for first-aid shall be provided at site.
- 18. A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of the Local Bodies, Panchayat and Municipal Bodies, as applicable, in addition to the relevant officers of the Government
- 19. The Ministry or any other competent authority may alter/modify the conditions or stipulate any further condition in the interest of environment protection.
- 20. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- 21. Any appeal against this prior environmental clearance shall lie with the Green Tribunal, if necessary, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
