With reference to above, the proposal has been appraised as per prescribed procedure & provisions under the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14th September 2006 and its amendment, on the basis of the mandatory documents enclosed with the application viz., Form I, Form IA, Conceptual Plan, drawings, ppt & the additional clarifications furnished in response to the observations by the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

- (i). The proposed project is building and construction Redevelopment and Redensification of Government Housing project Under Ram Nagar-Pari Bazaar-Bara Mahal Scheme Shahjahanabad, Bhopal (M.P.) The project comprises 461 units including 4 types of blocks (F+G+H+I) and an old age ashra. Redevelopment & Redensification of existing Govt. Quarters are PWD Stores, PWD Quarters, Ram Nagar, HT Quarters.etc.
- (ii). As per the Joint Director, T & CP, Bhopal-Sehore -Raisen (vide letter dtd 16.02.2017) the total land area of the proposed project is 51700.0 sq.m (5.17 ha). The total built up area proposed by PP is 3888.32 sq.m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 because total construction is between 20,000 sq.mt. & 1,50,000 sq mt. and plot area is less than 50 ha.
- (iii). Regarding land documents PP has submitted Minutes of meeting of State Level Empowere Committee (SLEC) dtd. 24.04.12 conducted on 12.04.12 under the Chaimainship of Principle Secretary H & Envt. GoMP.

- (iv). The total water & fresh water requirement is 319 KLD. The source of water supply is Municipal Corporation, Bhopal,. PP has submitted letter (dtd. 20.03.2017) from Municipal Corporation, Bhopal for water supply.
- (v). The total waste water generation is 256 KLD which is proposed to use the capacity of existing STP of Nagar Nigam Bhopal for treatment of waste water. PP has submitted letter dtd 22.06.2017 for treatment and disposal of waste water in municipal sewer line.
- (vi). Approximately 1432 kg/day Municipal Solid waste shall be generated. The generated biodegradable and non biodegradable waste will be collected separately and disposed of at the landfill site of Municipal Corporation. Debris quantity resulted from demolition works will be segregated in recyclable (approx 20%) and non recyclable categories. Quantities will be recorded for Recyclable part such as wooden pieces, doors, windows, steel beams, rods, stone sheets etc and will be provided to recycling agencies. Non recyclable debris will be handled in two ways in refilling foundations of buildings and in refilling in identified low areas/stone queries. PP has submitted letter (dtd. 22.06.2017) from Municipal Corporation, Bhopal for disposal of solid waste.
- (vii). PP has proposed e-waste shall be collected stored and disposed in accordance with E-waste Management Guidelines. Hazardous Wastes (Management, Handling and Transboundary Movement) Rules, 2008 will be strictly followed.
- (viii). Under demolition Planning of Existing Structure Pp has proposed some mandatory safety arrangement such as Signage, First Aid, Ambulance arrangements, PPEs, Safe working areas, barricades, lighting arrangements etc For dust suppression PP has proposed sufficient water sprinkling, covering/separating with green net etc.
- (ix). PP has submitted 2 Fire Stations are already functioning within the range of 3 Km. Fire Station 1 – at Shahjahanabad and Fire Station 2 – Near Sadar Manzil, Nagar Nigam Office.
- (x). The maximum height of the building is 13.8 m. PP has proposed to provide road widths, front MOS and side / rear MOS as per approved layout of T & CP.
- (xi). PP has proposed roof top rain water harvesting system for ground water recharging including 12.no of recharging pits.
- (xii). The total power requirement is 1375 KW. The source of electricity is Madhya Pradesh Kshetra Vidyut Vitran Company Limited. For energy conservation measures LED light fixtures shall be used to save power consumption up to 30%. Backup power will be provided using DG 10 KVA for site office, DG-50 KVA for batching plant and a mobile DG-10 KVA for construction works in case of power failures. Separate 10 KVA DGs each will be provided at PWD Store and PWD Quarter.
- (xiii). PP has proposed to provide 389 ECS including 108 ECS covered parking and 281 ECS open parking.
- (xiv). PP has proposed an area of 6927.05 Sqm. to be developed as green area by planting species of Sheeham Neem, Gulmohar, etc. There are 230 number of trees exists in the site. Out of 230 121 will be cut and 82 number of trees will be saved and in compensatory of cutting trees 266 numbers of trees are proposed to be planted on the site as per the direction of Nagar Nigam Bhopal.(letter dtd. 02.06.2017)

Based on the information submitted at Para i to xiv above and others, the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 456th meeting held on 16.11.2017 and decided to accept the recommendations of 295th SEAC meeting held on dtd. 06.11.2017.

Hence, Environmental Clearance is accorded under the provisions of EIA notification dtd. 14th September 2006 and its amendments to the proposed Redevelopment and Redensification of Government Housing under Ram Nagar, Pari Nazar, Bara Mahal Scheme, Tehsil - Huzur, Dist. Bhopal, MP, Total Land Area - 51700.0 sq.m (5.17 ha) Proposed built-up area- 3888.32 sq m , by District Magistrate & Collector Bhopal. Collectorate, A-Block, Old Sectt., Bhopal, MP - 462001 subject to the compliance of the Standard Conditions enclosed at Annex-I and the following additional Specific Conditions as recommended by SEIAA & SEAC in its meetings.

A. Specific Conditions as recommended by SEIAA:-

- The fresh water supply arrangement should be met through Municipal Corporation and there should no extraction of ground water.
- (2) The inlet and outlet point of natural drain system should be maintained with adequate size of channel for ensuring unrestricted flow of water.
- (3) Disposal of waste water.
 - PP should ensure disposal of waste water arrangement should be done in such a manner that water supply sources are not impaired.
 - During rainy season disposal of the treated effluent should be done through pumping system towards downstream to a nallah at the selected site as per prescribed norms of concerned regulatory agency if applicable in site. (CPCB/MPPCB)

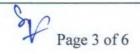
(4) **Solid Waste Management:**

- (a) Separate wet and dry bins must be provided at the ground level for facilitating segregation of waste.
- (b) The solid waste generated should be properly collected and segregated. Wet garbage should be composted and dry inert solid waste should be disposed off to the approved sites for land filling after recovering recyclable material.
- PP should ensure road width, front MOS and side / rear as per MPBVR 2012. (5)
- (6) For firefighting:-
 - (a) PP should ensure connectivity to the fire station from the project site.
- For Rain Water Harvesting, and Ground water recharge:-(7)
 - (a) PP should ensure the rain water harvesting with 12 nos of recharging pits and these pits should be connected laterally to consume the surplus runoff. In addition, PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.
 - (b) The storm water from roof top, paved surfaces and landscaped surfaces should be properly channelized to the rain water harvesting sumps through efficient storm water network as proposed. The budget should be included in EMP plan for storm water management.

- (c) Rain water harvesting for roof run- off and surface run- off, as plan submitted should be implemented. Before recharging the surface run off, pre-treatment must be done to remove suspended matter, oil and grease.
- (d) The unpaved area shall be more than or equal to 20% of the recreational open spaces.
- (8) PP should ensure to provide car parking as proposed 389 ECS (covered parking-108 ECS and 281ECS).

(9) For Energy Conservation PP should Ensure :-

- (a) Use of LED lights in the common areas, landscape areas, signage's, entry gates and boundary compound walls etc.
- (b) Solar lights provide for common amenities like Street lighting & Garden lighting.

(10) Air Quality and Noise:-

(a) Dust, smoke & debris prevention measures such as wheel washing, screens, barricading & debris chute shall be installed at the site during construction including plastic/tarpaulin sheet covers for trucks bringing in sand & material at the site.

(11) Green belt :-

- (a) PP should ensure plantation to the 6927.05 Sqm by planting 496 no. of trees two rows in periphery, besides, this along the road, around open space area, parking area and other amenities. Trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar, Saltree, Gulmohar etc.should be planted.
- (b) Existing 121 trees should be cut as per BMC letter dtd. 02.06.2017.
- (c) The green belt of the adequate width and density preferably with local species along the periphery of the plot shall be raised so as to provide protection against particulates and noise.

B. Specific Conditions as recommended by SEAC

(A) PRE-CONSTRUCTION PHASE

- (12) During demolition of old structures, the entire area should be covered with 12 feet MS sheets and due care should be taken for noise and vibration control during demolition work.
- (13) Curtaining of site should also be carried out to protect nearby habitat.
- (14) No demolition work should be carried out during night hours.
- (15) For dust suppression, regular sprinkling of water should be undertaken
- (16) PP will obtain other necessary clearances/NOC from respective authorities.
- (17) Provisions shall be made for the housing of construction labour within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile toilets, mobile STP, safe drinking water, medical health care, crèche etc. The housing may be in the form of temporary structure to be removed after completion of the period.
- (18) The grant of Environmental Clearance should be subject necessary Wild Life Clearance from NBWL to be obtained by PP.

(B) CONSTRUCTION PHASE

- (19) During construction phase, a settling tank should be provided before final discharge of the effluent.
- (20) PPE's such as helmet, ear muffs etc should be provide to the workers.
- (21) Fire extinguishers should be provided on site during construction period.
- (22) Properly tuned construction machinery and good condition vehicles (low noise generating and having PUC certificate) should be used.
- (23) Waste construction material should be recycles as far as possible and remaining should be disposed off at a designated place in consultation with the local authority.
- (24) Peripheral plantation all around the project boundary shall be carried out using tall saplings of minimum 2 meters height of species which are fast growing with thick canopy cover preferably of perennial green nature. As proposed in the landscape plan & EMP a minimum of 496 no's of trees will be planted. (230 within the premises and 266 on the location outside of the projector area) PP will also make necessary arrangements for the causality replacement and maintenance of the plants.
- (25) MSW storage area should have 48 hours storage capacity and MSW should be disposed off at a designated place in consultation with the local authority.
- (26) As proposed, 12 number rain water harvesting pits (size 2.4mx1.5mx1.8m) should be provided and their design should be based on recharge rate study.
- (27) CFL/LED should be preferred over of tube lights.
- (28) Provision for physically challenged persons be made so that they easily excess pathway/derive way for their vehicles.
- (29) PP should explore the possibility of providing solar street light.
- (30) Waste oil generated from the DG sets should be disposed off in accordance with the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 after obtaining authorization.

(C) POST CONSTRUCTION/OPERATIONAL PHASE

- (31) Fresh water requirement for the project shall not exceed 319 KLD.
- (32) As proposed, the sewage and waste water will be discharged in municipal drains and same will be treated in the PHE STP of 25 MLD capacity at Maholidamkheda for which necessary sewage discharge approval is obtained by them form the municipal corporation.
- (33) Proper fire fighting arrangements in consultation with the fire department should be provided against fire incident.
- (34) Fund should be exclusively earmarked for the implementation of EMP through a separate bank account.

(D) ENTIRE LIFE OF THE PROJECT

- (35) PP has proposed Rs. 45.00 lacks for green belt development and Rs. 20.00 lacks/year for recurring expenses in the proposed EMP of this project.
- (36) As proposed, the green belt development / plantation activities should be completed within the first three years of the project and the proposed species should also be planted in consultation with the forest department.

- (37) The project authorities should comply with the provisions made in the Hazardous Waste (management, handling & Trans-boundary Movement) Rules 2016, Plastic Waste Management Rules 2016, e-waste (Management) Rules, 2016, Construction and Demolition Waste Management Rules, 2016 and Solid Waste Management Rules, 2016 etc.
- (38) In case of any, change in scope of work, technology, modernization and enhancement of capacity/ built-up area/ project area shall again require prior environmental clearance as per EIA notification, 2006.
- (39) The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity/ built-up area/ project area, addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.

Annex-L

Standard Conditions related to under item 8 (a) & 8 (b) of the schedule of EIA notification, 2006 (Building/ construction projects / area development projects & township)

A. Construction Phase.

- The construction site shall be provided with adequately barricades of at least 3 m height on its periphery with adequate signage.
- 2 All required sanitary and hygienic measures should be in place before starting any construction work and are to be maintained throughout the project phase.
- 3. Provision shall be made for the housing of construction labour within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile toilets, safe drinking water, medical health care, crèche etc. The housing may be in the form of temporary structures to be removed after the completion of the project.
- 4. Occupational health and safety measures for the workers including identification of work related health hazards, training on malaria eradication, HIV, and health effects on exposure to dust etc. shall be carried out. Periodic monitoring for exposure to respirable dust on the workers shall be conducted and records maintained including health records of the workers. Awareness programme for workers on impact of dust on their health and precautionary measures like use of personal equipments etc. shall be carried out periodically.
- A First Aid Room will be provided in the project both during construction and operation of the project.
- All the topsoil excavated during construction activities should be stored for use in horticulture/landscape development within the project site.
- 7. Disposal of muck during construction phase should not create any adverse effect on the neighbouring communities and be disposed taking the necessary precautions for general safety and health aspects of people, only in approved sites with the approval of competent authority.
- Soil and ground water samples will be tested to ascertain that there is no threat to ground water quality by leaching of heavy metals and other toxic contaminants.
- Construction spoils, including bituminous material and other hazardous materials, must not be allowed to contaminate water courses and the dump sites for such material must be secured so that they should not leach into the ground water.

10. Any hazardous waste generated during construction phase, should be disposed off as per applicable rules and norms with necessary approvals of the M.P. Pollution Control Board.

- 11. The diesel generator sets (if any) to be used during construction phase should be low sulphur diesel type and should conform to Environment (Protection) Rules prescribed for air and noise emission standards.
- 12. The diesel required (if any) for operating DG sets shall be stored in underground tanks and if required, clearance from Chief Controller of Explosives shall be taken.
- 13. Wastewater generated from temporary leabour tents will be diverted to the sewer network in the area.
- 14. No water logging should take place at any point during construction phase.
- 15. If the project site is located within the 100 km of Thermal Power Stations, then fly ash should be used as building material in the construction as per the provisions of Fly ash Notification of September, 1999 and amended as on 27th August, 2003.
- 16. As far as possible ready mixed concrete should be used in construction work.
- 17. Vehicles hired for bringing construction material to the site should be in good condition and should have a pollution check certificate and should conform to applicable air and noise emission standards and should be operated only during non-peak hours.
- 18: Ambient noise levels should conform to residential standards both during day and night. Incremental pollution loads on the ambient air and noise quality should be closely monitored during construction phase. Adequate measures should be made to reduce ambient air and noise level during construction phase, so as to conform to the stipulated standards by CPCB/ MPPCB.
- Storm water control and its use should be as per CGWB and BIS standards for various applications.
- Water demand during construction should be reduced by use of pre-mixed concrete, curing agents and other best practices referred.
- 21. Care shall be taken during the wet drilling activities.
- 22. Spread of contaminated water should be prevented by installing temporary barriers of G.I. Sheets.
- 23. To prevent surface and ground water contamination by oil/grease, leak proof containers shall be used for storage and transportation of oil/grease. The floors of oil/grease handling area will be kept effectively impelvious.
- 24. On-site burning of waste material will not be permitted.
- 25. Ground water should not be used during construction phase. Private tanker water suppliers may be asked to supply water during construction phase.
- 26. Commitment towards CSR have to be followed strictly.

27. Fixtures for showers, toilet flushing and drinking should be of low flow either by use of aerators or pressure reducing devices or sensor based control.

- 28. Wherever possible, the area around the STP / ETP should be surrounded with dense green belt.
- 29. To reduce the electricity consumption and load on air conditioning, high quality double glass with special reflective coating in windows should be promoted.
- 30. Roof should meet prescriptive requirement as per Energy Conservation Building Code by using appropriate thermal insulation material to fulfill requirement.
- 31. Opaque wall should meet prescriptive requirement as per Energy Conservation Building Code which is proposed to be mandatory for all air-conditioned spaces while it is aspirational for non-air conditioned spaces by use of appropriate thermal insulation material to fulfill requirement.
- 32. Approval of the competent authority shall be obtained for structural safety of the buildings due to earthquake, adequacy of fire fighting equipments, etc. as per National:

 Building Code including protection measures from lightening etc.

B. Operation Phase

- 1. The installation of the Sewage Treatment Plant (STP) as submitted by PP in the office of SEIAA should be certified by an independent expert and a report in this regard should be submitted to the Regional office of the Ministry of Environment & Forest, Gol before the project is commissioned for operation. Treated effluent discharge from STP shall be recycled/reused to the maximum extent possible. Treated effluent shall conform to the norms and standards of the M.P. Pollution Control Board. Necessary measures should be made to mitigate the odour problem from STP.
- Treated waste water should not be used for air conditioning.
- 3. Treatment of 100% grey water by decentralized treatment should be done.
- The bio-medical waste (if applicable) generated should be disposed off as per the provisions of Bio-medical waste (Management and Handling) Rules 1988 as amended till date.
- Provision of separate entrance I exit gate should be made for collection of segregated bio-medical waste (if applicable) from the storage area.
- The solid waste generated should be properly collected and segregated. Wet garbage should be composted and dry/inert solid waste should be disposed off to the approved sites for land filling after recovering recyclable material as per CPCB norms.
- 7. Diesel power generating sets if proposed as source of back up power for elevators and common area illumination during operation phase should be of enclosed type and confirm to rules made under the Environment (Protection) Act, 1986. The height of stack of DG sets should be equal to the height needed for the combined capacity of all proposed DG sets. Low sulphur diesel must be used. The location of the DG sets may be decided with in consultation with Madnya Pradesh Pollution Control Board.

- 8. No water logging should take place at any point during operation phase.
- 9. The Project Proponent shall explore the possibility of using solar energy wherever
- 10. Provision for plantation has to be made as per Madhya Pradesh Bhumi Vikas Niyam, 1984.-
 - 11. Any hazardous waste generated during operation phase, should be disposed off as per applicable rules and norms with necessary approvals of the M.P. Pellution Control Board.
 - 12. Noise should be controlled to ensure that it does not exceed the prescribed standards of CPCB.
 - 13. Weep holes in the compound walls shall be provided to ensure natural drainage of rain water in the catchment area during the monsoon period.
 - 14. Rain water harvesting for roof run- off and surface run- off, should be implemented. Before recharging the surface run off, pre-treatment must be done to remove suspended matter, oil and grease. The bore well for rainwater recharging should be kept at least 5 . mts. above the highest ground water table.
 - 15. The ground water level and its quality should be monitored regularly in consultation with Central Ground Water Authority.
 - 16. Traffic congestion near the entry and exit points from the roads adjoining the proposed project site must be avoided. Parking should be fully internalized and no public space should be utilized.
 - 17. A Report on the energy conservation measures confirming to energy conservation norms finalize by Bureau of Energy. Efficiency should be prepared incorporating details about building materials & technology, R & U Factors etc and submit to the Regional office of Ministry of Environment & Forest, Gol in three months time.
 - 18. Energy conservation measures like installation of CFLs/TFLs for the lighting the areas outside the building should be integral part of the project design and should be in place before project commissioning. Used CFLs and TFLs should be properly collected and disposed off/sent for recycling as per the prevailing guidelines/ rules of the regulatory authority to avoid mercury contamination. Use of solar panels may be done to the extent. possible.
 - 19. The building should have adequate distance between them to allow movement of fresh air and passage of natural light, air and ventilation.
 - 20. The area earmarked for the parking shall be used for parking only. No other activity shall be permitted in this area.
 - 21. Ozone Depleting Substances (Regulation & Control) Rules shall be followed while designing the air conditioning system (if any) of the project.

C. Others

- All activities / mitigative measures proposed by PP in Environmental Impact Assessment (if applicable) and approved by SEAC must be ensured.
- All activities / mitigative measures proposed by PP in Environmental Management Plan and approved by SEAC must be ensured.
- 3. All parameters listed in Environmental Monitoring Plan approved by SEAC must be monitored at approved locations and frequencies.
- 4. Project Proponent has to strictly follow the direction/guidelines issued by MoEF; CPCE and other Govt. agencies from time to time.
- 5. The funds earmarked for environmental protection measures shall be kept in separate account and shall not be diverted for other purpose. Year wise expenditure shall be reported to the MoEF, GoI, and its Regional Office located at Bhopal.
- 6. The Ministry or any other competent authority may alter/modify the conditions or stipulate any further condition in the interest of environment protection.
- The Environmental Clearance shall be valid for a period of five years from the date of issue of this letter.
- The project proponent shall also submit six monthly reports on 1st June and 1st December
 of each calendar year on the status of compliance of the stipulated EC conditions
 including results of monitored data to the regulatory Authority in hard and soft copies.
- The Regional Office, MoEF, Gol, Bhopal and MPPCB shall monitor compliance of the stipulated conditions. A complete set of documents including Environment Impact Assessment Report. Environmental Management Plan and other documents information should be given to Regional Office of the MoEF, Gol at Bhopai and MPPCB.
- 10. The Project Proponent shall inform to the Regional Office, MoEF, Gol, Bhopal and MP PCB regarding date of financial closures and final approval of the project by the concerned authorities and the date of start of land development work.
- 11. In the case of expansion or any change(s) in the scope of the project, the project shall again require prior Environmental Clearance as per EIA notification, 2006.
- 12. The SEIAA of M.P. reserves the right to add additional safeguard, measures subsequently, if found necessary, and to take action including revoking of the environment clearance under the provisions of the Environmental (Protection), Act, 1986, to ensure effective implementation of the suggested safeguard measures in a time bound and satisfactory manner.
- 13. All other statutory clearances such as the approvals for storage of diesel from Chief Controller of Explosives, Fire Department, Civil Aviation Department, Forest Conservation Act, 1980 and Wildlife (Protection) Act, 1972 etc. shall be obtained (as and when applicable), by the project proponent from the respective competent authorities.

- 14. These stipulations would be enforced among others under the provisions of Water. (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and control of Pollution) act 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1,991 and EIA Notification, 2006.
- 15. The proponent shall upload the status of compliance of the stipulated EC conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the Regional Office of MoEF, the respective Zonal Office of CPCB and the SPCB. The criteria pollutant levels namely; SPM, RSPM, SO2, NOx (ambient levels as well as stack emissions) or critical sectoral parameters, indicated for the project shall be monitored and displayed at a convenient location near the main gate of the company and in the public domain.
- 16. The environmental statement for each financial year ending 31st March in Form-V as is mandated to be submitted by the project proponent to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as: amended subsequently, shall also be put on the website of the company along with the status of compliance of EC conditions and shall also be sent to the Regional Office of
- 17. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- 18. A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of the Local Bodies, Panchayat and municipal bodies as applicable in addition tothe relevant officers of the Government who in turn has to display the same for 30 days from the date of receipt.
- 19. The Project Proponent shall advertise at least in two local newspapers widely circulated, one of which shall be in the vernacular language of the locality concerned, within 7 days of the issue of the clearance letter informing that the project has been accorded environmental clearance and a copy of the clearance letter is available with the State Pollution Control Board and also at website of the State Level Environment Impact. Assessment Authority (SEIAA) at www.mpseiaa.nic.in and a copy of the same shall be forwarded to the Regional Office, MoEF, Gol, Bhopal.

20. Any appeal against this prior environmental clearance shall lie with the Green Tribunal, if necessary, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
