Sub:- Case No.5579/2017 Prior Environmental Clearance for Granite Deposit Mine (Open cast semi-mechanized method) in an area of 8.0 ha. for production capacity of 33125 TPA at Khasra no.110 (Part) at Village-Pratappura, Tehsil-Lavkushnagar, District-Chhatarpur (M.P.) by M/s D.G. Minerals Pvt. Ltd. Shri Dilip Gupta, Owner, 158, Third Floor, Zone-II M.P. Nagar ,District Bhopal (M.P.)

This has reference to your letter received in SEIAA office on 21.06.2017 and subsequent letters seeking Prior Environmental Clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of provisions under the EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application viz., the Form – I, Appendix-1 Mining Plan & EMP, the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

II. It has been noted that the proposal is for Granite Deposit Mine in an area of 8.0 ha. The mining lease area is located at khasra no. 110 (Part) at Village- Pratappura, Tehsil-Lavkushnagar, District-Chhatarpur The nearest village Pratappura is located at the distance of 375 m –NEN & the nearest village pond is located at the distance 0.30 km - NEN. There is no National Park/Sanctuary within 10 Km radius. There is no forest boundary within 250m from mining site.

The proposed project is for production capacity of 33125 TPA. The mining will be carried out by Open cast semi mechanized method. The water requirement is 107 KLD. The water met from Tankers will be used for domestic purpose, dust suppression and green belt development. An area of 5.85 ha area shall be covered under plantation and 9425 sapling shall be planted.

- III. The project has been considered in accordance with the provisions of the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated 14th September 2006.
- IV. Based on the information submitted, as at Para (II) above and others the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 456th meeting dtd. 16.11.2017 and decided to accept the recommendations of 81st SEAC-II meeting dtd. 22.06.2017.

Hence, Prior Environmental Clearance is granted for Granite Deposit Mine (Open cast semi-mechanized method) in an area of 8.0 ha. for production capacity of 33125 TPA at Village Pratappura, Tehsil Lavkushnagar, District Chhatarpur (M.P) for the lease period to M/s D.G. Minerals Pvt. Ltd. Shri Dilip Gupta, Owner, 158, Third Floor, Zone-II M.P. Nagar, District Bhopal (M.P.) 462011, subject to the compliance of following specific conditions as recommended by SEIAA & SEAC and subsequent Standard Conditions.

A. Specific Conditions

- Before commencing any mining activity fencing shall be carried out all around the lease area.
 Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- 3. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three row plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- 4. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- 5. Before commencing the mining activity, site demarcation should be done leaving 100 m. from the water body as a "no mining zone" and it will be maintained as buffer zone. The demarcation should be done by the Revenue Officials in the presence of WRD and Mining Officer, Chhatarpur. Plantation both side of canals.
- 6. PP shall ensure to construct and maintain approx 550 m Cement Concrete approach road and maintained the 01 km. existing PMGSY road at Village-Pratappura for transportation of material from ML area with cooperation of adjoining all lease holder in consultation with District Administration. Plantation will be carried out on both side of approach road.
- PP will plant 3 years old 750 trees saplings of suitable indigenous tree species in 0.50 ha barrier zone during first year.
- The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- No overburden will be dumped outside the mine lease area.
- Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB.
- 11. PP shall ensure generation of employment opportunities nearby Village on priority bases.
- 12. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- 13. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- 14. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields
- 15. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- 16. PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- 17. PP shall ensure proper implementation of plantation, dust suppression, construction of CC approach road, maintenance of 01 km. existing PMGSY road at Village-Pratappura for transportation of material and construction of garland drain with settling tank especially for prevention of pollution in nearby lake as part of Environmental Management Plan. Additional budget provision shall be made in EMP.
- 18. PP must ensure implementation of the following activities with separate budget provision should be kept under CSR:
 - a) PP shall ensure social welfare, skill development activities and sanitation programme at nearby village for woman & girls.
 - b) PP shall ensure education of villagers children, like books, stationary & Scholarship for 5 students etc.
 - c) PP shall organize health checkup camp for villagers
 - d) Providing two Computer in the Higher Secondary School in Village Hardua

Pratappura.

- e) Providing 5 no. of Solar Street Light provide to nearby villages Hardua, Pratappura, Bando, Bajura, Hasrai.
- f) PP shall ensure to maintain the approach road to mine site and PMSY Road.
- g) PP must ensure to leave 100 m near water tank as a "no mining zone". Demarcation should be done by the Revenue officials in the presence of representatives.

The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Grampanchayat.

- 19. PP shall ensure appropriate budget provision Rs. 11.20 Lakh per annum (as proposed) for the CSR activities
- 20. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 21. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
- 22. Transportation of material shall be done in covered vehicles.
- 23. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
- 24. Curtaining of site shall be done using appropriate media.
- 25. The proposed plantation should be carried out along as per the submitted proposal and PP would maintain the plants for five years including casualty replacement.
- 26. The OB should be properly stacked inside the ML area in barrier zone and disposed off as per the submitted plan.
- 27. Transportation shall not be carried out through forest area.
- 28. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 29. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 30. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded.
- 31. PP should also maintain a log book containing annual details of tree plantation and causality replacement.
- 32. Authorization under Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 should be obtained by the PP if required.
- 33. As proposed, garland drains with protective bunds all around the lease boundary (2523mx1.5mX1.0m) shall be provided along with 02 settling tanks (50mX20mX5.0m & 80mX20mX6.0m) for proper sedimentation and retention connected with garland drains shall be provided.
- 34. All garland drains shall be connected to settling tanks through settling pits and settled water shall be used for dust suppression, green belt development and beneficiation plant. Regular de-silting of drains and pits should be carried out.
- 35. Regular water spraying should be provided on 1.20 km long and 5.0 meter wide haul road and transportation road for dust suppression.
- 36. If any tree uprooting is proposed necessary permission from the competent authority should be obtained for the same.
- Appropriate and submitted activities shall be taken up for social up-liftment of the Region. Funds reserved towards the same shall be utilized through Gram Panchayat. Further any need base and appropriate activity may be taken up in coordination with local panchayat.
- 38. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 39. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change

in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.

40. Mining should be done as per the submitted land use plan submitted by PP

B. Standard Conditions

- Controlled blasting techniques, as and when required, shall be carried out in the day time only.
- Mining will be carried out as per the approved Mining Plan. In case of any violation of Mining Plan the Environmental Clearance given by SEIAA will stand cancelled.
- Effective safeguard measures, such as regular water sprinkling shall be carried out in critical areas prone to air pollution and having high levels of particulate matter such as loading and unloading point and all transfer points.
- 4. Where the quarry is in a hilly terrain and where some part of the hill is already cut for quarrying, further hill cutting shall not be done. In such cases, deepening the existing operational area may be preferably done.
- Precise mining area will be jointly demarcated at site by officials of Mining/Revenue department prior to mining operations for all proposals under consideration.
- The lease holder shall obtain necessary prior permission of the competent authorities for drawal of requisite quantity of water (surface water and groundwater), if required for the project.
- 7. Parking of vehicles should not be made on public places.
- Special Measures shall be adopted to prevent the nearby settlements from the impacts of mining activities. Maintenance of roads through which transportation of minor minerals is to be undertaken, shall be carried-out regularly.
- Measures for prevention and control of soil erosion and management of silt shall be undertaken.
- Trenches / garland drains shall be constructed at foot of dumps to arrest silt from being carried to water bodies.
- 11. The project proponent will ensure necessary protection measures around the mine pit, waste dumps and garland drain.
- 12. Top soil / solid waste shall be stacked properly with proper slope and adequate safeguards and shall be utilized for backfilling (wherever applicable) for reclamation and rehabilitation of mined out area.
- 13. Plantation programme shall be carried out as per EMP. Self sustenance of the vegetation should be ensured. No tree-felling shall be done in the leased area, except only with the permission from competent authority.
- 14. The vehicles transporting minerals shall be covered with a tarpaulin or other suitable enclosures so that no dust particles / fine matters escape during the course of transportation.
- Project Proponent shall ensure appropriate arrangement for shelter and drinking water for the mine workers.
- 16. Persons working in dusty areas shall be provided with protective respiratory devices and they shall also be imparted adequate training and information on safety and health aspects.
- 17. Dispensary facilities for first-aid shall be provided at site.
- 18. A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of the Local Bodies, Panchayat and Municipal Bodies, as applicable, in addition to the relevant officers of the Government
- 19. The Ministry or any other competent authority may alter/modify the conditions or stipulate any further condition in the interest of environment protection.
- 20. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.

21. Any appeal against this prior environmental clearance shall lie with the Green Tribunal, if necessary, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
