This has reference to your application No. Nil, dated 22.06.2011 received in SEIAA office on 23.06.2011 for seeking Prior Environmental Clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of provisions under the EIA Notification, 2006 and on the basis of the mandatory documents enclosed with the application viz., form I, form IA, Conceptual Plan, drawings & the additional clarifications furnished in response to the observations of the State Expert Appraisal Committee (SEAC) and State Environment Impact Assessment Authority (SEIAA) constituted by the competent Authority.

II. It has been noted that the proposal is for Group Housing "Coral Wood City" Proposed an area of 88,840.00 m² and has a built up area of 1,33,907.78 m² at Misrod, Tehsil Huzur, Distt- Bhopal. The height of tower proposed in the project is 18 m. The proposed total water requirement is 1,135 KLD, out of which 654.5 KLD shall be used for the domestic purpose while 280.5 KLD for flushing, 192 KLD for horticulture 8.1 KLD for DG cooling. Total waste water generation is 804 KLD. A sewage treatment plant of capacity 1000 KLD will be provided by the project proponent at site to treat the waste water generated. The Solid waste is about 3942.5 kg / day. The total power requirement for the proposed project will be 5198 KVA along with backup power facility of 02 DG sets of 750 KVA each. An area of 3100.00 sg m shall be covered under plantation.

- III. The project has been considered in accordance with the provisions of the EIA notification issued by the Ministry of Environment & Forests vide S.O. 1533 (E), dated September 14, 2006.
- IV. Based on the information submitted at Para II above and others, the State Level Environment Impact Assessment Authority (SEIAA) considered the case in its 103<sup>rd</sup> meeting held on 17.08.12 and decided to accept the recommendations of 87<sup>th</sup> SEAC meeting held on 07.01.12.

Hence, Prior Environmental Clearance for Group Housing Project "Coral Wood City" at Village Misrod, Tehsil Huzur, Bhopal, MP by M/s Rishi Constructions, Bhopal is accorded (for the Khasra numbers indicated in the layout map approved by Town and Country Planning Deptt. vide No. 393/L.P./175/29/Na.gra.ni/Ji.Ka/ 2010, Bhopal dtd. 17.02.2011) under the provisions of EIA notification dtd. September 14, 2006, subject to the compliance of the Standard Conditions enclosed at Annex-I and the following additional Specific Conditions as recommended by SEIAA & SEAC:

- i. It was noted that the PP has obtained the permission of the water supply for 935 KLD from the Bhopal Municipal Corporation (vide letter no. 118/PM/JNNURM/WS/11 dtd 23.09.11). It was decided that the fresh water demand should not to beyond 655 KLD as recommneded by the SEAC.
- Looking to the height of the building w.r.t. fire fighting provision it was decided that as per MP Bhumi Vikas Niyam- 2012 the width of internal front road should be 12 m and front M.O.S. 7.5 m and side & back MOS 6.0 m.
- PP shall promote schemes for conservation of water in such a way that the fresh water demand shall not go beyond 655 KLD.
- iv. PP shall use surface water supplied by the municipal corporation in the project as far as possible and no abstraction of ground water shall done with out obtaining the permission from CGWA.
- Structural design aspects in accordance to the seismic zone shall be strictly adhered to.
- vi. The construction materials and debris shall be properly stored and handled to avoid negative impacts such as air pollution and public nuisances by blocking the roads and public passages.
- vii. Environment Management Cell shall be formed, which will supervise and monitor the Environment related aspects of the project during construction and operational phases in addition to observance of Madhya Pradesh Building and other Construction Workers Rules.
- viii. Best available technology (BAT) such as Ultra violet radiation shall be used for disinfection of sewage before reuse / recycle / discharge.
- ix. Dual plumbing system as proposed shall be adopted for the re-use of treated waste water.
- x. The energy audit shall be conducted at regular interval for the project and the

- recommendations of the Audit report shall be implemented with spirit.
- xi. Common utilities like drinking water facility, Toilets etc. shall be provided on each floor with adequate signage thereof. Adequate distance shall be maintained between the drinking water and toilet blocks.
- xii. Necessary emergency lighting system along with emergency power back up system shall be provided. In addition, emergency public address system arrangement and signage for emergency exit route shall be provided on each floor.
- xiii. Necessary auto glow signage at all appropriate places shall be provided to guide the people towards exits and assembly points during the unforeseen emergency and eventuality conditions.
- xiv. Training to the staff for the first aid and fire fighting along with regular mock drill shall be made an integral part of the disaster management plan of the project.

Annex-I

Standard Conditions related to under item 8 (a) & 8 (b) of the schedule of EIA notification, 2006

(Building/ construction projects / area development projects & township)

#### A. Construction Phase

- 1. The construction site shall be provided with adequately barricades of at least 3 m height on its periphery with adequate signage.
- 2. All required sanitary and hygienic measures should be in place before starting any construction work and are to be maintained throughout the project phase.
- 3. Provision shall be made for the housing of construction labour within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile toilets, safe drinking water, medical health care, crèche etc. The housing may be in the form of temporary structures to be removed after the completion of the project.
- 4. Occupational health and safety measures for the workers including identification of work related health hazards, training on malaria eradication, HIV, and health effects on exposure to dust etc. shall be carried out. Periodic monitoring for exposure to respirable dust on the workers shall be conducted and records maintained including health records of the workers. Awareness programme for workers on impact of dust on their health and precautionary measures like use of personal equipments etc. shall be carried out periodically.
- 5. A First Aid Room will be provided in the project both during construction and operation of the project.
- 6. All the topsoil excavated during construction activities should be stored for use in horticulture/landscape development within the project site.
- 7. Disposal of muck during construction phase should not create any adverse effect on the neighbouring communities and be disposed taking the necessary precautions for general safety and health aspects of people, only in approved sites with the approval of competent authority.
- 8. Soil and ground water samples will be tested to ascertain that there is no threat to ground water quality by leaching of heavy metals and other toxic contaminants.
- 9. Construction spoils, including bituminous material and other hazardous materials, must not be allowed to contaminate water courses and the dump sites for such material must be secured so that they should not leach into the ground water.

10. Any hazardous waste generated during construction phase, should be disposed off as per applicable rules and norms with necessary approvals of the M.P. Pollution Control Board.

- 11. The diesel generator sets (if any) to be used during construction phase should be low sulphur diesel type and should conform to Environment (Protection) Rules prescribed for air and noise emission standards.
- The diesel required (if any) for operating DG sets shall be stored in underground tanks and if required, clearance from Chief Controller of Explosives shall be taken.
- 13. Wastewater generated from temporary leabour tents will be diverted to the sewer network in the area.
- 14. No water logging should take place at any point during construction phase.
- 15. If the project site is located within the 100 km of Thermal Power Stations, then fly ash should be used as building material in the construction as per the provisions of Fly ash Notification of September, 1999 and amended as on 27<sup>th</sup> August, 2003.
- 16. As far as possible ready mixed concrete should be used in construction work.
- 17. Vehicles hired for bringing construction material to the site should be in good condition and should have a pollution check certificate and should conform to applicable air and noise emission standards and should be operated only during non-peak hours.
- 18. Ambient noise levels should conform to residential standards both during day and night. Incremental pollution loads on the ambient air and noise quality should be closely monitored during construction phase. Adequate measures should be made to reduce ambient air and noise level during construction phase, so as to conform to the stipulated standards by CPCB/ MPPCB.
- Storm water control and its use should be as per CGWB and BIS standards for various applications.
- Water demand during construction should be reduced by use of pre-mixed concrete, curing agents and other best practices referred.
- 21. Care shall be taken during the wet drilling activities.
- Spread of contaminated water should be prevented by installing temporary barriers of G.I. Sheets.
- 23. To prevent surface and ground water contamination by oil/grease, leak proof containers shall be used for storage and transportation of oil/grease. The floors of oil/grease handling area will be kept effectively impervious.
- 24. On-site burning of waste material will not be permitted.
- Ground water should not be used during construction phase. Private tanker water suppliers may be asked to supply water during construction phase.
- 26. Commitment towards CSR have to be followed strictly.

27. Fixtures for showers, toilet flushing and drinking should be of low flow either by use of aerators or pressure reducing devices or sensor based control.

- 28. Wherever possible, the area around the STP / ETP should be surrounded with dense green belt.
- 29. To reduce the electricity consumption and load on air conditioning, high quality double glass with special reflective coating in windows should be promoted.
- Roof should meet prescriptive requirement as per Energy Conservation Building Code by using appropriate thermal insulation material to fulfill requirement.
- 31. Opaque wall should meet prescriptive requirement as per Energy Conservation Building Code which is proposed to be mandatory for all air-conditioned spaces while it is aspirational for non-air conditioned spaces by use of appropriate thermal insulation material to fulfill requirement.
- 32. Approval of the competent authority shall be obtained for structural safety of the buildings due to earthquake, adequacy of fire fighting equipments, etc. as per National Building Code including protection measures from lightening etc.

#### B. Operation Phase

- 1. The installation of the Sewage Treatment Plant (STP) as submitted by PP in the office of SEIAA should be certified by an independent expert and a report in this regard should be submitted to the Regional office of the Ministry of Environment & Forest, Gol before the project is commissioned for operation. Treated effluent discharge from STP shall be recycled/reused to the maximum extent possible. Treated effluent shall conform to the norms and standards of the M.P. Pollution Control Board. Necessary measures should be made to mitigate the odour problem from STP.
- 2. Treated waste water should not be used for air conditioning.
- 3. Treatment of 100% grey water by decentralized treatment should be done.
- The bio-medical waste (if applicable) generated should be disposed off as per the provisions of Bio-medical waste (Management and Handling) Rules 1988 as amended till date.
- Provision of separate entrance / exit gate should be made for collection of segregated bio-medical waste (if applicable) from the storage area.
- The solid waste generated should be properly collected and segregated. Wet garbage should be composted and dry/inert solid waste should be disposed off to the approved sites for land filling after recovering recyclable material as per CPCB norms.
- 7. Diesel power generating sets if proposed as source of back up power for elevators and common area illumination during operation phase should be of enclosed type and confirm to rules made under the Environment (Protection) Act, 1986. The height of stack of DG sets should be equal to the height needed for the combined capacity of all proposed DG sets. Low sulphur diesel must be used. The location of the DG sets may be decided with in consultation with Madhya Pradesh Pollution Control Board.

- No water logging should take place at any point during operation phase.
- The Project Proponent shall explore the possibility of using solar energy wherever possible.
- Provision for plantation has to be made as per Madhya Pradesh Bhumi Vikas Niyam, 1984.
- Any hazardous waste generated during operation phase, should be disposed off as per applicable rules and norms with necessary approvals of the M.P. Pollution Control Board.
- Noise should be controlled to ensure that it does not exceed the prescribed standards of CPCB.
- Weep holes in the compound walls shall be provided to ensure natural drainage of rain water in the catchment area during the monsoon period.
- 14. Rain water harvesting for roof run- off and surface run- off, should be implemented. Before recharging the surface run off, pre-treatment must be done to remove suspended matter, oil and grease. The bore well for rainwater recharging should be kept at least 5 mts. above the highest ground water table.
- The ground water level and its quality should be monitored regularly in consultation with Central Ground Water Authority.
- Traffic congestion near the entry and exit points from the roads adjoining the proposed project site must be avoided. Parking should be fully internalized and no public space should be utilized.
- 17. A Report on the energy conservation measures confirming to energy conservation norms finalize by Bureau of Energy Efficiency should be prepared incorporating details about building materials & technology, R & U Factors etc and submit to the Regional office of Ministry of Environment & Forest, GoI in three months time.
- 18. Energy conservation measures like installation of CFLs/TFLs for the lighting the areas outside the building should be integral part of the project design and should be in place before project commissioning. Used CFLs and TFLs should be properly collected and disposed off/sent for recycling as per the prevailing guidelines/ rules of the regulatory authority to avoid mercury contamination. Use of solar panels may be done to the extent possible.
- The building should have adequate distance between them to allow movement of fresh air and passage of natural light, air and ventilation.
- The area earmarked for the parking shall be used for parking only. No other activity shall be permitted in this area.

 Ozone Depleting Substances (Regulation & Control) Rules shall be followed while designing the air conditioning system (if any) of the project.

- 11. In the case of expansion, of any change in the scope of the project, the project shall again require prior Environmental Clearance as per EIA notification, 2006.
- 12. The SEIAA of M.P. reserves the right to artif additional safeguard measures subsequently, if found measures, and to take action implemental provisions of the Environment clearance under the provisions of the Environmental (Protection) Act, 1986, to ensure effective implementation of the suggested safeguard measures in a time bound and satisfactory manner.
- 13. All other statutory clearances such as the approvals for storage of diesel from Chief Controller of Explosives, Fire Department, Civil Aviation Department, Forest Conservation Act, 1980 and Wildlife (Protection) Act, 1972 etc. shall be obtained (as and when applicable), by the project proponent from the respective competent authorities.

- 14. These stipulations would be enforced among others under the provisions of Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and control of Pollution) act 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1991 and EIA Notification, 2006.
- 15. The proponent shall upload the status of compliance of the stipulated EC conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the Regional Office of MoEF, the respective Zonal Office of CPCB and the SPCB. The criteria pollutant levels namely; SPM, RSPM, SO<sub>2</sub>, NOx (ambient levels as well as stack emissions) or critical sectoral parameters, indicated for the project shall be monitored and displayed at a convenient location near the main gate of the company and in the public domain.
- 16. The environmental statement for each financial year ending 31<sup>st</sup> March in Form-V as is mandated to be submitted by the project proponent to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently, shall also be put on the website of the company along with the status of compliance of EC conditions and shall also be sent to the Regional Office of MoEF.
- 17. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- 18. A copy of the environmental clearance shall be submitted by the Project Proponent to the Heads of the Local Bodies, Panchayat and municipal bodies as applicable in addition to the relevant officers of the Government who in turn has to display the same for 30 days from the date of receipt.
- 19. The Project Propenent shall advertise at least in two local newspapers widely circulated, one of which shall be in the vernacular language of the locality concerned, within 7 days of the issue, of the clearance letter informing that the project has been accorded environmental clearance, and a copy of the clearance letter is available with the State Pollution Control Board and also at website of the State Level Environment Impact Assessment Authority (SEIAA) at www.mpseiaa.nic.in and a copy of the same shall be forwarded to the Regional Office, MoEF, Gol, Bhopal.
- Any appeal against this prior environmental clearance shall lie with the Green Tribunal, if necessary, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
