Sub: Case No 8634/2021: Prior Environment Clearance for Stone Quarry in an area of 21.10 ha. for production capacity 6,00000 cum per annum at Khasra No. 201/1, Village - Mudahara, Tehsil - Gaurihar, Dist. The case was discussed in 688th SEIAA meeting dtd 01.10.2021 and it has been recorded that

".....Being it's a case of cluster of more than 5.0 ha. area thus, committee recommended to issue standard TOR prescribed by the MoEF&CC for conducting the EIA along with following additional TOR's and general conditions as per Annex. D"

After detailed discussion, it was observed that this is a first case of highest production capacity (6,00,000 Cum) belongs to tehsil Gaurihar, district Chhatarpur. In the past, there were number of cases of this area, found controversial/ revoked by SEIAA.

In this case, no details of firm/ company have been submitted and a person shri Manoj Kumar Mishra, resident of district Madhubani, Bihar has signed some papers, but in what capacity & who has authorized him? As per the photocopy submitted by PP a letter issued by Director, Geology & Mining, Bhopal (M.P.) for allotment of 21.00 ha area is addressed to M/s Rockphailer Gramudhyog Sewa Sansthan, Hameerpur, U.P. without complete address sanctioned on the basis of seniority and rejecting the claims of number of other applicants. Since, this project is having a very large area 21.00 ha and it will have huge environmental impact, hence above details are to be collected first then the case will be considered by SEIAA.

In view of above, you are hereby directed to clarify the above mistakes in all the documents duly signed by Shri Manoj Kumar Mishra without authorization of M/s Rockphailer Gramudhyog Sewa Sansthan, UP submittd before SEIAA. As well as, it is also directed to clarify the designation of Shri Manoj Kumar Mishra in M/s Rockphailer Gramudhyog Sewa Sansthan and submit the authorization letter of Shri Manoj Kumar Mishra by the firm alongwith legal status & registration letter of the firm, so that the further decision can be taken by the committee.
