(1) PP had applied in Form-7 for transfer of Prior Environmental Clearance for Stone Quarry in an area of 2.0 ha. for production capacity of 18810 cum per annum at Khasra No. 239/1/min-2, at Village - Manpura, Tehsil - Shamgarh, Dist. Mandsaur (MP) by Shri Prathviraj Singh S/o Shri Ranjeet Singh, Village - Guradiya Mata, Dist. Mandsaur,

(2) The Prior Environmental Clearance was issued by DEIAA Mandsaur vide letter No. DEIAA/ 2016/ 81, dated 30.05.2016 in the name of Shri Anil Kumar s/o Devilal Chandel Residence Bhanpura Road, Garoth- Tehsil Garoth, District Mandsaur

(M.P.).

(3) It is noted that in support of his request the PP has submitted the following documents:

No Objection Certificate in the form of Notarized Affidavit submitted by Shri Anil Kumar S/o Devilal Chandel Residence Bhanpura Road, Garoth- Tehsil Garoth, District Mandsaur (M.P.) for transfer of prior EC in the name of Shri Prathviraj Singh S/o Shri Ranjeet Singh, Village - Guradiya Mata, Dist. Mandsaur, (MP) and mentioning that no legal action/ credible action has been initiated against the leasee till date.

(ii) Notarized affidavit of Shri Prathviraj Singh S/o Shri Ranjeet Singh, Village -Guradiya Mata, Dist. Mandsaur, (MP) mentioning that no legal action/ credible action has been initiated against the mine till date and commitment to comply all

the standard and specific conditions stipulated in the prior EC issued.

(4) It is noted that in EIA Notification 2006 as per Para-11 Transferability of

Environmental Clearance (FC) there is a provision of transferring the EC.

Para-11:- A prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period. No reference to the Expert Appraisal Committee or State Level Expert Appraisal Committee concerned is necessary in such cases.

After detailed discussion, it was found that the mine site is not included in District Survey Report. Hence, it is decided that the case will be considered after receiving certificate of Mining Officer ensuring that the proposed mine shall be included in the updated DSR.

As per above decision you are requested to provide a copy letter ensuring that the proposed mine shall be included in the updated DSR, as earliest so that further decision may be taken.
