It was noted that PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter No. 1976 dated: 21/01/19 has reported that there are 02 more mines operating or proposed within 500 meters around the said mine with total area of 6.450 ha., including this mine.
