1. **Case No. 46/2008-** Prior Environmental Clearance for **Bachaha Ochre Mine** in an area of 13.808 ha. at Village-Bachaha, Tehsil-Manpur, District-Umaria, by M/s Harrish Minerals Supply Company, Jaitwara, District-Satna (M.P)-485221.
  - (1) The case was considered in 121<sup>st</sup> SEAC meeting dtd. 28.02.2013 and it was recorded..... ***It was observed by the committee that the maximum validity of the existing TOR (i.e four years) in accordance to the MoEF OM dated 22.03.2010 has already expired on 22.03.2012. Hence no further extension can be granted, the PP may be advised to re-apply in the prescribed form as per the procedures laid in the EIA notification. The case is recommended for delisting.***
  - (2) It was noted that after Registration the Case was sent to SEAC vide L.No. 33 dtd. 29.04.2008. The SEAC issued ToR vide L.No. 331 dtd. 07.08.2008. The PP vide letter dtd. 27.01.2013 has requested for extension of validity of ToR and PP's letter was sent to SEAC vide L.No. 2129 dtd. 04.02.2013 for necessary action.

(3) Agreeing with the recommendation of SEAC it was decided to close the case summarily and inform the PP and concerned accordingly.

2. **Case no. 607/2010**, Prior Environmental Clearance for Basalt Stone mine-Crusher Unit (Open cast/Semi Mechanized method) in an area of 37.5 ha for Production Capacity 12,00,000 m<sup>3</sup>/annum at Khasra No. 62/1/1 at Village Rangwasa, Teh-Depalpura, Distt. Indore (M.P) by Shri Manoj Kumar, M/S IVRCL Infrastructure & Projects Ltd. IVR Indore Gujrat Tollways Ltd. (Mining Unit), office camp Village-Gyanpura, Jhabua Road, Dhar (M.P)-454001.

(1) The case was discussed in 74<sup>th</sup>, 82<sup>nd</sup>, 98<sup>th</sup> & 100<sup>th</sup> SEAC meeting dated 05.01.2011, 13.04.2011, 23.07.2012 & 21.08.2012 respectively and **recommended in 121<sup>st</sup> SEAC meeting dtd. 28.02.2013** ..... based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 10 conditions.**

(2) It was noted that as per 55<sup>th</sup> & 65<sup>th</sup> SEIAA meeting dated 28.03.2011 & 26.08.2011, the PP was asked to submit the application in revised format. The application in revised format received from PP was forwarded to SEAC vide L.No. 488 dtd. 16.09.2011 for Prior Environmental Clearance of **Basalt Stone Mine-Crusher Unit** (Open cast/Semi Mechanized method) in an area of 37.5 ha. for proposed production capacity (by PP) of 12,00,000 m<sup>3</sup>/annum at **Survey No. 62/1/1** at Village Rangwasa, Teh-Depalpura, Distt. Indore (M.P.).


(3) Indore Municipal Corporation has been declared as Critically Polluted area by the Central Pollution Control Board. According to the general condition provided at end of the schedule in the EIA Notification 2006 if any project is located within distance of 10 km from the periphery of critically polluted area, then SEIAA has no jurisdiction to consider application for grant of prior EC. To ascertain this issue letter was sent to Collector, Indore (vide letter no. 104 dtd 24.05.11 & 490 dtd 16.09.11) as per decision of 55<sup>th</sup> SEIAA meeting held on 28.03.2011. However, no information has been received from the Collector so far. A DO letter is to be sent to him under the signature of the Member Secretary to make this information available within one month. The letter should be endorsed to the PP also.


3. **Case No. 613/2010** Prior Environmental Clearance for expansion of dolomite & limestone mine (Open cast/Fully Mechanized method) in an area of 19.71 ha for enhancement of production capacity from 6660 TPA to 5,00,000 TPA at Khasra No. Part of 31 and 13 at village Chhaparwah, Tehsil Badwara, District Katni by M/s Ultra Tech Cement Ltd.

(1) The case was discussed in 77<sup>th</sup>, 99<sup>th</sup>, 103<sup>rd</sup> & 104<sup>th</sup> SEAC meeting dated 25.08.2011, 24.07.2012, 12.09.2012 & 30.09.2012 respectively. The case was recommended for Grant of Prior EC in 99<sup>th</sup> SEAC meeting dtd. 24.07.2012 and **121<sup>st</sup> SEAC meeting dtd. 28.02.2013** ..... based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 12 conditions.**

(2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Dolomite & limestone Mine** (Open cast/Fully Mechanized method) in an area

of 19.71 ha. for enhancement of production capacity from 6660 TPA to 5,00,000 TPA at **Survey No. Part of 31 and 13** at Village Chhaparwah, Tehsil Badwara, District Katni (M.P.).

(3) It was noted that the case was discussed in 96<sup>th</sup>, 99<sup>th</sup> & 104<sup>th</sup> SEIAA meeting dtd. 11.06.2012, 11.07.2012 & 04.09.2012 and following issues were resolved:

- The issue of transfer of Prior EC from M/s Grasim Industry Ltd. (White Cement Division) to M/s Ultra Tech Cement Ltd. (Birla White Division) was decided.
- The following issues were discussed in 104<sup>th</sup> SEIAA meeting dtd. 04.09.2012:-
  - i. *The project proponent shall henceforth submit a certified report of the status of compliance of the conditions stipulated in the environmental clearance for the ongoing / existing operation of the project by the Regional Offices of the Ministry of Environment and Forests.*
  - ii. *The status of compliance of the conditions stipulated in the environmental clearance as highlighted in the report(s) will be subsequently discussed by the respective Expert Appraisal Committees during the appraisal of the expansion proposal and duly recorded in the minutes of the meeting.*
  - iii. *The PP should submit copy of the latest compliance report to SEAC. SEAC will further appraise and send their views to the office of SEIAA by 31<sup>st</sup> October, 2012, positively.*
  - iv. *Member Secretary, MPPCB should be asked to provide the information by 30.09.2012, whether any notice has been served under Air Pollution (Prevention) Act 1981 & Water Pollution (Prevention) Act 1974 against the prior EC issued to the PP.*
  - v. *PP should be asked to provide information by 31st October 2012 whether he has been served any notice under Environment Protection Act 1986?*
  - vi. *It was found that the PP has applied for the expansion from 6660 TPA to 500000 TPA, while SEAC in its 99<sup>th</sup> meeting dated 24.07.12 has recommended (at pt.no.4) that "under no circumstances the production should go beyond 45000 MTPA". It was decided that a clarification should be obtained from MS, SEAC in this regard by 31<sup>st</sup> October, 2012.*


(4) .....In response to above Point No. a, b, c PP vide letter dated 15.02.2013 had submitted certified compliance report which was sent to SEAC vide L.No. 2832 dated 13.03.2013. **SEAC in its 121<sup>st</sup> meeting dated 28.02.2013/05.03.2013 has appraised the compliance report and again recommended the case for grant of Prior EC subject to the 4 additional conditions.**

(5) .....In reference to above Point No. d & e, MPPCB and PP had informed that notice under Environment Protection Act 1986 and Air Act 1981 and Water Act 1974 was not issued to PP.

(6) In reference to Point No. f SEAC in its 103<sup>rd</sup> meeting dtd. 12.09.2012 had cleared that the production capacity was quoted wrongly as 45,000 MTPA instead of

5,00,000 MTPA and it should be read as ***under no circumstance the production should go beyond 5,00,000 MTPA.***

(7) It was found that as per approved mining plan vide No. MP/Katni/Dol/Mod-M.Sch-02/11-12 dated 12.01.2012, the available reserve is 2587712 ton. Production during gestation period of one year is 522407 ton. After gestation period remaining reserve will be available 2065305 ton. As per proposed production capacity of 5 lack TPA, the anticipated life of mine is 5 years i.e.  $1 + \{2587712 - 522407\} / 500000 = \text{five years.}$

(8) It was noted that the proposed case is of enhancement of production capacity from 6660 TPA to 5,00,000 TPA which is about 75 times higher than previous one and it is found that the EIA report has not been critically analyzed by the SEAC in terms of magnitude of environmental impact and mitigative measures thereof. It was decided that SEIAA office will examine the EIA report in this context very soon and the case will be put up for consideration in the meeting.

4. **Case No. 631/2011**, Prior Environmental Clearance for Group Housing Project "Chinar Dream CT" land area 95456.68 sqmt. ( T & CP approval) 11.362 ha (Form-1) at Village Ratanpur Sadak and village Narela Hanumant, Tehsil Huzur, District Bhopal, MP by M/S Chinar Reality Pvt. Ltd. through Director Shri Sunil Moolchandani, House No. 231, Zone-II, MP Nagar, Bhopal.


(1) The case was discussed in SEIAA 117<sup>th</sup> meeting dtd. 22.01.13 ".....and it was recorded that " .....


ii. *In response to the above queries information submitted by PP vide their letter No. NIL dt. 28.12.2012 was examined and it is noted that the fresh water demand is of 411 KLD. It was decided that as submitted by PP the fresh water requirement should not exceed 411 KLD as against the condition of fresh water quantity (571 KLD) approved by SEAC (93<sup>th</sup> SEAC meeting dtd 10.04.12). In view of vicinity of the project area to the Bhopal township regarding the source of water it was decided that PP should be asked why Municipal Water is not being used for the project and PP should submit details of efforts made by him regarding Municipal Water Supply.*


iii. *It was noted that regarding fire fighting NOC, PP has submitted copy of application submitted to Bhopal Municipal Corporation. It is decided that PP should submit clear fire fighting NOC from the Bhopal Municipal Corporation or competent authority.*

iv. *It was decided that PP should submit the above information by 15.03.2013."*

(2) As per 111<sup>th</sup> SEIAA meeting dtd 23.10.2012 it was noted that there is disparity in water demand and availability. As per PP the water requirement was 467 KLD while as per 93<sup>rd</sup> SEAC meeting recommended that fresh water demand should not go beyond 571 KLD and sewage should not exceed 629 KLD. Accordingly letter was sent (dtd 15.11.2012) to SEAC. The case was discussed in 121<sup>st</sup> SEAC meeting dtd 05.03.2013 and it is mentioned that the fresh water requirement & waste-water generation for the project has been quoted incorrectly

5. **Case No. 685/2012-** Prior Environmental Clearance for Proposed "Maple High Street" Commercial Shopping Mall (land area 10114.96 sqmt. i.e. 1.01 ha & total builtup area 25255.35 sqmt.) at Khasra No. 367, 374, 386/1 village Bawadian Kalan, Hoshangabad Road, Opp Ashima Mall, Tehsil – Huzur, Distt. – Bhopal (M.P.) – 462036 by Global Properties Pvt. Ltd., through Shri Manoj Jain (Partner).

- (1). The proposed project is Commercial shopping Mall " Maple High Street " at Khasra No. 367,374, 386/1 village - Bawadian Kalan, Hoshangabad Road, Opp Ashima Mall Tehsil – Huzur, Distt. – Bhopal (M.P.) – 462036 by Global Properties Pvt. Ltd., through Shri Manoj Jain (Partner).
- (2). The total land area & built up area proposed by PP is 10114.96 sq. m. & 25255.37 sq m. respectively. (Form-1 & 93<sup>rd</sup> SEAC meeting minutes dtd 10.04.12). The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 as the total construction is between 20,000 sqmt. & 1,50,000 sqmt. The project includes Commercial shopping Mall (Offices + Shops + Hotel +) (G+5 floor).
- (3). The case was discussed in SEAC meetings 93<sup>rd</sup> SEAC mtg. dtd. 10.04.12, 109<sup>th</sup> SEAC mtg. dtd. 06.11.12 and 121<sup>st</sup> SEAC mtg. dtd. 05.03.13 and in 121<sup>st</sup> SEAC meeting recommended for grant of prior EC subject to 07 special conditions.
- (4). As per the letter from T & CP Bhopal to BDA (vide L. No. 704 dtd. 30.10.09) the total land area is 39.963 ha at Village – Bawadian Kalan, Tehsil – Huzur, Distt. – Bhopal (M.P.).
- (5). The Proposed land (village Bawadia Kalan Khasra No. 367, 374, 386/1) area 4.99 acres is included in Vidhya Nagar Scheme Phase –II of BDA. Vide letter no. 288 dtd 19.08.2011 BDA has given NOC to M/s Global Properties through Partner Shri Jayant Bhandari for 108837.00 sqmt. commercial use. PP has submitted notarized copy of agreement dtd 25.03.2010 between BDA and Global Properties through Shri Jayant Bhandari.
- (6). As per Khasra Panchsala 2011-12 submitted by the PP land is in the name of M/s Global Properties Pvt. Ltd. through partners Shri Manoj Boolchandani and details of khasra nos. are as follows :-

Planning approval (dtd 30.10.2009) is issued to BDA for 39.963 ha and the survey nos. are not mentioned in the said approval. It is decided that:-

- i. PP should submit notarized copy of latest Khasra Panchsala mentioning the area and ownership for each individual survey number (367, 374, 386 / 1) included in the project.
  - ii. Town & Country Planning approval and approved layout plan for the proposed commercial complex by PP.
- b. It is noted that the applicant is Global Properties Pvt. Ltd through Shri Manoj Jain (Partner) while the land is in the name of Global Properties Pvt. Ltd through Manoj Bulchandani (partner) and the NOC from BDA is in the name of M/s Global Properties through Jayant Bhandari (Partner). PP has not submitted partnership deed. It is decided that PP should submit notarized copy of registered partnership deed.
- (7). PP should submit the above information by 15.07.2013.

- (1) The case was **recommended in 120<sup>th</sup> SEAC meeting dtd. 27.02.2013** ..... based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 11 conditions.**
- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Stone Boulder, Murrum Mining & Crushing for Execution of the Work Khandaphod-Nachalbhor Road** in an area of 2.54 ha. for production capacity of Stone Boulder 1,60,000 m<sup>3</sup> per year & Murrum 10,000 m<sup>3</sup> per year at Khasra No. 60 at Village-Papdapani, Tehsil-Bagli, Distt.-Dewas (M.P.). It is found that PP has submitted the copy of the letter from office of the Collector (Mining), District-Dewas (vide No. 1155 dated 23.10.2012) wherein temporary permission for mining is mentioned.
- (3) As per information given by the PP in Appendix-1 duly certified by Conservator Forest & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- (4) It was noted that as per **Appendix-I**, certified by the Tehsildar, there is no habitation/settlement and water body at the **distance of 500 m. from the mining site.**
- (5) It was noted that the information about the distance of mining site from the Forest (Reserved/Protected) land is not available in the records.
- (6) It was noted that neither PP nor SEAC has mentioned about the distance of the any other mine from the proposed mining site.
- (7) The SEAC has recommended two years lease period.

(9) It was decided to accept the recommendation of 120<sup>th</sup> SEAC meeting dtd 27.02.2013 to grant Prior Environmental Clearance for **Stone Boulder, Murrum Mining & Crushing for Execution of the Work Khandaphod-Nachalbhor Road** in an area of 2.54 ha. for production capacity of Stone Boulder 1,60,000 m<sup>3</sup> per year & Murrum 10,000 m<sup>3</sup> per year at Khasra No. 60 at Village-Papdapani, Tehsil-Bagli, Distt.-Dewas (M.P.) for lease period of **Two years** by Shri B.R. Goyal, Infrastructure Pvt. Ltd., 3-A, Agarwal Nagar, Near Vikram Tower, Sapna-Sangeeta Road, Indore (M.P.)-452001 subject to the following conditions :-

- In case if the distance is less than 250 m. it was decided that the Collector would ensure that the PP has obtained the NOC from the committee constituted under the Chairmanship of PS Forest before execution of quarry agreement / mining.
- Before granting the lease or permit to the PP the Collector will ensure that, there is no other prior existing mining lease or permit in operation at or within the distance of 250 m. from the this case mining area which makes the total mining lease area more than 5.0 ha. He shall intimate the position within one month to the SEIAA.


In case there is no other mining lease or permit in operation within 250 m. distance the Collector will also ensure that the permission for any new mine will not be granted without Prior EC from competent authority.

- **The collector will get a detailed EMS from PP and approve it before granting mining lease or permit.** Following points should be incorporated in the EMS :-
  - Precaution during dumping and stabilization of the top soil to be excavated and its utilization for rehabilitation of the land after quarrying.
  - Scheme of removal, storage and utilization of overburden.
  - Scheme of plantation of trees.
  - Measure for prevention air and water pollution.
  - Specific measures for addressing socio-economic concerns of local inhabitants like health, water, employment etc.
  - Other measures to be taken for minimizing the adverse effect of quarrying operation on the environment.
- The Collector or an officer authorized by him will ensure the implementation of the EMS accordingly.
- The PP will submit the approved copy of the EMS to the SEIAA office within 15 days of its approval from the collector.
