Ltd, at Plot No. – 6, 7, 8, 11, 12, 13, Sector I, Industrial Area, AB Road Near Tata Square, Tehsil & Distt. Dewas (M.P.) by Mr. Ashish Tiwari M/s Varun Fertilizer Pvt. Ltd. 203, 2nd Floor, Indore Trade Centre, South Tukoganj, Indore, (M. P.).
 - (1) Prior Environmental Clearance has been issued earlier (vide letter no. 1779 dtd 21.12.2012 in case no. 662/2012) by MPSEIAA to PP for production capacity enhancement from 30 TPD to 350 TPD powder SSP at plot no. 6, 7, 8, 11, 12, 13 Industrial area, Sector -1, AB Road, Dewas, MP.
 - (2) PP has applied vide letter dtd 28.01.2013 received in SEIAA office on 30.01.12 for change in the product form from powder SSP (350 TPD) to Granulated SSP (350 TPD).

- (3) The case was considered in 122nd SEAC meeting dtd 11.03.2013 and has been recommended for grant of prior EC.
- (4) The case was discussed in depth and it is noted that :-
- PP has applied for change in the product form from powder SSP to granulated SSP. The production capacity and the proposed site and area is same for which the earlier EC was issued by MPSEIAA (dtd 21.12.2012).
 - Neither ToR has been issued by SEAC nor the EIA Report has been prepared and submitted for appraisal for the change in product form from Powder SSP to Granulated SSP. SEAC has given recommendation on the basis of information submitted and signed by PP in Form-1. No comparison has been done regarding the pollution load w.r.t air, water, noise for the production of powder SSP and Granulated SSP.
 - As per Para 1 clause (ii) of MoEF GoI circular no. J-11013/41/2006-IA-II (I) dtd 14.12.2006- clarification regarding EIA clearance for change in product mix, *Project involving increase in pollution load will have to obtain Prior Environmental Clearance under EIA Notification 2006. If no increase in pollution load takes place due to revised process then no EC is required. If EC is required then prescribed procedure under EIA Notification 2006 is to be followed. Such comparative figures of "Pollution Load" for the original and proposed revised process must be available in the record and it is not there. Hence, it is decided that PP should submit details of :-*
 - The additional raw material and process requirements
 - Projected changes in emissions, effluents, solid waste etc.
 - A comparative statement of the pollution load w.r.t. air, water and noise for the powder SSP (350 TPD) and Granulated SSP (350 TPD).
 - The above information should be duly authenticated and signed by the Accredited Consultant, of the PP.
- (5) PP should submit above information by 30.06.2013 positively.

Part-II: - Cases related to Minor Minerals below 5 ha.

2. **Case No. 1191/2013-** Prior Environmental Clearance for Sand mine (Manual method) in an area of 3.00 ha. for production capacity 11,282 cum/year at Khasra No. 54 at Village Musamundi, Tehsil Dindori, District Dindori, MP by Shri Shivcharan Armo S/o Shri Vishali Singh, Village Musamundi, Tehsil Dindori, District Dindori (MP)-481882.
- (1) The case was **recommended in 121st SEAC meeting dtd. 28.02.2013** based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 13 conditions.**


- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Sand mine** (Manual method) in an area of 3.00 ha. for production capacity of 11,282 cum/year at **Survey No. 54** at Village Musamundi, Tehsil Dindori, District Dindori (M.P.). It is found that PP has submitted the copy of the order from office of the Collector (Mining), District-Dindori (vide L.No. 29 dated 11.01.2013).
- (3) As per information given by the PP in Appendix-1 duly certified by Conservator Forest & Nayab Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- (4) It was noted that as per **Appendix-I**, certified by the Nayab Tehsildar, there is habitation/settlement, and Primary School at the distance of about 300 m. **from the mining site.**


In this context it was decided to write to the Collector for seeking information regarding the exact distance of the settlement, number of houses & Primary School from the mining site and impact of mining activity on them. These information should be available to SEIAA within one month. A copy of the letter should be endorsed to the PP also.

- (1) The case was **recommended in 121st SEAC meeting dtd. 28.02.2013** based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 13 conditions.**
- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Sand Mine Project** (Manual Method) in an area of 1.619 ha. for production capacity of 80,000 cum per six months at Khasra Nos. 612/1 at Village-Barua, Tehsil-Gourihar, Distt.-Chhatarpur (M.P.). It is found that PP has submitted the copy of the letter from office of the Collector (Mining), District-Chhatarpur (vide No. 1939 dated 11.12.2012) wherein temporary permission for mining is mentioned.
- (3) As per information given by the PP in Appendix-1 duly certified by Conservator Forest & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- (4) It was noted that as per **Appendix-I**, certified by the Tehsildar, there is no habitation/settlement and water body **within 500 m. from the mining site.**
- (5) It is noted that the distance of mining site from the Forest Boundary is 9 k.m. (vide Conservator Forest, Chhatarpur L.No. 436 dtd. 19.02.2013).



- (6) It was noted that neither PP nor SEAC has mentioned about the distance of the any other mine from the proposed mining site.
- (7) The PP has proposed the lease period for six months (Form-1 & Appendix-2) and SEAC has recommended six months lease period.
- (8) The Environmental Management Scheme (EMS) submitted by the PP as a part of **Appendix-II** was examined and found that the EMS as submitted by PP is sketchy.
- (9) It is noted that this case is of Sand Mining from PP's own agriculture land not from the river bank. As per Tehsildar L.No. 256 dtd. 21.10.2011 & L.No. 27 dtd. 23.01.2013 and Conservator Forest L.No. 437 dtd. 19.02.2013, the sand has been deposited in PP's land due to flood.
- (10) It was decided to accept the **recommendation of 121st SEAC meeting dtd. 28.02.2013** to grant Prior Environmental Clearance **for Sand Mine Project** (Manual Method) in an area of 1.619 ha. for production capacity of 80,000 cum in six months at Khasra No. 612/1 at Village-Barua, Tehsil-Gourihar, Distt.-Chhatarpur (M.P.) for lease period of **Six months** by Shri Hariya S/o Shri Ramlal Khangar, Village-Barua, Tehsil-Gourihar, District-Chhatarpur (M.P.)-471001 subject to the following conditions :-
- Before granting the lease or permit to the PP the Collector will ensure that, there is no other prior existing mining lease or permit in operation at or within the distance of 250 m. from the this case mining area which makes the total mining lease area more than 5.0 ha. He shall intimate the position within one month to the SEIAA.

In case there is no other mining lease or permit in operation within 250 m. distance the Collector will also ensure that the permission for any new mine will not be granted without Prior EC from competent authority.
 - **The collector will get a detailed EMS from PP and approve it before granting mining lease or permit.** Following points should be incorporated in the EMS :-
 - Precaution during dumping and stabilization of the top soil to be excavated and its utilization for rehabilitation of the land after quarrying.

- (1) The case was **recommended in 121th SEAC meeting dtd. 28.02.2013** based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 11 conditions.**
- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Stone Boulder mine with crusher** (Manual method) in an area of 1.050 ha. for production capacity of 50,000 cum/year at **Survey No. 201/1** at Village Ratua, Tehsil Bairasia, District Bhopal (M.P.). It is found that PP has submitted the copy of the order from office of the Collector (Mining), District-Bhopal (vide L.No. 234 dated 28.01.2013).
- (3) As per information given by the PP in Appendix-1 duly certified by DFO & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- (4) It was noted that as per **Appendix-I**, certified by the Tehsildar, there is no habitation/settlement and water body within **500 m. from the mining site.**
- (5) It is noted that the distance of mining site from the Forest Boundary not within 1500 m. (vide DFO, Bhopal L. No. 1731 dtd. 07.11.2003).

- (1) The case was **recommended in 122th SEAC meeting dtd. 11.03.2013** based on the submission of documents and presentation made by the PP the committee has **recommended for grant of prior EC to the project subject to the 13 conditions.**
- (2) It was noted that the PP has applied in **Form-I** for Prior Environmental Clearance of **Stone Boulder mine with crusher** (Manual method) in an area of 4.00 ha. for production capacity of 20,000 cum/year at **Survey No. 1216/1** at Village Kathairi, Tehsil Sarai, District Singrauli (M.P.). It is found that PP has submitted the copy of the order from office of the Collector (Mining), District-Singrauli (vide Endt. No. 1888 dated 05.11.2012).
- (3) As per information given by the PP in Appendix-1 duly certified by DFO & Tehsildar, the Interstate Boundary and National Park/Sanctuary are not within 10 Km. radius. Hence, **General Conditions are not attracted.**
- (4) It was noted that as per **Appendix-I**, certified by the Tehsildar, there is no habitation/settlement and water body within **500 m. from the mining site.**
- (5) It was noted that the information about the distance of mining site from the Forest (Reserved/Protected) land is not available in the records.

- (6) It was noted that neither PP nor SEAC has mentioned about the distance of the any other mine from the proposed mining site.
- (7) It was noted that the PP has proposed the lease period for 10 years but SEAC **has recommended 2 years lease period without mentioning any reason.**

In view of above Member and Member Secretary decided the maximum period for **Ten years**. However, Chairman recorded his dissent on the basis of decision taken in 117th SEIAA meeting dated 22-01-2013, which is mentioned at Para no 10 of Point no 13 of the minutes. The relevant lines of the Para showing the reason of dissent are given hereunder;

- In case if the distance of mining site is less than 250 m. from forest land the Collector would ensure that the PP has obtained the NOC from the committee constituted under the Chairmanship of PS Forest before execution of quarry agreement/ mining.
- Before granting the lease or permit to the PP the Collector will ensure that, there is no other prior existing mining lease or permit in operation at or within the distance of 250 m. from the this case mining area which makes the total mining lease area more than 5.0 ha. He shall intimate the position within one month to the SEIAA.

In case there is no other mining lease or permit in operation within 250 m. distance the Collector will also ensure that the permission for any new mine will not be granted without Prior EC from competent authority.

- **The collector will get a detailed EMS from PP and approve it before granting mining lease or permit.** Following points should be incorporated in the EMS :-
 - Precaution during dumping and stabilization of the top soil to be excavated and its utilization for rehabilitation of the land after quarrying.
 - Scheme of removal, storage and utilization of overburden.
 - Scheme of plantation of trees.

- (5) It is noted that the distance of mining site from the Forest Boundary not within 460 m. (vide DFO, Dindori L. No. 4352 dtd. 18.05.2012).

- Precaution during dumping and stabilization of the top soil to be excavated and its utilization for rehabilitation of the land after quarrying.
 - Scheme of removal, storage and utilization of overburden.
 - Scheme of plantation of trees.
 - Measure for prevention air and water pollution.
 - Specific measures for addressing socio-economic concerns of local inhabitants like health, water, employment etc.
 - Other measures to be taken for minimizing the adverse effect of quarrying operation on the environment.
