(A) Cases recommended for Prior Environmental Clearance

M/s R K Minerals Corporation Sawarkar ward Nai Basti, Katni M.P., Limestone & clay mine 15.04 hact. at village – Hinotapatkui, Teh-Banda, Distt-Sagar M.P.
 Case no 227/2008

The above case was recommended by SEAC for prior environmental clearance.

SEIAA accepted the recommendation of SEAC and decided to accord prior environmental clearance to the above project.

2. Creative House-were Pvt. Ltd, B-13, Rico Housing Colony, P.O. Bewhror-Alwar, Rajasthan, Mini Cement Plant 100 TPD 31-33 Industrial area, Lamtara, Teh.&Distt-Katni-M.P. *Case no 435/2009*

The above case was recommended by SEAC for prior environmental clearance. SEIAA accepted the recommendation of SEAC and decided to accord prior

SEIAA while scrutinizing the documents observed that in the Forest Deptt. NOC the Khasra nos and area are not correctly mentioned. The NOC does not specify the distance of mining lease area from the inter state boundary and from the protected areas under Wildlife Protection Act 1972.

SEIAA while scrutinizing the documents observed that the distance of mining lease area from the protected areas under Wildlife Protection Act 1972 has not been mentioned in the Forest Deptt. NOC.

Hence it was decided to send the case back to SEAC for reconsideration on the above ground.

5. M/s Laxminarayan mining Co., Shri Shantilal Balmukund, Somani-241, Pratappur marg, Alirajpur, Jhabua M.P., Dolomite mine 8.093 ha. 4000 TPA at Vill-Panwani, Teh- Alirajpur, Distt-Jhabua, *Case no 136/2008.*

The above case was recommended by SEAC for prior environmental clearance.

SEIAA while scrutinizing the documents observed that the distance of mining lease area from the protected areas under Wildlife Protection Act 1972 has not been mentioned in the Forest Deptt. NOC.

Hence it was decided to send the case back to SEAC for reconsideration on the above ground.

6. Satguru Cement Pvt Ltd, 102, Golden Tower 94/47, Sneh Nagar, Main Road, Indore- M.P., Mini cement plant 30,000 TPA to 95,000 TPA at village- Ghursal, Jeerabad, The- Gandwani, Distt- Dhar M.P. *Case no 248/2008*

The above case was recommended by SEAC for prior environmental clearance.

SEIAA accepted the recommendation of SEAC and decided to accord prior environmental clearance to the above project.

7. M/s Dolphin marbles Pvt. Ltd, New Bus stand, Katni M.P, Marble mine 6.02 ha. at Kachhargaon, Teh-Bahuriband, Katni M.P. *Case no 203/2008*

The above case was recommended by SEAC for prior environmental clearance.

SEIAA while scrutinizing the documents observed that the Forest Deptt. NOC submitted is a hand written photocopy. It does not specify the distance of mining lease area from the protected areas under Wildlife Protection Act 1972. It is expected that an attested copy of the Forest Deptt. NOC should be submitted.

Hence it was decided to send the case back to SEAC or reconsideration on the above ground.

8. Gopal Enterprises, 4-Old Palasia, A-B Road, Indore M.P., Stone Gitti mine (quarry) 7.5 ha. at Bicholi Mardana, Indore- M.P. *Case no 106/2008*

The above case was recommended by SEAC for prior environmental clearance.

SEIAA decided to defer the decision in this case till next meeting.

9. M/s Sukhedeo Prasad Goenka, Station Road, Katni-M.P., Limestone & Dolomite mine 5.46/4.40 ha. At village Haraiya, Teh- Vijayraghogarh, Distt-Katni-M.P. *Case no 549/2010*

The above case was sent back by SEAC for further action.

SEIAA while scrutinising the documents observed that the Project Proponent has been alloted 4.40 hect. of mining lease in place of 5.46 hect. The mining lease area is less than 5.00 hect. Hence does not come under the purview of the EIA notification of 14th September 2006.

It was decided by the SEIAA to delist the case on the above grounds.

It had been decided earlier by the Authority to write to the Collector Indore & Commissioner Indore Municipal Corporation requesting them to clarify whether the projects under consideration of the SEIAA proposed at Indore, fall within the critically polluted areas of Indore as mentioned in the MoEF's Memorandum. But no communication has been received so far and the decision in these matters are getting delayed.

Hence it was decided to get required information in this regard from the Regional Officer, M.P. Pollution Control Board, Indore, to enable the Authority to decide such cases expeditiously.

(C) Other Cases

 M/s Shukdeo Prasad Goenka, C/o Goenka Bhawan, Katni M.P., Laterite yellow ochre and manganese red oxide, red ochre mines fire clay 48.562 hact. Vill- Jhinna Teh- Dhimmerkhera, Distt- Katni M.P.case no 153/08

The Authority heard the Project Proponent of the above case during the meeting. He explained that no case of illegal mining has been registered against him. The Authority has already written to the Collector, Katni in this regard. No communication has been received by the Authority from the Collector.

Hence it was decided to defer the decision till next meeting.

The project proponent of the above case submitted and afficavit for return of land, copy of planning permission document and staggerd requirement of water and a commitment letter to supply water from the Municipal Authorities were submitted to the authority for its consideration.
