Minutes of the 5th SEIAA meeting held on 4th December, 2008

The fifth meeting of State Level Environment Impact Assessment Authority was convened on 4th Dec.'2008 at 11.00 A M at Authority's office in M.P. Pollution Control Building, Paryavaran Parisar, Bhopal chaired by Shri Subroto Banerji.

- (I) Following cases recommended by SEAC for granting environmental clearance were discussed.
 - **1.** Kanha Mall, Multiplex & Kanha Towr at Bag Sewania, Bhopal M.P. M/s Rakesh Lila, Dharmendra Liala, E-4/132, Arera colony, Bhopal, **Case no 18/2008.**

The above case was sent to SEAC for reconsideration on certain grounds. SEAC in their meeting held on 25th Oct. 2008 has reconsidered on the points raised by SEIAA and have again recommended for granting environmental clearance.

SEIAA after taking note of SEAC's recommendations decided to accord environmental clearance to the project.

2. Arya Energy Ltd, D-1, Maruti Enclave, Tatibandh, Raipur, Chatisgarh, 12 MW capacity biomass based power plant at vill- Gohandra & Dongratota Teh-Kotma, Distt- Anuppur **Case no 174/2008.**

The above case has been recommended by SEAC for granting environmental clearance.

During scrutiny of the documents submitted by the project proponent it was found that the permission for two tube wells has been given by the Tehsildar while Sub Divisional Magistrate is the competent authority for the same. The project proponent may be asked to obtain the permission from SDM Annuppur and submit to SEAC.

Hence it was decided to send the case back to SEAC to obtain the above permission from project proponent.

SEIAA agreed with the recommendation of SEAC and decided to reject the above three cases.
