The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. Confirmation of minutes of 102nd & 103rd meetings of SEAC dated 11th and 12th September 2012

The minutes of the said meetings were confirmed and approved. Copy the said minutes have already been forwarded to SEIAA earlier with signature of the local members and the Member Secretary

2. Consideration of the Projects

These are the mining cases with MLA less than 5 Hectare. Committee has pointed out that till date of this meeting no guidelines / directions have been confirmed by the SEIAA for appraising these cases. Committee has decided to write a reminder letter to SEIAA in this context. It was also decided by the committee that these cases may kept on hold like similar other cases presented in earlier meetings till the guidelines are finalized & conveyed by the SEIAA. Following projects were taken up for discussion on general and location related aspects:
