SEIAA further examined the case and referred the case to SEAC for a review in light of following quarries:

- 1. Measures to avoid water logging at the site.
- 2. Sources of water during construction phase.
- 3. Measures for safe disposal of sewage and the STP sludge.

In view of above quarries, SEAC asked the proponent [vide its letter no. 682 dated 30/09/2008] to respond to the above quarries along with the contouring of the proposed site to assess the problem of water logging (if any).

Reply to the above quarries have been submitted by the proponent vide letter dated 15th October 2008 [Copy enclosed]. Reply reveals following points of concern:

Measures to avoid water logging at the site-

Contour map of the area with 0.5m interval, has been submitted, [copy enclosed].
There won't be any water logging.

Sources of water during construction phase-

 Proponent has submitted that the water required during construction phase shall be purchased from the market.

Measures for safe disposal of sewage and the STP sludge-

Regarding safe disposal of sewage, solid waste and STP sludge project proponent has undertaken to submit that the sewage shall be disposed off into the sewage line of Municipal Corporation after appropriate treatment. The solid waste from the community shall be segregated at source, the bio-degradable waste is proposed to be composted and utilized for in-house gardening purpose whereas the non-biodegradable waste shall be disposed off at the landfill site of Municipal Corporation after taking necessary approval from the Municipal Corporation.

On the basis of the response submitted by the project proponent the case is submitted to SEIAA.

- 2. To ask the proponent to obtain building permission for proposed construction and submit the same.
- Regarding possible consequences on environment of extracting ground water committee earlier has already examined the case critically, based on the information and hydrological studies submitted by the proponent vide letter dated 01/08/08.
- Project proponent has submitted that they have applied for the building permission.

However, committee has recommended to ask the project proponent:

- To submit building permission from the concerned agency, only than the case shall be considered for EC and
- to furnish the details regarding availability of ground-water & other sources for the project & permission for ground- water extraction from CGWB.

Delhi furnished by the PP, it reveals that the area falls under <u>'Safe Category area on ground water resource considerations'</u> accordingly the concerned agency has issued NOC to the project proponent for extraction of 411 m³ water per day.

However, committee has recommended to ask the proponent to furnish the details regarding availability of ground-water & other sources for the project
