This clearly indicates that misleading information has been given in mine plan thus case is rejected and file is sent back to SEIAA.

Discussion on the projects referred back by SEIAA and the query responses

1. Case No. 2668/2015 - Shri Nitish Arjaria, M/s Khajuraho Stone (India) Pvt. Ltd., 6th Km., Sagar Road, Dhadari, P.O. & District-Chhatarpur (M.P.)-471001.Stone Quarry Lease Area - ha.4.00 ha., Capacity -1,00,000 cum/year, at Village-Ghoora, Tehsil-Rajnagar, District-Chhatarpur (MP).

The case was recommended by SEAC in the 200th meeting dated 30/06/2015 for grant of prior EC subject to several special conditions including one of condition of obtaining \pm Necessary clearance from standing Committee of NBWL/MoEF & CCø, SEIAA through its 218th meeting dated 14/07/2015 returned the case to SEAC asking clarification for putting the above condition. The matter was reviewed by the committee in the meeting and it wqs observed that the project site is reported to be 8.5 Km from the boundary of Core zone and 7.6 Km from the boundary of Buffer zone of the Panna Tiger Reserve by the Chief Wild Life Warden. The Chief Wild Life Warden has granted NOC for the project vide letter no. 3659 dated 26/05/2015 along with a copy of authentication of the location on map imposing the above condition. The O.M. of MoEF & CC no. J-11013/41/2006-IA.II(I) dated 02/12/2009 also spells out that the projects falling within 10 Km from the boundary of PA (where eco-sensitive zone is not yet notified) may be considered for EC

only when application has been filed for Wild Life Clearance and a copy of the same is furnished to SEAC/SEIAA. It also states that a special condition shall be stipulated that the EC is subject to their obtaining prior clearance from forestry and wild life angle including clearance from the standing committee of NBWL as applicable. Accordingly the said condition has to be imposed in the EC. Hence committee stands with its earlier recommendations

2. Case No. 920/12 - Smt. Sangeeta Sharma, 77, Sawan Nagar, Lalghati, Bhopal, (M.P.) PP req Submission/ inf. Dt. 25/09/14 E.C. for approval of 03.670 Hectares Renewal Stone/Boulder Quarry at Vill.-Barkheda Bondar, Teh.-Huzoor, Dist.-Bhopal.

The case was recommended for grant of EC by SEAC in the 153rd SEAC meeting dated 21/10/2014. SEIAA returned the case to SEAC with request for carrying out site visit to assess possible impacts of mining activity on adjoining sensitive features if any. Based on the visit report recommendations TOR was issued for the project to carry out EIA in the 203rd SEAC meeting. PPøs request for review was received through SEIAA. It was stated by the PP that the cumulative Mining lease area within 500 meters around the said mine is only 7.87 Ha comprising only two mines of the same proponent. The distance of this mine was reported to be about 650 meters from the nearest habitation i.e. building of Police Housing Society and no other sensitive feature exists in proximity of the said lease area. PP has also agreed to leave the adjacent lease area (mentioned as Case no. 921/2012) as no mining area. This lease area comprising 2.0 Ha falls towards the building of Police Housing Society and distance of the project boundary from the same is about 500 meters. The matter was reviewed by the committee and found the submissions made by the PP satisfactory and acceptable. Accordingly committee decided to with draw the TOR and recommends the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :Aø

- 1. The production capacity shall be as per the approved Mining Plan not exceeding 9000 m3/Year.
- 2. The mine adjacent to this project (registered as Case no. 921/2012) shall not be excavated.

The case was recommended for grant of EC by SEAC in the 153rd SEAC meeting dated 21/10/2014. Based on the visit report recommendations TOR was issued for the project to carry out EIA in the

203rd SEAC meeting. PPøs request for review was received through SEIAA. It was stated by the PP that the cumulative Mining lease area with in 500 meters around the said mine is only 7.87 Ha comprising only two mines of the same proponent. The distance of this mine was reported to be about 500 meters from the nearest habitation i.e. building of Police Housing Society and no other sensitive feature exists in proximity of the said lease area. PP has also agreed to leave this lease area as no mining area and allow mining in the adjacent area registered as case no. 920/12. The matter was reviewed by the committee and found the submission made by the PP is acceptable. Accordingly committee decided to with draw the TOR and recommends the case for delisting and closing.

4. Case No. 2252/2014 Shri Mohammad Shaft S/o Shri Akram Kha. Vill. Sehore, Tehsil – Dharampur, Distt. Dhar- proposed Kheda Stone Quarry in an area of 4.00 ha. at Village-Kheda, Tehsil-Dhar, District-Dhar (MP).

PPøs request for withdrawing the application has been forwarded by SEIAA. Committee accepted the request and recommends for closing the case as per the request of PP after verification that the request has been made by the authentic proponent.

5. Case No. 2286/2014 Shri Vishnu Choudhary S/o Shri Radhakrishan Choudhary, Village-Khandwa, Tehsil & District-Dhar (MP)-454001- proposed Stone Quarry in an area of 3.00 ha. at Village-Khandwa, Tehsil-Dhar, District-Dhar (MP).

PP¢s request for withdrawing the application has been forwarded by SEIAA. Committee accepted the request and recommends for closing the case as per the request of PP after verification that the request has been made by the authentic proponent.

6. Case No. - 2351/2015 Shri Yogendra Singh S/o Shri Raghuveer Singh, Bhagwaanganj, Sagar (MP)-470001 3029 dt. 09-01-15, Rec. dt. 15/01/15 Basalt Stone Quarry Lease Area - 2.50 Ha., at Village-Khejrbaag, Tehsil-Sagar, District-Sagar (MP) Capacity - 5,000 Cubic meter/Year

The case was considered in the 179th SEAC meeting and whereby, based on the presentation and scrutiny of the case committee decided to recommend the case for rejection in view of following facts: 1. DFO has reported that the proposed land is a grazing landø and allocation of the same shall exert pressure on adjoining forest area for grazing. 2. Distance of the forest boundary is reported to be approximately 255 meters and exact distance from the forest boundary is not known in this case.

The case was returned by SEIAA along with the representation submitted by the PP for reconsidering the case based on the documentation submitted by the PP. Record

- 1. The production capacity shall be as per the approved Mining Plan not exceeding 5000 m3/Year.
- 7. Case no. 720/2012 Smt. Manisha Nayak, M/s Sohini Agency Pvt. Ltd., Nayak House, 114 Manbhawan Nagar, Madaorao Sindhiya Chauraha, Indore (M.P.) Bijaiyan Laterite & Quartz Deposit Mine at Khasra No. 59 Part, 88 Part, 90 Part, 91 Part, and 92 Village Bijaiyan, Tehsil Sihora, Distt. Jabalpur.

The case was recommended in 164th SEAC meeting and was returned by SEIAA through its 184th meeting to SEAC for seeking clarification on life of the mine. It was pointed out by SEIAA that the Mine Plan for the project reports the mine life as 14 years considering the rate of production as 5000 TPA whereas PP and SEAC have considered the mine life as 09 years considering the production rate as 10000 TPA. Examination of the case could not reveal any clarification hence it was decided to call the PP for the same in coming meetings.

8. Case No. - 2298/2014 Shri Arjun Singh Chouhan S/o Shri Soman Singh Chouhan, Village-Doulatganj, Tehsil-Taal, District-Ratlam (MP) Basalt Stone Quarry Lease Area -2.00 ha.,. at Khasra No. -04, Capacity-11400Cu.mt./Year, Village-Kharwakalan, Tehsil-Taal, District-Ratlam (MP)

The case was considered in the 178th SEAC meeting where by scrutiny of the case revealed that the Mining Plan and submitted documents has several discrepancies based on the same it was decided to return the case to SEIAA for delisting - ·

- Mandatory Buffer zone around the mine has not been left.
- Total of post mining land-use is exceeding the actual lease area.
- Surface plan not submitted with the Mine Plan.
- Scrutiny of the mining plan reveals the presence of certain scheduled animals in the area which needs confirmation from the forest department. The DFO in his letter has not commented on this issue.

The case was returned by SEIAA for reconsideration based on the submissions made by the PP. It was decided to consider the case only after receiving revised Mining Plan addressing the above issues.

PP has submitted the requisite documents. Thus, committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure $A\alpha$

As per application an enhancement in production capacitywas envisaged in the project from 15000 TPA to 16000 TPA. Later PP submitted a request vide letter dated 20/07/15 stating that the Mining Plan for the project has been approved for 12072 TPA hence accordingly an amendment has been requested by the PP in the issued TOR. Committee accepted the request and decided to issue amended TOR as requested subject to the following conditions:

Tehsil-Rajnagar, District-Chhatarpur (MP). The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 325 dated: 27/4/2015, has reported that there are two more mines operating or proposed within 500 meters around the said mine and the total area is 7.62 ha. including area of this mine. The EMS and other submissions made by the PP were found to be satisfactory and acceptable.

The case was presented in the 218th. SEAC meeting Dated 42/08/15 wherein PP was asked to submit application for wild life clearance to NBWL as Ken Sanctuary is 5.5 Kms away for further consideration of the case. PP vide letter Dated 27.08.2015 has informed that they have made online submission for wild life clearance and attached the e-receipt and copy of application made for wild life clearance. Being the case is of Granite Mine, PP should submit detailed site specific õEnvironmental Management Planö, through QCI/NABET accredited consultant along with tehsildargs certificate.
