technical presentation on their projects.

2. Lawyer and the Officials of M.P. State Mining Corporation submitted that their projects on sand quarries are not covered in the EIA Notification and requested for exemption from obtaining EC. Here, SEAC finds it worth mentioning that the issue was discussed in length with the Officials of M.P. State Mining Corporation and their Lawyer earlier during the meeting held on 29th May 2009. Whereby, the Proponents requested some time to submit reply / application pertaining to the discussions.
3. The applicants were informed that no submission in this context has been received by the SEAC so far. It was also informed that the SEAC is a technical advisory committee to SEIAA and has to deliver recommendations to SEIAA based on the environ- technical aspects of the projects.
4. As the matter regarding legal aspects is already under trial with Hon'ble High Court, SEAC can appraise the projects on Environmental considerations.
5. In view of above, committee requested the proponents to present the technical aspects and salient features of the sand quarries but the proponent and their lawyer insisted on their request for exemption from obtaining EC.
6. Representatives of The M.P. State Mining Corporation disagreed to deliver any presentation on their projects. Thus, the committee decided to issue standard TOR based on the applications and merits / demerits of the projects.

Building and Construction projects covering built-up area of  $\geq 20000$  sq.mtrs and  $< 1, 50,000$  sq.mtrs. shall be appraised under the B1 [8(a) ] Category of the Schedule of EIA Notification-2006. The present project is a proposal for Construction of Medical College with 150 admissions & Hospital with 750 beds, at Sagar.

Hence the project was appraised by the SEAC. Salient features of the project are as follows:

- Total water requirement: 700 KLD. The water requirement as reported shall met through Municipal Corporation Sagar.
- Total land area is 12.5 Ha and total built up area is 108650 sqm.
- Approved development plan from Town & Country Planning Deptt., Land Diversion from Competent Authority has been submitted by the proponent.
- Total demand of electricity load is about 7.5 MVA; the power supply shall be

- made through state electricity board. For back-up power supply 3 DG sets of 500 KVA will be installed.
- It is also reported during presentation that the incinerator shall be installed in the land about 2 Km away from the site. This land is under the process of procurement.
  - Similarly it was submitted by the PP that another piece of land adjacent to the site shall be procured for parking and green belt development.
  - After detailed deliberations on the project the PP was asked to present reply on following queries which were raised by the committee:
1. Quantity and source of water during construction and operational phases have to be reported separately accordingly necessary permission / commitment from the concerned agency to be submitted.
  2. A lay-out of the site showing proposed green area & locations of tube-wells have to be furnished with area calculation for green belt. 33% of total area should be ensured for green area in the proposal.
  3. Location of the site and the proposed additional land (where ETP, STP & incinerator etc. is proposed) - showing land use of at least 2-6 Km area around these has to be provided.
  4. Documents pertaining to procurement of additional land.
  5. Category-wise Quantity & space for storing the segregated BMW prior to disposal, location of incinerator, shredder, autoclave and deep-burial site has to be submitted on lay out.
  6. Details of the design and specification of deep burial site and incinerator has

7. ETP / STP details to be provided along with the disposal of liquid effluent.
8. Proposal for the re-use and recycle of treated effluent has to be submitted.
9. Details of the safety measures to be provided w.r.t. to fire, accidents, radiations etc,
10. Plan for disposal of hazardous wastes (used oil and filters from DG-Sets or any other HW expected) to be submitted.
11. Building permission from Municipal Corporation to be furnished.
12. Wind speed / direction with wind rose to be submitted.
13. Analyses of water and the base line ambient air quality to be reported through Govt. approved laboratory.
14. Use of solar energy has to be promoted; in view of this a plan has to be submitted.
15. Quantification of the recharge expected from water harvesting system to be furnished. Precaution taken to avoid any infiltration of infectious contaminants from Bio-medical waste has to be addressed.

- located within 2 Km around the mining site.
3. EMP should address the steps planned to avoid any disturbance in the routine activities of aquatic animal which may be caused due to mining.
  4. Mining should be planned at least 50-100 meters away from the main stream of the water body. Accordingly, drawing of demarked mining area should be furnished.
  5. Measures planned or taken to check the soil erosion due to transportation have to be detailed out.
  6. Sand-loading station should be at least 100 meters away from the main stream of the water body, location to be shown on a map.
  7. Sand should be transported in covered vehicles to avoid dispersion of particles in atmosphere.
  8. Mining or loading/ unloading should be avoided at junctions or turning points of the water body (river).
  9. Safe distances from Railway and Road bridges should be maintained, these distances have to be reported in the report.
  10. Safe distance from monuments of Local or Archeological importance and the fragile areas such as National Parks, Wild Life Sanctuaries, Protected Forests etc. should be maintained in accordance to the rules and guidelines laid down by the concerned departments.
  11. Permissions and NOCs' from various departments such as Forest, Gram Panchayat and Local Bodies etc. have to be furnished with report.
