

1. Opening Remarks of the Chairman

The Chairman welcomed all the members of the Committee (**Annexure-1**) and thereafter agenda items were taken up for deliberations. The list of participants present during meeting is annexed as **Annexure-2**.

2. Consideration of the Projects

12 Cases (for TOR / EIA / Query Reply deliberations) were invited. Out of these proposals only 09 proposals were presented before the committee. It is decided to hold the 64th meeting on 31th Aug 2010.

Ground water table is reported to be 8mbgl (332m AMSL) and Ultimate working depth is 7m (333m AMSL). Nearest Village is Jarahmohgaon - 500 meters in SE. No national parks and sanctuary has been reported in the vicinity. Sonawani Reserve Forest is reported at 8.5km in North. Jamunia Nalla in West is reported to be at 1 km and Jamunia Canal in the West at 50 meters from the mining site. Proposed mining operation will be carried out by manual method of mining using hand tools such as spades, hammer, crowbar, chisel etc. Loading of mineral in to truck/ dumper will be done manually by head load using can basket and tasla etc. The average thickness is considered to be 2m on the basis of occurrence of ore body in old excavations as well as exposures. The mining operations will be taken up in the southern part of the area. The proposed pit will be rectangular longer side will be parallel to the strike line of the ore body an shorter will be parallel to the dip direction. The mining operations will be done by open cast manual method like breaking after drilling sorting screening stacking loading etc and it will aided by mining machineries such as compressors, jack hammers, etc. Public hearing issues were discussed in detail; no adverse point was raised in the public hearing. PP has submitted an affidavit for compliance of the suggestions received during the public hearing. NOC from DFO, Balaghat has been submitted which reveals that the site is at 2250 meters away from the forest land and the site is tree-less. Pp has reported that about 4.79 Ha out of 11.766 Ha shall be planted within the lease period.

After deliberations committee has asked the PP for submission of reply with supporting documents on following queries:

- NOC from Gram Sabha to be submitted.
- In view of proximity to the canal leachate study of OB to be submitted.
- Location of OB area to be planned as far as possible from the canal plan to be submitted accordingly.

This being a mining project with lease area between 50 ha to 5 ha is listed at S.N. 1(a) of schedule under 'B' Category of EIA Notification, 2006 and is to be appraised by SEAC. PP and his consultant presented the EIA / EMP before the committee. During deliberations it was reported that, Sindursi Laterite & Hematite Mine is situated in village Sindursi village, Tehsil-Sihora, District Jabalpur (M.P). The ML has been granted for 20 years period w.e.f. 09.09.2004 to 08.09.2024 in the name of M/s Jai Minerals. Vide letter .no. 3-17/91/12/2 dated 28.08.2004. The Mining Plan was approved on 04.09.2008 vide letter no MP/Jabalpur/ Laterite/ MPLN/ Mod.03/08-09 under the rule 10(1) of MCDR 1988. MPSEAC has issued a project specific TOR vide letter no. 101 dated 04-06-2008 to carry out EIA / EMP. Public Hearing for the project was completed on 1st April 201 The mine is existing but presently closed. Type of lease area is reported to be Govt. Barren Land, authenticated by local Patwari. Nearest Habitation is Sindursi at a distance of 600 meters towards West and altitude of the Site- 380 m AMSL to 407 m AMSL. Mining Method proposed – Opencast Other Than Fully Mechanized. The ultimate depth of mine is reported to be 25 m from top. Surface R.L (407m AMSL). Level of Ground Water is reported to be 12m to 15m bgl (368m to 365m AMSL). Mining will not intersect the ground water table

Life of the Mine is 39 years. Chandela Reserve Forest is reported at 6.9 km. Nearest River is Ken River at 4.2 km. Inter-state boundary is reported to be More than 20 km. No National Park/ Heritage site or Ecological Sensitive Zone has been reported in 10 km radius. Plantation is proposed in 1.65 ha. Stripping Ratio is 1:0.2. Ultimate depth of mine 8.0 Bgl (Max). PP and his consultant presented the case for approval of TOR before the committee. During the presentation it was informed that, the mine exists but presently closed. Type of mining proposed is manual and fully mechanized. Piprahath Limestone mine is located in Piprahath Village of Tehsil Maihar, District Satna, of State M.P. Area of the Mining Lease is 7.316 ha. Earlier Mining Lease was sanctioned to Shri Ram Lubhaya Sehgal for 20 years upto 08.11.2002. which was further renewed for 20 years upto 08.11.2022. Further the mining lease has been transferred to Shri. Ram Lal Daftari vide State Govt. order dated 20.08.2008. The lessee intend to produce 5,00,000 TPA of Limestone. Ultimate Depth of Mine is 15 m and Ground Water Table is 20 m BGL the Mining will not intersect the ground water table.

Nearest water body reportes is Chakdahi Nalla at 500 meters from the site towards South and Tamasa River is reported at 6 Kms in North. Hardua R.F is at 6 Kms in South of the site. Nearest habitation is Piprahath village at 1.0 Km. The site

- Details of STP with quality of treated effluent.
- Plan for disposal of sludge.
- Conceptual plan (on map) showing the location and area marked for STP, MSW storage, bore wells, rain-water harvesting pits and plantation.

- 10. Case No. 108/2008** Comm., Municipal Corp., Jabalpur(M.P.) Construction of proposed MSW Landfill site at Kathonda, Jabalpur **Query Reply Presentation.** TOR issued dated- 23/12/08. The EIA was presented before the committee in the 46th meeting dated 28/01/2010. Sub-committee of SEAC also visited the site on 18/02/2010.

Brief of the project

Projects pertaining to Common Municipal Solid Waste Management Facility (CMSWMF) have been listed at SN 7(i) under B category of the Schedule of EIA Notification 2006. The present project is a Common Municipal Solid Waste Management Facility (CMSWMF) proposed for Jabalpur city hence was appraised by the SEAC. The case was earlier presented in the 58th, 63rd and 64th EAC meetings of MoEF, New Delhi. Latter the case was transferred to SEAC for further action the matter as it falls under 'B' category projects. SEAC issued TOR for carrying EIA / EMP vide letter dated 23/12/2008. Municipal Corporation Jabalpur the Project proponent along with their consultation has made a detail presentation of the EIA/EMP for development of MSW Land-fill site at village Kathonda Distt. Jabalpur (M.P). The area of land-fill site is 24.6 Ha out of which 4.88 Ha is proposed for compost plant. Land has been acquired by Municipal Corporation Jabalpur. Presently MSW of Jabalpur city is being dumped in the Ranital area which is proposed to be shifted in organized land-fill site proposed at village Kathonda. EIA report and the presentation made thereby reveals following:

- Quantity of solid waste generated – 428 MT/Day. About 75 % of generated MSW shall be collected which would be taken to the land-fill site. Sorting of bio-degradable, re-cyclable and inert material is proposed at site. The segregated inert material (about 163 MT/day) shall be dumped in the land-fill site. The bio-medical waste from hospitals is collected and disposed off separately.
- The site shall be adequate to serve for 20 years.
- Proposed capacity of the compost plant is 256 MT/day.
- Public Interest Litigations have been filed pertaining to development of this site. It was reported that decision in one of the litigation has been given whereas decision pertaining to other litigation is yet to come out.
- Land-fill site- Lining of 1.5 mm high density polythene will be laid down. Leachate water shall be collected and sent to the STP proposed at site.

It was informed by the PP that the proposed project is more than 500 mts. away from residential area and all measures shall be provided to handle odour nuisance and disinfection of the region. Being a govt. project R&R plan shall be taken up as per the provisions of government.
- PP has submitted the NOC from Town & Country Planning Deptt, Ground water Board and Air Port Authority.

Multiple queries were raised by the committee and sub-committee and PP was asked to submit and present the reply with supporting documents on the same.

- Per capita MSW generation has been taken as 500 gm/ day, for calculation, projections and design of the facility; which is on the maximum side.
- Separate provisions to collect the compostable waste from major sources such as hotels, vegetable markets (Mandi) etc has been proposed.
- Segregation – methodology for segregation of bio-degradable, plastic, re-cyclable and other wastes at site was also submitted – which reveals that the door to door collection and segregation of waste shall be done involving NGOs’.
- Essential facilities such as proper boundary with gate, measures taken to avoid entry of un-authorized person and animals, approach road, facilities for record keeping, pollution monitoring, weighing bridge, drinking water facility for workers, safety & fire fighting equipments etc. have been submitted as desired by the committee.
- Site selection criteria was found to be satisfactory, distance of village Kathonda is about 500 meters from MSW disposal site which as per the MSW Rules 2000.
- Land-fill design specification has been submitted in detail, which is as per the Guidelines of MSW Rules 2000. Leachate collection pipe will be provided at the bottom of the land-fill site and leachate will be treated in the STP which adjoining to MSW site.
- Detailed Plantation scheme with lay out on a map has been furnished; 30% of the total MSW area has been allocated for plantation this may be raised to 33% min. plantation area
- Details on R&R plan has been submitted with supporting photographs.

PP has submitted that municipal waste generated from cantonment area of Jabalpur shall also be accommodated in this site. After deliberations, committee decided to recommend the case for grant of prior Environmental Clearance to the project with inclusion of above conditions.

Regarding difference in the water demand and permissible ground water draft, PP has submitted and presented revised water balance sheet as per the MoEF guidelines. As per the guidelines PP has re-calculated the fresh water requirement which reveals a reduction of 36% water in flushing and washing, with total fresh water requirement of 1052 KLD for which PP has obtained permission from Central Ground Water Authority. The case is recommended for grant of prior environmental clearance.
