The 30th meeting of the Second State Expert Appraisal Committee (SEAC-II) for mining projects was held on 04th June, 2016 under the Chairmanship of Dr. Navin Chandra for discussion on the query responses submitted by the PP and the projects issues received from SEIAA. The following members attended the meeting-

The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. Case No. – 1427/13 M/s Shri Ram Traders, Prop. Shri Leelaram Gupta, Doli Road, Barhi Distt. Katni (M.P.) Environmental Clearance for Mining of Stone. Lease area 1.89 ha. capacity 70,000 cum/year at Khasra No. 1048/1, 1048/3 at village Bichpura, Tehsil Barahi, Dist. Katni (M.P.) (Submit maps duly approved by the competent authority)

This is case of Stone mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 1048/1, 1048/3 at village Bichpura, Tehsil Barahi, Dist. Katni (MP) 1.89 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 3733 dated: 07/09/2015 has reported that there are 08 more mines operating or proposed within 500 meters around the said mine with total area of 15.53 ha including this mine.

The case was presented by the PP in the 264th SEAC meeting dated 12/01/2016 wherein during scrutiny of documents it was observed that maps attached with the mine plan are not approved by the competent authority. Thus PP was asked to submit maps duly approved by the competent authority.

Today, Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the

committee during the deliberation. Earlier case was discussed in the 264th SEAC meeting dated 12/01/2016 wherein PP was asked to submit maps duly approved by the competent authority. PP was also informed vide letter no. 316 dated 02/03/2016 to submit the desired information within 15 days but no information is submitted by the PP.

Committee decided that since the area of this mine is < 5.00 ha and as per MO certificate the cluster area is of 15.53 ha including this mine with no individual mining lease area is >5.00 ha, this case may be transferred to DEIAA.

2. <u>Case No. – 2601/15 Shri Umashankar Mishra, M/s Uma Shankar Mishra, Indira Nagar, Rewa (M.P.)-486001 Prior Environment Clearance for approval of Laterite, Quartz & Clay Mine Lease Area - 8.04 ha., Capacity -15,028 cum/year, at Khasra No.-4, 94, 95 Vill.-Umaria, Teh.-Dheemarkheda, Distt.-Katni (M.P.) EIA Presentation</u>

This is case of Laterite, Quartz & Clay Mine. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-4, 94, 95, at Vill.-Umaria, Teh.-Dheemarkheda, Distt.-Katni (M.P.) 8.04 Ha. The project requires prior EC before commencement of any activity at site.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. The case was earlier listed in the 196th SEAC meeting dated 02/06/2015, 233rd SEAC meeting dated 29/10/2015 and 244th SEAC meeting dated 08/12/2015 wherein PP remains absent. Committee decided that since sufficient opportunites have been given to the PP for appraisal and consideration of the project wherein PP remain absent, the case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project.

3. <u>Case No. – 3029/15 Shri Babulal Patwala S/o Shri Ambaram Patwala, 91, Sukhniwas, Teh. & District-Indore (M.P.)-455001. Basalt Stone Quarry Lease Area - 3.740 Ha for expansion in production Capacity from 15,772 cum/year to 20,000 cum/year, at Khasra No.-37/1, Vill. -Dhamanda, Teh.-Dewas, District-Dewas (M.P.)</u>

This is case of Basalt Stone mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-37/1, Vill. -Dhamanda, Teh.-Dewas, District-Dewas (M.P.) 3.740 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 522 dated: 08/04/15 has reported that there is 01 more mine operating or proposed within 500 meters around the said mine with total area of 7.740 ha including this mine.

Today, Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Earlier case was discussed in the 215th SEAC meeting dated 21/08/2015 wherein due to shortcomings case was returned to SEIAA. Since PP has submitted the desired information, the case was relisted and sent to SEAC for appraisal vide SEIAA letter no. 1476/SEIAA/16 dated 13/05/2016.

Committee decided that since the area of this mine is < 5.00 ha and as per MO certificate the cluster area is of 7.740 ha including this mine with no individual mining lease area is > 5.00 ha, this case may be transferred to DEIAA.

4. Case No. – 3025/15 Smt. Asha Paatwala W/o Shri Sunil Paatwala, 91, Sukh Niwas, Indore (M.P.)-455001 Basalt Stone Quarry Lease Area - 4.00 Ha., Capacity - 55,000 cum/year, at Khasra No.-37/1, Vill.-Dhamanda, Teh.-Dewas, District-Dewas (M.P.)

This is case of Basalt Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is at Khasra No.-37/1, Vill.-Dhamanda, Teh.-Dewas, District-Dewas (M.P.) 4.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.523, dated: 08/04/15 has reported that there is 01 more mine operating or proposed within 500 meters around the said mine with total area of 7.740ha including this mine.

Today, Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Earlier case was discussed in the 215th SEAC meeting

dated 21/08/2015 wherein due to shortcomings case was returned to SEIAA. Since PP has submitted the desired information, the case was relisted and sent to SEAC for appraisal vide SEIAA letter no. 1474/SEIAA/16 dated 13/05/2016.

Committee decided that since the area of this mine is < 5.00 ha and as per MO certificate the cluster area is of 7.740 ha including this mine with no individual mining lease area is > 5.00 ha, this case may be transferred to DEIAA.

5. <u>Case No. 3523/15 Shri Sumit Khandooja S/o Shri Kuldeep Khanooja, Near State Bank of India, P.O. & District-Dindori (MP)-481880 Prior Environment Clearance for approval of Stone Quarry in an area of 0.870 ha. (10,000 cum/year) at Khasra No.-90, Vill.-Jamunia, Teh.-Dindori, District-Dindori (MP)</u>

This is case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is at Khasra No.-90, Vill.-Jamunia, Teh.-Dindori, District-Dindori (MP) 0.870 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.559, dated: 26/08/15 has reported that there is no more mine operating or proposed within 500 meters around the said mine.

The case was earlier discussed in the 227th SEAC meeting dated 19/09/2015 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :Aø

1. Production of Stone not exceeding 10,000 m3/Year as per mine plan with depth restriction of 12 meters.

SEIAA vide letter no. 1496/SEIAA/16 dated 16/05/2016 sent back the file to SEAC for reappraisal as co-ordinates issued by DFO does not matches with the co-ordinates provided by the PP.

Today, Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to give last chance to PP in subsequent meetings and even it the PP remains absent, the case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project.

6. Case No. 4188/15 Shri Naresh Jayswani S/o Shri Ramgopal Jayswani R/o Bangla Line, Madhav Nagar, District-Katni (MP)-483501 Prior Environment Clearance for approval of Flag Stone Quarry in an area of 2.00 ha. (expansion in production capacity from 450 to 12,000 cum/year)(Flag Stone-4800, Murrum-3600, & Boulder Stone-3000) Khasra No.- 858, at Village-Simra, Tehsil-Rithi, District-Katni (MP)

This is case of **Sand Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 167 at Village ó Choupra, Teshil ó Pawai, Distt. Panna (M.P.) 1.50 ha Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1720 dated: 26/8/15 has reported that there is no more mines operating or proposed within 500 meters around the said mine.

The case was earlier discussed in the 254th SEAC meeting dated 19/12/2015 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :Aøx

• Production of **Flag Stone** as per mine plan with quantity not exceeding 4,000 cum/year.

SEIAA vide letter no.10874/SEIAA/16 dated 01/02/2016 sent back the file to SEAC for reappraisal as "in the body of the minutes this case has been described as flagstone, Murum and Bolder Stone. Case may be retured to SEAC for clarification and also further appraisal as to how bolder stone and flag stone will be excavated from the mineas methodology of extraction is different for these two categories".

The case was presented by the PP and their consultant wherein PP informed regarding the methodology of excavation of these minerals and submitted necessary documents for consideration. After detailed deliberations and discussions, committee observed that as per the Form-1 and approved mine plan PP has applied for the Flagstone, Bolder and Murum. It was also observed from the õmethodology and production bench heightö submitted by PP in presentation that there is 20 mm ranging from 10mm to 30mm thicknes of chips and chachhri, again at the depth of approx. 3.5 meters, there is 1.00 meter thick chips & chachri dust which is marketable as building material in place of Murum. This will minimize the soild waste disposal at the lowest and also State Govt. will earn revenue agaist reuse of waste otherwise this will be stacked as waste material. These two layers will be minable manually with chisel and hammer. The remaining two layers of 3.0 meter and 1.5 meter of flag stone & bolder stone will be minable as per mine plan. PP has also informed during presentation that he has given marketable name as õMurumö to waste as õchips & chachriö. Committee decided that the above clarification may be sent to SEIAA.

7. Case No.4640/15 Shri Neeraj Garg, M/s Ma Vaishno Granite R/o 102, Vinjay Nagar, Sector-1, District-Gwalior (MP)-474003. Prior Environment Clearance for Metal Stone Quarry in an area of 4.90 ha. (60,000 cum/year) at Khasra No.-626, 629, 630, 631, Village-Tatarpur, Tehsil-Bhander, District-Datia (MP) (TOR)

This is case of Metal Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is at Khasra No.-626, 629, 630, 631, Village-Tatarpur, Tehsil-Bhander, District-Datia (MP) 4.90 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.380, dated: 13/11/14 has reported that there are 11 more mines operating or proposed within 500 meters around the said mine with total area of 30.240 ha including this mine.

Today, Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. The case was earlier also scheduled for presentation in the 12th SEAC II meeting dated 10/03/2016 but PP remain absent. Committee decided to give last chance to the PP in subsequent meetings and even it the PP remains absent, the case shall be

returned to SEIAA for delisting assuming that PP is not interested to continue with the project.

8. Case No.4874/15 Shri Rajendra Singh Bais, Village-Mangrol, Tehsil-Ujjain, District-Ujjain (MP)-456010 Prior Environment Clearance for Stone Quarry in an area of 1.00 ha. (14,300 cum/year) at Khasra No.- 298(Part), Village-Jalalkhedi, Tehsil-Ujjain, District-Ujjain (MP)

This is case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is at Khasra No. - 298(Part), Village-Jalalkhedi, Tehsil-Ujjain, District-Ujjain (MP) 1.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-1690, dated: -18/06/15, has reported that there are 13 more mines operating or proposed within 500 meters around the said mine with total area of 32.06 ha including this mine.

Today, Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. The case was earlier also scheduled for presentation in the 18th SEAC II meeting dated 13/04/2016 but PP remain absent. Committee decided to give last chance to the PP in subsequent meetings and even it the PP remains absent, the case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project.

9. <u>Case No. 950/12 Shri Pramod Kumar Patel, C/o Smt. Tara Patel Baba Tal Sehora Road,</u>
<u>Jabalpur Distt. - Jabalpur (M.P.)-457887. Prior Environment Clearance for approval of Metal Stone Quarry with Crusher at Khasra No. - 362, 363 & 432 Village - Dadar Sihudi, Tehsil - Dheemarkheda, Distt. - Katni (M.P.) Lease Area 1.20 Ha. Capacity - 5,000 Cubic Meter/Year. (Case for Expansion 5000 to 8550 Cubic Meter/Year)</u>

This is case of Metal Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is Khasra No. ó 362, 363 & 432 Village ó Dadar Sihudi, Tehsil ó Dheemarkheda, Distt. ó Katni (M.P.) 1.20 ha. The project requires prior EC before commencement of any activity at site.

The case was presented before the committee in the meeting dated 17/12/2012 whereby it was submitted by the PP that the mining is proposed in self owned land which is barren. The lease period has been planned for 2 years and crusher shall not be installed in the MLA, hence the proposed project may be considered as category B-2. PP has submitted a copy of information in prescribed format-1 and Env. Management Scheme and requested for appraisal of the project as cat. B-2. Committee has asked the PP to submit an affidavit stating the requisite lease period and the location of proposed crusher.

Case was presented in the 115th SEAC meeting dated 05/01/2013 wherein the Project proponent has submitted an affidavit stating that the opted lease period shall be for 2 years and that crusher shall not be placed in the MLA. Based on the information provided by the PP, committee appraised project under B-2 category. Accordingly, committee recommended the case for grant of prior EC subject to the following conditions:

- 1. PP shall be responsible for any discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- 2. Transportation of material shall be done in covered vehicles.
- 3. Curtaining of site shall be done using appropriate media.
- 4. Wet drilling method shall be adopted.
- 5. Crusher or any other sizing device shall not be allowed in the mining lease area.
- 6. The pits formed after the mining shall be appropriately developed into water body which should properly fenced and safe for easy access for the local residents.
- 7. The proposed plantation should be carried out along with the mining and PP should take care that these plants attain full growth.
- 8. The validity of the prior EC & the lease shall be for a maximum period of one year only.
- 9. Transportation shall not be carried out through forest area.
- 10.PP shall take CSR activities in the region through the :Gram Panchayatø
- 11. The amount towards EMP shall be deposited with the Collector for further execution of the activities under EMP.

The above case is referred back by SEIAA vides letter no. 7562 dated 10/11/2015 stating that after detailed discussion and perusal of the query response of 188 SEIAA meeting dated 05/2/2013, PP had been issued EC for two years ending 14/01/2015. Now he has requested for extension of EC for 10 years on the lease renewal from 15/10/11 to 14/10/21 which was placed before the committee.

The case was again discussed in the 268th SEAC meeting dated 16/01/2016 wherein the committee after discussion decided that if the mining lease area and production remains the same and if the lease has been renewed, the EC may be extended as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.

SEIAA vides letter no. 1113/SEIAA/16 dated 30/04/2016 again sent back the file to SEAC for re-appraisal stating that "the approved mining plan submitted by the PP was for a period of 02 years ending 2915. On perusal of the approved mining plan, the production capacity indicated is 8550 cum/year, whereas earlier the EC was issued for a capacity of 5000 cum/year".

The case was scheduled for the presentation toaday but PP remains absent. However, the committee on perusal of documents observed that initially on 14/09/2012, the applicant has applied for the production capacity of 5000 cum/year in form-1 and with other necessary documents required at that time. The EC was issued to the PP on dated 15/02/2013 for two years. PP again applied for EC on dated 02/03/2015 through simple application (without Form-1) for the production capacity of 5000 cum/year and enclosing approved mine plan of 8550 cum/year which was approved by the competent authority on dated 05/10/2013 with other documents. SEIAA vides letter no. 7562/SEIAA/15 dated 10/11/0215 forwarded the file to SEAC considering the application as extention of EC upto 14/10/2021. Since the production capacity remains the same in form-1 and fresh application submitted by PP 02/03/2015, the case was not considered as expansion. Thus committee after deliberations decided to stands by its earlier recommendations made in the 268th SEAC meeting dated 16/01/2016 and status quo should be maintained.

10. Case No. – 2645/15 Shri Niresh Jain S/o Shri C.M. Jain, House No. E-3/217, Arera Colony, Bhopal (M.P.)-462016 of Basalt Stone Quarry Lease Area - 8.00 ha., Capacity - 62,400 cum/year, at Khasra no.-71/1, Vill.-Maholi, Teh.-Bairsiya, District-Bhopal (MP)

This is case of Basalt Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is at Khasra no.-71/1, Vill.-Maholi, Teh.-Bairsiya, District-Bhopal (MP) 8.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.---,

dated: ---, has reported that there -- more mine operating or proposed within 500 meters around the said mine.(M.O certificate not enclosed)

Today, Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. On perusal of the documents committee observed that the application submitted by the PP is incomplete for which SEIAA vides letter no. 3454/SEIAA/15 dated 30/03/15 has instructed to submit the desired documents but PP has not submitted the same. SEAC also vide letter no. 215 dated 18/05/2015 has instructed PP to submit the lacking details but PP except the mine plan has not submitted other necessary documents (such as DFO, Tehsildar & MO certificat) which are essential for the appraisal of the peoject. Committee decided that since sufficient opportunites have been given to the PP for appraisal and consideration of the project wherein PP remain absent and have also not submitted the essential documents, the case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project as per MoEF&CC OM No. J-11013/5/2009-IA-II (Part) dated 30/10/2012.

11. Case No. 3551/15 Shri Shiv Kumar Singh R/o House No. C-3/22, Sindsor Hill, Siroi Road, District-Gwalior (MP)-474011 Prior Environment Clearance for approval of Stone Quarry in an area of 1.00 ha. (26,325 cum/year) at Khasra No.-1351, Vill.-Kharag, Teh.-Datia, District-Datia (MP) (TOR)

This is case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-1351, Vill.-Kharag, Teh.-Datia, District-Datia (MP) 1.00 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no. 376 dated: 16/07/2015 has reported that there are 10 more mines operating or proposed within 500 meters around the said mine with total area of 27.22 ha including this mine.

The case was presented by the PP and their consultant wherein it was informed to the PP that being a case of cluster where area is > 25.00 ha, TOR will be issued for carrying out EIA considering the certificate of Mining Officer wherein it is reported that there are 10 more mines operating or proposed within 500 meters around the said mine with total area of 27.22

ha including this mine issued vide letter no. 376 dated: 16/07/2015. However, PP contested that some mine which are listed in the MO certificate are actually cancelled. The committee after deliberations asked PP to get the revised Mining Officer certificate within 15 days for further consideration of the project. If PP fails to submit the certificate within 15 days case may be sent back to SEIAA assuming that PP is not interested to continue with the project as in earlier SEAC meeting no. 234 and 260 PP was absent.

12. Case No. 1665/13 M/s Vidhi Alias Pvt. Ltd., Bhiktiyog Apartment, Nargundkar, Layout Khamala Road, Nagpur (MH). Environment Clearance of Mangnese Ore for approval of 6.229 Ha for Production Capacity 5000 MTPA at Khasra no.-982, 984/2, 985, Vill.-Katangjhari, Teh.- Lalbarra, Dist.-Balaghat (M.P.) (EIA)

This is case of Mangnese Ore. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra no.-982, 984/2, 985, Vill.-Katangjhari, Teh. - Lalbarra, Dist.-Balaghat (M.P.) 6.229 ha. The project requires prior EC before commencement of any activity at site.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings after hearing from PP. A request has to be made by the PP for scheduling the case in coming meetings within a monthose time after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

13. Case No. 2244/14 Shri Bharat Singh Raghuvanshi S/o Shri Bheru Singh Raghuvanshi, Vill.-Bardari, Th.- & District-Dhar (M.P.)-454001. Prior Environment Clearance for approval of proposed Khandwa Basalt Stone & Murram Quarry in an area of 3.20 ha.for Production Capacity of Basalt- 39140 cum/year & Murram -4605 cum/year at Khasra no.-1 & Part of 414, Vill.-Khandwa, Th.-Dhar, District-Dhar (M.P.)

This is case of Khandwa Basalt Stone & Murram Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra no.-1 & Part of 414, Vill.-Khandwa, Th.-Dhar, District-Dhar (M.P.) 3.20 ha. The project requires prior EC before commencement of any activity at site.

However, during scrutiny of the file committee observed that SEIAA vides letter no. 1602/SEIAA/16 dated 24/05/16 forwarded a letter from the PP requesting that their case may be transferred to DEIAA as their lease is <5.00 ha. - If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.

- The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- No diversion of active channel should be allowed for mining.

26. <u>Case No.4881/15 Shri Tikam Singh Panwar R/o Village-Kanthariya, Tehsil-Mahidpur, District-Ujjain (MP)-456443. Prior Environment Clearance for approval of Sand Quarry in an area of 13.48 ha. (4,044 cum/year) at Khasra No.-01, Village-Aranyabena, Tehsil-Mahidpur, District-Ujjain (MP) abs 22nd meeting</u>

This is case of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site, at Khasra No.-01, Village-Aranyabena, Tehsil-Mahidpur, District-Ujjain (MP) 13.48 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.2780, dated: -30/10/15, has reported that there is no more mine operating or proposed within 1000 meters around the said mine.

SEIAA vide letter no. 1087/SEIAA/16 dated 28/04/2016 forwarded that replanishemnt plan submitted by the PP.

The case was presented by the PP and their consultant in the 27th SEAC II meeting dated 25/05/2016 wherein it was also observed by the committee that as per the Google image of November, 2015 based on the co-ordinates provided by the PP that most part of the lease area is submerged in the water. PP submitted that there is enough sand available and QL area is not submerged in the water during summer season and as a proof they can produce the recent photographs of the site. The committee after deliberation decided that PP should submit the recent photographs of the QL duly signed by both of them for further consideration of this project within 07 days.

PP vide letter dated 03/06/2016 has submitted the recent photographs of the site which were placed before the committee. Committee after deliberations decided that as per the photographs submitted submitted by PP sand is available in certain patches and since the demanded quantity in only 4,044 cum/year case can be considered for EC. Thus the

committee decided to <u>recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :Bø</u>

- Production of Sand as per mine plan with quantity not exceeding 4,044 cum/year.
- District Authority should record the deposition of sand in the lease area at an interval of 100 meters annually in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.
- Evacuation of sand should not be allowed through the roads passing through the villages.
- Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads.
- If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.
- The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- No diversion of active channel should be allowed for mining.

DUISCUSSION ON QUERY RESPONSE SUBMITTED BY PP

- 27. There are certain case (List attached as Annexure-1) where some infornmations were saught from the PP or TOR were issued but even after the sufficient time given to these PPøs neither they have not submitted the desired informations nor has applied for the extention in TORøs validity period which was placed before the committee. The committee after deliberation decided that these cases (List attached as Annexure-1) may be recommended for delisting to SEIAA.

Stone Quarry in an area of 1.435 ha. (20,000 cum/year) at Khasra No.-3579/7, 3577, Vill.-Billaua, Tehsil-Dabra, District-Gwalior (MP)

This is case of **Stone Quarry**. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-3579/7, 3577, Vill.-Billaua, Tehsil-Dabra, District-Gwalior (MP) 1.435 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.-Q-L-50/2015, dated: 21/08/2015 has reported that there are no more mines operating or proposed within 500 meters around the said mine.

The case was earlier discussed in the 249th SEAC meeting dated 14/12/2015 wherein the EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure :Aøx

- Production of **Stone** as per mine plan with quantity not exceeding 20,000 cum/year.
- Mining is restricted to the southern part of the ML area and considering the shape of mining, the depth is also restricted to 12 meters.

SEIAA vide letter no. 10827 dated 29/01/2016 sent the file back to SEAC stating that this case pertains to village Billaua and therefore should have been part of Billaua cluster for which Honøble NGT has also directed to form a committee for a site visit and thereafter its site report. SEIAA has decided to return the case to SEAC for appraisal as per the directives of Honøble NGT.

The above cases were placed before the committee in the 17th SEAC II meeting dated 06/04/2016 wherein it was observed by the committee that in all the above cases mining officer has certified the leases within 500 meters radius around the site and on the basis of MO certificate the EC was recommended by the SEAC. Committee after deliberations decided to carryout site visit of all the above cases by a sub-committee to ascertain whether above cases are part of Biloua cluster or not.

Accordingly a two member sub committee comprising of Shri. Prashant Shrivastava and Dr. Mohd. Akram Khan visited the site on 22.05.2016 wherein it is recorded that mine registered with case no. Case No.-3876/15 of Shri Sushil Kumar Jain S/o Shri B.K. Jain, M/s Stuti Stone Crushing Co. R/o J-82, Kalka Jee, Delhi-474001 Prior Environment Clearance for approval of Stone Quarry Lease Area - 1.435 ha., Capacity - 20,000 cum/year, at Khasra No.-3579/7, 3577, Vill.-Billaua, Tehsil-Dabra, District-Gwalior (MP) is located > 500 meters away from the above mines with can be verified from the letter issued by concerned mining Officer (letter no.-Q-L-50/2015, dated: 21/08/2015) wherein it has been reported that there are no more mines operating or proposed within 500 meters around the said mine. This site is a single lease of 1.435 ha with no other mine within 500 meters located in the northwestern side of the billaua cluster. Two crushers are located on the western side of this lease and both were non-operational at the time of inspection. The wind direction at the time of inspection was from North to Southeastern direction. No demarcation/mine boundary pillars were available on site to verify the exact distances of this lease from the other sensitive environmental factors and billaua cluster. The mining officer and PP present during inspection also could not establish the exact mine boundary of this lease and their respective distances from the billaua cluster and other sensitive environmental factors. Thus subcommittee asked the concerned mine owner and officers from mining department to prepare a surface map of all the lease with the help of Tehsildar/Patwari/Mining Officer mentioning their exact distances from billaua cluster, nearby industry, billaua village, Main road etc and this map should be duly verified by the Tehsildar/Patwari/Mining Officer for further considerations. The repor of the committee was placed in the 28th SEACII meeting dated 02/06/2016.

PP vide letter dated 25/05/2016 has submitted the desired information which was placed before the committee. Committee observed that PP has submitted surface map which is duly verified by the Tehsildar stating the distances of this lease which are as follows:

Distance from mine to the road
 Distance from mine to the billaua village
 Distance from mine to Billaua cluster
 Distance from mine to steal plant
 Distance from mine to School
 310 meter.
 789 meter.
 830 meter.
 648 meter.

The committee after deliberations decided that since this mine is >700 meters away from the billaua cluster and it single mine, the committee stands by its earlier recommendations made in the 249^{th} SEAC meeting dated 14/12/2015.

Following standard conditions shall be applicable for the mining projects of minor mineral in addition to the specific conditions:

Annexure- 'A'

Standard conditions applicable to Stone/Murrum and Soil quarries:

- 1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
- 3. Transportation of material shall be done in covered vehicles.
- 4. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
- 5. Curtaining of site shall be done using appropriate media.
- 6. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement.
- 7. Transportation shall not be carried out through forest area.
- 8. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 9. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 10. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded and in extream summer season hourly road wetting be done.
- 11. PP should also maintain a log book containing annual details of tree plantation and causality replacement.
- 12. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product mix in proposed mining unit shall require a fresh Environment Clearance.

Annexure- 'B'

Standard conditions applicable for the sand Mine Quarries*

- 1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- 3. Plantation shall be carried out on the banks for stabilization of the banks above high flood level and a log book be maintained.
- 4. The mining activity shall be done manually.
- 5. Heavy vehicles shall not be allowed on the banks for loading of sand. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded and in extream summer season hourly road wetting be done.
- 6. The sand shall be transported by small trolleys up to the main transport vehicle.
- 7. Transport vehicles will be covered with taurpoline to minimize dust/sand particle emissions.
- 8. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
- 9. No Mining shall be carried out during Monsoon season.
- 10. The depth of mining shall be restricted to 3m or water level, whichever is less.
- 11. No in-stream mining shall be allowed.
- 12. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
- 13. Established water conveyance channels should not be relocated, straightened, or modified.
- 14. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
- 15. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
- 16. PP shall take Socio-economic activities in the region through the 'Gram Panchayat'.
- 17. EC will be valid for mine lease period subject to a ceiling of 5 years.
