

1. **Case No., 2260/2014**, Prior Environmental Clearance for **Marble Quarry** in an area of 2.60 ha for production capacity of 7,200 Cu.mt./Year, at Khasra No. 707 at Village-Tokariya Jhiran, Tehsil-Jobat, District-Alirajpur (MP) by Shri Milan Kumar Maheshwari, 279, Mahatma Gandhi Marg, Alirajpur (MP)-457887.


- (1) After detailed discussions and perusal of the recommendations of 175th SEAC meeting dtd. 25.02.2015, it was noted that the PP has applied for marble deposit (quarry) in Form - 1. It is mentioned in the mining plan that the mineral which are occurring in the area is marble (Khanda) for which applicant intends to mine.



- (2) In this context it was decided to ask from the Mining Officer, Alirajpur to provide the actual information regarding the mineral for which PP intends to mining from the lease area. **The information should be made available at the earliest. Copy of the letter should be endorsed to the PP also.**
2. **Case No. 1990/2014** Prior Environmental Clearance for **Jalakhedi Stone Quarry** in an area of 4.0 ha. for production capacity 30,000 cum/year at Khasra No. 192 at **Village-Jalakhedi, Tehsil-Ujjain, District-Ujjain (MP)** by Smt. Jaya W/o Late Mr. Prasant Yadav, 180, Abdalpura, Ujjain, Teh-Ujjain, Dist-Ujjain (MP)-456001
- (1) After detailed discussions and perusal of the recommendations of 175th SEAC meeting dtd. 25.02.2015, it was noted through Google Map view (as per coordinates submitted by PP) that the proposed mining site is not very clearly visible. In this context, it was decided to ask from the Mining Officer to provide Coordinates (Latitudes & Longitudes) of all four corners / pillars of the mining site. **Copy of the letter should be endorsed to PP also.**
3. **Case No. 1864/2014** Prior Environmental Clearance for **Stone Quarry** in an area of 2.00 ha for production capacity of 25,000 Cu.mt./Year, at Khasra No. 343, 345, 346 & 347 at Village Morghadi, Tehsil Punasa, Distt. Khandwa (MP) by Smt. Dipti Patel W/o Shri Nilesh Patel, 84, Luv Kush Nagar, Sector No. 2, District -Khandwa (MP)-450001.
- (1) After detailed discussions and perusal of the recommendations of 176th SEAC meeting dtd 26.2.2015, it was noted that the existing operating status of mine is not clear whether it is operating or not. If it is operating then the yearwise production of mineral for last three years.
- (2) It was also noted that the lease period of mine is 10 years from 06.02.2006 (vide endt no. 2062 dtd 06.02.2006 of Assistant Mining Officer, East Nimar, Distt. - Khandwa) but it is not clear that mining is new or applied for renewal.
- In the above context, it was decided to ask from the Mining Officer to provide the existing operating status of mine and its production capacity for the last three years and the status of renewal of mining lease. Copy of the letter should be endorsed to PP also.**
4. **Case No. 2071/2014** - Prior Environmental Clearance for **Malikhedi Stone Quarry** in an area of 1.33 ha. for production capacity 5000 cum/year at Khasra No. 54, 59 at **Village-Malikhedi, Tehsil-Nagda, District-Ujjain (MP)** by Smt. Sita Bai W/o Shri Ranchodlal, Vill-Bedawan, Teh-Nagda, Dist-Ujjain (M.P)-456224.
- (1) After detailed discussions and perusal of the recommendations of 176th SEAC meeting dtd. 26.02.2015, it was found from record that PP has not provided information about the distance of nearest Forest Boundary from the mining site. **In this context, it was decided to ask from PP to provide this information duly certified by DFO, Dist-Ujjain. Copy of the letter should be endorsed to DFO, Ujjain also.**
5. **Case No., 1960/2014**, Prior Environmental Clearance for **Basalt Stone & Murram Quarry** in an area of 3.66 ha for production capacity of Basalt – 1,50,000 Cu.mt./Year & Murram- 22466 Cu.mt./Year **(as per SEAC recommendation)** at Khasra No. 123/5 at Village-Rewati, Tehsil-Hatod, District-Indore (MP) by M/s Umbra Mining Pvt. Ltd., 23-A, Royal Residency, Pipalyahana, Indore (MP) -452006.
- (1) After detailed discussions and perusal of the recommendations of 176th SEAC meeting dtd. 26.2.2015, from the google map it was observed that the

area falls near the State Highway and therefore many colonies are planned near the proposed mining site. It is now decided to accept the recommendation of SEAC for a reduced production capacity of Stone 1,50,000 cum/year & Murrum 22,466 cum/year and grant EC for a period of two years i.e. upto 19.04.2017. PP will have to apply for a review by SEIAA before 60 days from the expiry of the EC period. In case of expansion in the planning area of Indore town, if this area is also included, then the EC granted to the PP for the mining site will be deemed to be terminated and the PP can apply for a review. Hence the EC is granted with slight modification :-

- i. PP shall not start mining activity before execution of lease agreement.
- ii. The average depth of the pit shall not exceed 6.0 m. upto 19.04.2017.
- iii. The location of the crusher should be so fixed that it doesn't create air & noise pollution for the habitations nearby.


Hence, Prior Environmental Clearance is granted for **Basalt Stone & Murrum Quarry** in an area of 3.66 ha for production capacity of Basalt – 1,50,000 Cu.mt./Year & Murram- 22466 Cu.mt./Year (**as per SEAC recommendation**) at Khasra No. 123/5 at Village-Rewati, Tehsil-Hatod, District-Indore (M.P) **for the two year i.e. upto 19.04.2017** to M/s Umbra Mining Pvt. Ltd., 23-A, Royal Residency, Pipalyahana, Indore (MP) -452006.


6. **Case No. 1765/2014** Prior Environmental Clearance proposed project Central Academy for Police Training of Bureau of Police Research and Development Ministry of Home Affairs, Government of India at Khasra No. 197, 198, 204, 261, Village Kanhasaiya, Tehsil Huzur, Distt. Bhopal (MP) Total Land Area 106.15 ha., Proposed Built Up Area 59383.84 sqm by Shri Kanhiya Lal, Executive Engineer, Central Academy of Police Training CAPT Project Division, CPWD, Kanhasaiya, Tehsil Huzur, Distt. Bhopal (MP). Env. Consultant: Creative Enviro Services, Bhopal (M.P.)


- (1) The case was discussed in 194th SEIAA meeting dtd 17.04.2015 and it is recorded that " (1)...The proposed project is building & construction of project Central Academy for Police Training of Bureau of Police Research and Development Ministry of Home Affairs, Government of India at Khasra No. 197, 198, 204, 261, Village Kanhasaiya, Tehsil Huzur, Distt. Bhopal (M.P.) The project includes Construction of Residential building, Administrative & academic building, Amenities and hostel buildings.
- (2) As per the T & CP Bhopal - Sehore (vide letter no. 2327 dtd. 14.11.14, the total land area is 106.15 ha. The total built up area proposed by PP is 59383.84 sqm by virtue of the size of plot area (more than 50 hectares) the project comes under 8(b) category (B) of schedule of EIA Notification, 2006.
- (3) The case was discussed in SEAC meetings 176th dtd. 26.02.15 and is recommended for grant of prior EC subject to 13 special conditions.
- (4) **The Authority decided that PP should be called for presentation on 20.04.2015."**

- (2) The case was discussed in depth and it is noted that :-

- (i) This is a Central Sector scheme of Ministry of Home Affairs funded from Government of India. The state government of Madhya Pradesh has provided about 401 acres land spread in three Plots-A, B & C of approximately area 118, 267 & 16 acres respectively near village Kanhasaiya, Tehsil Huzoor, Distt. Bhopal for setting up the Central Academy. The main academy is proposed in Plot- B comprising of



Khasra nos 204, 197, 198, 199 and 261 having an area of 106.15 hectares.

- (ii) Govt of Madhya Pradesh revenue Deptt. has allocated total land of 160.44 ha (401 acre) vide letter dtd.27.06.09 at village Kanhasaiya. An agreement (dtd. 30.07.09) for 160.44 ha (401 acre) has been executed between Hon'ble Governor GoMP through Collector Bhopal (first Party & Director training BPR & D, Ministry of Home, New Delhi through Shri Sanjay Beniwal IPS/DIG/Deputy Director (Development) BPR & D New Delhi. Out of this PP has applied for 106.15 ha for the proposed project. As per Khasra Panchsala (2013-14) the Khasra no. 197 is in the name of Central Academy for Police Training institute & V.I.P Surksha traffic training Centre New Delhi While Khasra no. 198,204 & 261 are the name of Central Academy for Police Training institute.
- (iii) It is noted that Ghoda-pachhar river ~~is~~ passes from distance of 0.010 km in the east of the site. Ghoda-Pachhar Reservoir is located 1.75 km south. The total water requirement is 203.74 KLD. The fresh water requirement is 111.74 KLD. The source of water supply is Ghoda-Pachhar Reservoir. PP has submitted letter from Water Resource Deptt. dtd. 17.07.13 regarding water supply. **It is decided that PP should ensure that the entire water demand is met through Water Resource Department and there is no extraction of ground water.**
- (iv) The total waste water generation is 127.74 KLD. PP has provided sewage treatment plant of 150 KLD. The total treated waste water is 121.35 KLD. PP has proposed to recycle the entire quantity of waste water for flushing, horticulture etc. PP has provided detention pond to supplement the horticulture need. **It is decided that PP should ensure zero discharge of treated waste water. PP should ensure linkage with municipal sewer line in case of discharge of extra treated waste water (if any).**
- (v) Approximately 607 kg per day of Municipal Solid waste generated is proposed to be segregated at source. **It is decided that PP should provide compactors for MSW and ensure linkage with Bhopal Municipal Corporation Bhopal for final disposal of MSW.**
Hazardous waste from campus will consist of waste oil from DG sets, resin from Water Treatment Plant. PP has proposed that the entire volume of the hazardous waste shall be disposed off at TSDF, Pithampur. **It is decided that PP should obtain authorization from MPPCB regarding Hazardous waste management.**
- (vi) As per T & CP approval the maximum height of the building is 18 m. PP has proposed 12.0 m. PP has provided road width 24 m; Front MOS 12 m and side / rear MOS 6.0 m. **It is decided that PP should ensure road width and open spaces as per MP Bhumi Vikas Niyam 2012.**
- (vii) Regarding fire fighting PP has proposed to provide Static tank (underground) and overhead tank, Landing valves with hose reels, External hydrant all around the building & yard, automatic sprinkler system, Pumping arrangement system- riser system with pressure

pump, auto operation with pressure switch etc. as per NBC 2005. It is decided that PP should ensure fire fighting provision as per National Building Code (2005) and MPBVR, 2012 and ensure that all the fire fighting measures are physically in place.

- (viii) PP has proposed rooftop rain water harvesting through 20 nos. of recharging pits for artificial recharge of ground water. It is decided that PP should ensure rain water harvesting.
- (ix) The total power requirement is 5200 KW. PP has also proposed power back up 2 DG Sets 750 KVA each and Solar lighting panel 20 KW for street lighting. The source of power supply is MP Electricity Board. It is decided that PP should ensure installation of photovoltaic cells (solar panels) for lighting in common areas, LED light fixtures and energy efficient equipments.
- (x) As per MPBVR 2012 (rule no. 84) the requirement of car parking is 537 ECS as follows:-

It is decided that PP should ensure car parking as per Rule no. 84 (1) Table Clause 1 (3) of MPBVR 2012.

- (xi) Out of the total project area (106.15 ha) an area of 12.10 ha is proposed to be developed as green area. The authority decided that PP should ensure maximum plantation all along the periphery of the project area, parks, playground and avenue plantation along the roads. PP should ensure plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Kachnaar etc. Every effort should be made to protect the existing trees on the plot.
- (3) The Authority decided to accept the recommendations of 176th SEAC mtg. dtd. 26.02.15 with 13 special conditions and accord Environmental Clearance to proposed project Central Academy for Police Training of Bureau of Police Research and Development, Ministry of Home Affairs, Government of India at Khasra No. 197, 198, 204, 261, Village Kanhasaiya, Tehsil Huzur, Distt. Bhopal (MP) Total Land Area 106.15 ha., Proposed Built Up Area 59383.84 sqm by Shri Kanhiya Lal, Executive Engineer, Central Academy of Police


- (1) SEAC in its 169th meeting dtd. 27.01.15 has recommended the case for delisting.
