- The total waste water generation is 323 KLD. PP has provided sewage treatment plant of 330 KLD. The total treated waste water is 297 KLD. Out of this 190 KLD will be recycled (120 KLD flushing + 70 KLD Horticulture & miscellaneous use) and extra treated waste water 107 KLD is proposed to be disposed off to sewer line. PP has not submitted NOC from GMC regarding disposal of extra treated waste water in Municipal sewer line. It is decided that :
 - a. PP should submit details of final discharge point and mode of disposal of extra treated waste water and submit clear NOC from Municipal Corporation, Gwalior.
