#### C. Policy Decision

MoEF & CC, GoI has endorsed a copy of the letter (vide no. J-11015/93/2014-IA.II (M) dtd 12.03.2015) addressed to M/s Billaua Stone Crusher Association in which they have categorically stated that the Association should apply to MP-SEIAA as individual LoI/ lease holders. MP-SEIAA in response to the directive of MoEF & CC, GoI had sought (vide no. 1359/SEIAA/15 dtd 26.05.2015) clarification from them on the cluster situation arising of 102 ha of proposed mining area. However, in its reply MoEF & CC, GoI (vide no. -11015/93/2014-IA.II (M) dtd 18.06.2015) has reiterated that individual lease holders may apply to MP-SEIAA for obtaining prior EC. MP-SEIAA has therefore decided to entertain online applications to be submitted by the individual lease holders in case of Billaua cluster situation.
