- (i). PP has submitted some additional receipts of fee deposited in Nagar Nigam, Indore. The Authority is of the view **that these receipts cannot be considered as NOC for water supply.** Reply of letter dtd 24.07.13, 03.10.13 & 15.10.14 from Commissioner Nagar Nigam Indore is still awaited. **It is decided that a DO letter should be written to Collector, Indore to look into the matter for providing clear permission for water supply specifying the quantity required by PP, NOC for discharge of extra treated waste water and NOC for disposal of MSW. A copy of this letter should be endorsed to Commissioner Nagar Nigam, Indore and PP.**
 - (ii). As per the MPBVR 2012 rule no. 84 Appendix I- I Table clause 1 (3) the car parking is to be provided @ 1 ECS per 100 sqm of built up area hence required car parking is 319 ECS. PP has proposed (vide letter dtd 31.07.14) to provide parking for 349 ECS and is **satisfactory.**
 - (iii). The maximum height of the building is 18 m (P + 6 Floors). As per minutes of 127th SEIAA meeting dtd 22.04.13 the conditions regarding road width is revisited and **it is decided that PP should provide road width 12.00 m and above, front MOS 7.50 m, and side/rear MOS 6.00 m as per MPBVR, 2012 Rule 42 (1) Table-4 S. No. 1 for building having height up to 18 m.**
 - (iv). PP has proposed green / open area of 9480.67 sq.m (46.58%). **It is decided that PP should submit detailed landscape plan with number of trees and species to be planted.**
- (3) **The above information should be submitted by PP latest by 28.02.2015."**
- (2) In response to above query, reply submitted by PP (vide letter dtd 02.06.15 received in SEIAA office on 02.06.15) was examined in depth and **it is decided that PP should be called for presentation."**
- (2) The case was presented by PP and it is noted that :-
- (i). The permissible FAR is 31942.50 sqmt. and proposed by PP in .ppt is 31891.36 sqmt., however as per calculations it was found to be much less (approximately 30990 sqmt.). **It is decided that PP should submit the clarification regarding built up area.**
 - (ii). During the presentation the project site was viewed on Google Earth. It was noted that construction work has started on the site. The consultant and PP also admitted that construction work has commenced at the site.
- (3) The Authority is of the view that it is undisputed that PP has already started construction work without obtaining prior EC under EIA Notification 2006, hence it is a case of violation. **It is decided that :-**
- (a). As per GoI, MoEF & CC office memorandum No. J-110131/41/2006-IA-II dtd 12.12.12 and 27.06.13 PP should submit the details of date of starting the construction work, total built up area that has been constructed, number of units sold, the present status of the construction activity whether it is still going on or stopped and why the construction activities have been undertaken without taking prior Environmental Clearance under EIA Notification, 2006? **PP should stop the construction activities with immediate effect and should not undertake any further construction/ development activity until Environmental Clearance is granted under EIA Notification 2006.**

submit the details of water balance and mode of final disposal of extra treated waste water until the Municipal sewer line is laid in the area.

- (v). It is noted that the distance of Hathaikheda reservoir is 700 m. A Nalla flows adjoining the project site and drains into the reservoir. **It is decided PP should submit the distance of project site from FTL of Nalla and Hathaikheda dam adjoining the site.**

- (xi). As per Rule no. 84 (1) Table Clause 1 (3) of MPBVR 2012 the required car parking is 38043.75 sqmt. $(FAR)/100=380$ ECS. PP has proposed to provide 192 ECS (still parking $5782.46/30 = 192$ ECS). **It is decided that PP should submit the details of car parking provisions for apartments, shops and duplexes as per MPBVR 2012.**
- (xii). Out of the total land area 32480 sq.m an area of 3240 sq.m. - (ii). The extra treated waste water 119 KLD is proposed to be disposed of finally into the nearby Nalla flowing approximately 7.0 m away from the site. This Nalla drains into Hathaikheda reservoir located approximately 700 m from the site. **It is decided that PP should conduct a study to assess the pollution load and carrying capacity of the Nalla flowing near the site and impact of discharge of sewage from the proposed project site on the water quality of Nalla and reservoir.**
- (iii). PP has provided 310 ECS parking for flats including total 8 Towers and 63 ECS for duplexes. **It is decided that PP should submit the revised car parking plan including the 9th tower (EWS) along with the details of area allocated for parking.**
- (iv). During presentation it was noted that PP has provided plantation in single row. **It is decided that as per the point no. 5 (xii) 187th SEIAA meeting dtd 17.03.2015 PP should provide two rows of plantation along the boundary in this rainy season and submit the photographs.**
