



1. **Case No 2686/2015** Application for Prior EC for proposed Construction of Residential Project "Signature City" at Khasra No. 163/1, 163/2, 163/3, 164/4, 165, 166, 167, 168, 169/1, 169/2, 172/2 at Bagli, and Khasra No. 326 Barrai, District-Bhopal, M.P. Total Project area – 80970 sq.m. Built up Area – 81238.36 sq. m. by M/s Signature Infrastructure through Mr. Rajesh Parchani (Authorized Signatory) 15-16, Comfort Enclave, E-8, Extension Babadiyakalan, Bhopal-462042(M.P.) E-mail rajeshparchani@gmail.com Mob No. 9826722608

- (1) The proposed project is building & construction Residential Project "Signature City" at Khasra No. 163/1, 163/2, 163/3, 164/4, 165, 166, 167, 168, 169/1, 169/2, 172/2 at Bagli, and Khasra No. 326 Barrai, District-Bhopal, M.P. The total built-up area of 81238.36 sq. m. hence the project comes under 8 (a) category (B) of schedule of EIA Notification, 2006.
- (2) Application for Prior Environmental Clearance was submitted by PP in SEIAA office on 04.04.15
- (3) The case was registered and forwarded to SEAC for appraisal on 08.04.15.
- (4) PP has submitted T & CP approval vide no. 775 dtd.04.05.2011 & building permission dtd.30.08.11 & revised on 10.05.14.
- (5) Along with the application Form PP submitted affidavit stating that construction activities have already been started at site. PP also submitted Resolution dtd 24.01.2015 regarding violation.
- (6) The case was discussed in 196th SEAC meeting dtd 02.06.2015 and recorded that *"It was reported by the PP and their consultant that construction activity at site has already been initiated. Thus the case is of violation. Committee decided to return the case to SEIAA with recommendation for credible action as per the provisions of the O.M. of MoEF & CC dated 12/12/2012. The case can only be considered after receipt of evidence of credible action against the duly forwarded by SEIAA"*.
- (7) Vide letter dtd 29.05.2015 PP has again submitted copy of resolution dtd 24.01.15. Approximately 40% of the construction has been done.
- (8) The Authority is of the view that it is undisputed that PP has already started construction work for the project "Signature City" at village Bagali & Barrai, District Bhopal without obtaining prior EC under EIA Notification 2006, hence it is a case of violation. **It is decided that :-**
 - (i). As per Gol, MoEF & CC office memorandum No. J-110131/41/2006-IA-II dtd 12.12.12 and 27.06.13 PP should submit the details of date of starting the construction work, breakup of the total built up area that has been constructed, number of units sold, the present status of the construction activity, whether it is still going on or stopped and why the construction activities have been undertaken without taking prior Environmental Clearance under EIA Notification, 2006? **PP should stop the construction activities with immediate effect and should not undertake any further construction/ development activity until Environmental Clearance is granted under EIA Notification 2006.**
 - (ii). A letter should be sent to Principal Secretary, GoMP, Housing and Environment giving the details of violation, to take action as per office memorandum of MoEF, Gol J-11013/41/2006 IA II (I)dt. 27.06.13 & 12.12.2012 (Para 2) *"to initiate credible action on the violation by invoking*

powers under section 19 of the Environment (Protection) Act, 1986 for taking necessary legal action under section 15 of the Act for the period for which the violation has taken place and evidence provided to MoEF of the credible action taken." The details of legal action taken by the Principal Secretary H & EN GoMP taken should be made available to the Authority by 30.08.2015. A copy of letter should be endorsed to MS, MPPCB.

- (iii). Details of project proponent, a copy of commitment and Resolution passed in the meeting of the Board of Directors of M/s Signature Infrastructure, Bhopal should be put on the website of MPSEIAA for information of all stake holders.




Recommendation of the visiting sub-committee: In view of the above facts, committee recommends rejection of the case.


