

1. **Case No. 2694/2015** Prior Environmental Clearance for proposed Residential Project "Affordable Housing Scheme" at Khasra no. 476 & 489 Village-Bairagarh Chichli, Tehsil-Huzur, District-Bhopal (MP). Land area - 66718 sq. m. Builtup-area - 50720 sq.m. by Mr. B.K. Agnihotri, Executive Engineer, M.P. Housing & Infrastructure Development Board, Div. 2, R.S.S. Market, 5 No. Stop, Bhopal-462011 (MP). - (1) The case was discussed in 246<sup>th</sup> SEIAA meeting dtd. 06.10.2015 and it was recorded that "After detailed discussion and perusal of the recommendation of 227<sup>th</sup> SEAC meeting dtd. 19.09.2015, PP should be invited for presentation."
- (2) After deliberations by PP the case was discussed in depth and it is noted that:
  - (i) The proposed project is building & construction residential township project under Affordable Housing Scheme of Atal AashryaYojna at Village-Bairagarh Chichli, Tehsil-Huzur, District-Bhopal (MP). The project includes construction of total 384 nos. EWS units (G+2) and 816 nos. LIG units (P+6).
  - (ii) As per the T & CP Bhopal (vide letter no. 1325 dtd 19.09.14). The total land area is 6.67 ha (66718 sq. m.) The total built up area proposed by PP is 50720 sq.m. The project comes under 8 (a) category (B) of schedule of EIA Notification, 2006 because total construction is between 20,000 sq.m. & 1,50,000 sq.m. and plot area is less than 50 ha.
  - (iii) The case was discussed in SEAC meetings 188<sup>th</sup> 02.05.2015, 223<sup>th</sup> 15.09.2015 & 227<sup>th</sup> dtd. 19.09.2015 and is recommended for grant of prior EC subject to 10 special conditions.
  - (iv) PP has submitted copy of allotment letter (vide letter no. 1560/RM BRANCH/TAHSIL/BHOPAL, dated 27/11/2014) as per the allotment order the land is allotted for Affordable Housing Scheme from Housing and Environment Department.
  - (v) The total water requirement is 862 KLD and fresh water requirement is 408 KLD. The total recycled water 454 KLD (used for landscaping-41 KLD, flushing-270 KLD and miscellaneous-143 KLD purpose). The source of water supply shall be from Municipal Corporation, Bhopal. In this regard, PP has submitted Bhopal Municipal Corporation letter dtd 10.06.2015. **It is decided that the entire demand of fresh water should be met from municipal supply and there should be no extraction of ground water.**
  - (vi) The total waste water generation is 699 KLD. PP has provided Sewage Treatment Plant of 840 KLD. The total treated waste water is 559 KLD, out of this 454 KLD proposed to be recycled and remaining 105 KLD + 41 KLD proposed to discharge in municipal sewer line /use for watering of municipal road side green area. PP has provided NOC dtd 19.10.2015 of Municipal Corporation, Bhopal for linking extra treated waste water in the sewer trunk which shall be laid in the near future. **PP shall create storage of 15 days of**



**extra treated waste water and has committed for the use of extra treated waste water in their construction activities.**

- (vii) Approximately 3660 kg /day Municipal Solid waste, horticulture waste 26.6 Kg/ day and street sweeping 665 kg / day shall be generated. The generated biodegradable and non biodegradable waste will be collected in three coloured bins at within campus and final disposal through Municipal Corporation Bhopal. The sewage sludge generated from STP will be converted into an odourless soil conditioner after digestion and used as manure for gardening purposes. PP has submitted copy of consent dtd 14.10.2015 from Municipal Corporation for disposal of solid waste. **It is decided that PP should:-**
- Provide compactors for MSW**
  - Ensure three bin system for segregated collection of waste.**
  - Ensure linkage with Bhopal Municipal Corporation for final disposal of MSW.**
- (viii) The maximum height of the building is Stilt + 6 floor (18 m.) road width 30 m; Front MOS m and side / rear MOS 7.50 m. As per MP Bhumi Vikas Niyam 2012 rule 42 (1) road width 12 m and above from MOS 7.50 m & side / rear 6.0 m for building up to 18 m height. **It is decided that the width of the road and side & rear MOS should be as per MPBVR 2012 rule no. 42 table 1.**
- (ix) PP has proposed to provide underground water storage tank, water sprinklers, Fire Fighting Extinguishers, separate fire hydrant pipe, 4 way fire brigade inlet connection, fire fighting pumps etc as per NBC 2005. **It is decided that as per MPBVR, 2012 rule 42 (3) PP should submit necessary drawings and details to the Authority (Nagar Nigam, Bhopal) incorporating all the fire fighting measures recommended in National Building Code part – IV point no. 3.4.6.1. The occupancy permit shall be issued by Nagar Nigam only after ensuring that all fire fighting measures are physically in place.**
- (x) PP has submitted roof top rain water harvesting system for ground water recharging and has proposed 08 nos of recharging pits. **It is decided that PP should ensure the rain water harvesting. In addition PP should provide recharging trenches. The base of the trenches should be Kachha with pebbles.**
- (xi) The total power requirement is 3171.46 KVA. The source of electricity is Madhya Pradesh Electricity Board. **It is decided that PP should ensure installation of photovoltaic cells (solar energy) for lighting in common areas, LED light fixtures, and other energy efficient equipments.**
- (xii) PP has proposed to provide 228 ECS for EWS (4571.84 @ 20 sq.m. per ECS) and 394 ECS for LIG (7888 @ 20 sq.m. per ECS). **It is decided that PP should ensure the car parking for 622 ECS as proposed.**

(xiii) PP has proposed a green buffer of 33 meters by planting trees from the bank of River Kerwa. PP has submitted landscape plan with detail of species. **It is decided that :-**

- (a) **Plantation should be done in two rows all along the periphery of the project area. PP should ensure plantation of the trees of indigenous local varieties like Neem, Peepal, Kadam, Karanj, Kachnaar etc along with ornamental varieties.**
- (b) **Every effort should be made to protect the existing trees on the plot.**
- (c) **PP should develop 10069 sq.m. as garden area.**
- (d) **Plantation should be done along the 18 m wide proposed road of the project.**

(3) The Authority decided to accept the recommendations of 227<sup>th</sup> SEAC meeting dtd 19.09.2015 with 10 special conditions and accord Environmental Clearance to Proposed Residential Project "Affordable Housing Scheme" at Khasra no. 476 & 489 Village-Bairagarh Chichli, Tehsil-Huzur, District-Bhopal (MP).
