It appears that PP has not consulted the village panchayat, nor they have actually estimated on a realistic basis the activities under both the components. Therefore, PP is advised to resubmit the activity wise estimates in consultation with the village panchayat.

PP was directed to submit a study report on the impact of the mining activity on ground water. PP in his reply has failed to submit a study report. Secondly they were directed to submit the SPM data monitored by MPPCB while the mine was under operation. The reply submitted did not mention the location of the area from where the SPM was monitored and also the distance from the present mine has not been mentioned in the report submitted. PP is therefore again directed to submit the study report and the details of the area monitored by MPPCB for collecting SPM data.




