

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1238 dated: 15/1/2015, has reported that there is no more mines operating or proposed within 500 meters around the said mine.

During presentation PP informed that he has requested mining department for certain amendments in mine plan and revised mine plan is under the approval. On the request of PP, the case is deferred to SEIAA for necessary action.

- (4) It was noted that human settlement is at 25 m distance, Kanhan river is at 750 m and Jam river at a distance of about 150 m. from the mining site.
- (5) It was noted that the Tehsildar has reported the inter-state boundary with Maharashtra at 6 km from the mining site.
- (6) National Park/Sanctuary is not located within 10 km radius.
- (7) It was noted that the mining plan is approved by the IBM (vide letter no. CNW/DOL/MPLN dtd. 11.01.2012. As per mine plan the life of mine is 10 years.
- (8) After detailed discussions and perusal of recommendations of 232nd SEAC meeting dtd 28.10.2015, presentation made by the PP in SEIAA & SEAC, **it was decided to ask the following information:**
 - I. Verification of the nearest Inter-State boundary distance from the ML area (i.e., Maharashtra boundary) by the Collector, Chhindwara.
