The case is therefore returned to SEIAA for necessary clarifications"


As per the above observation, it is decided to close the case and PP may be informed to submit fresh application alongwith the relevant document. Copy to all concerned.

As per the above observation, it is decided to delist the case. However, it is liable for re-listing once the PP submits the complete information. Copy to PP & all concerned.


