After detailed discussion and recommendations of 267th SEAC meeting dtd. 15.01.2016, the national highway is about 20 m. from the mining lease site. Collector, Gwalior be asked to explain how the mining lease has been granted in violation to the M.P. Minor Mineral Rules as amended in 2013. Copy to PP.

After detailed discussion and recommendations of 267th SEAC meeting dtd. 15.01.2016, from the google map it appears that another mine is in close proximity to the said mining lease area whereas Mining Officer Indore has reported that there

are not mines within a periphery of 500 m. Collector, Indore should have this verified and submit the information latest by 10.03.2016. Copy to PP.

After detailed discussion and recommendations of 267th SEAC meeting dtd. 15.01.2016, from the google map it appears that part of the site is well within the submergence area of a water body and in close proximity to the human settlement. Collector, Indore may be asked to clarify as to how the lease has been granted as per the M.P. Minor Mineral Rules as amended in 2013, wherein about 100 m. distance should be left from the water body. Copy to PP.

".....The case was presented by the PP and their consultant and during presentation it was observed that the shape of QL area is awkward and a natural drain is also passing very near (approx 80 meters) from then OL area and if the space for garland drain and buffer zone is deducted, the production of 20,000 cum/year will not be sustainable in an area of 0.85 ha. Thus the case is not recommended for grant of Environmental"

As per the above recommendation of SEAC, the case is hereby rejected. Copy to PP and all concerned.

..... The EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A':


- Production of **Stone** not exceeding 1,80,000 cum/year as per mine plan.
- Being a Temporary Permit (TP) validity of EC should be only up to the validity of TP.
- Approach road from site to the main road will be maintained by the PP.
- It being a case of TP, PP has to ensure the execution of closure plan


As per the above observation, the production capacity recommended by SEAC is 1,80,000 cum/year (**as per Mining Plan**). However, after perusal of the mining plan the capacity indicated therein is 75000 cum/year. The case may be returned to SEAC for clarification.


