"After detailed discussion and perusal of the recommendation of 219<sup>th</sup> SEAC meeting dtd. 25.08.2015, this is a case of Dolomite mining and appraised by SEAC under B2 category. However, another similar case of Dolomite mining

has been appraised under B1 category. This case may be returned to SEAC for clarification.

(3) Thereafter, the case was discussed in 255<sup>th</sup> SEAC meeting dtd 02.01.2016 and it has been recorded that......

"The case was earlier presented in the 219th SEAC meeting 25/08/2015 wherein after deliberations the EMS and other submissions made by the PP were found to be satisfactory and acceptable, hence committee decided to recommend the case for grant of prior EC.

SEIAA vide their letter no. 6515 dated 20/10/2015 has sent back the case for clarification as this is a case of Dolomite mining and appraised by SEAC under B-2 category. However, in other similar case of Dolomite mining has been appraised under B-1 category and the same was placed before the committee for scrutiny and necessary comments.

Committee after discussion observed that:-

- EIA notification 2006 does not differentiate between minor minerals and major minerals. As per EIA notification 2006, all the mining projects having lease area more than or equal to 5 ha were required to obtain prior Environment clearance.
- Mining projects of minor minerals having lease area less than 5 ha were brought under the purview of EIA notification 2006 after a judgement of Hon Supreme court Deepak Kumar Vs State of Haryana dated 27.2,2012.
- The mining projects of major minerals were also brought under the purview of EIA notification 2006 by an amendment in EIA notification 2006, no SO 2601(E) dated 7.10.2014.
- 4. As per the amended EIA notification 2006, Mining projects (both major and minor minerals) of lease area less than 50 ha are categorized as B and are appraised at State level by SEIAA.
- As per OM dated 24.06.2013, Mining projects of brick earth and ordinary earth (minor minerals) of less than 5 ha lease area are categorized category B2 projects and are appraised as per stipulations stated in the OM.
- 6. As per OM dated 24.12.2013, Brick Earth' / 'Ordinary Earth' mining projects with mining lease area more than equal to 5 ha but less than equal to 25 ha and all other minor, mineral mining projects with mining lease area < 25 ha, except for river sand mining projects are categorized as Category 'B2' projects. These projects are appraised based on the following documents: (a) Form-1 (b)Pre-feasibility report (c) Approved Mining plan approved by state govt. Provided in case the mining lease area is likely to result into a cluster situation, i.e. if the periphery of one lease area is less than 500 meter from the periphery of another lease area and the total lease area equals or exceeds 25 ha, the activity becomes Category 'B1' Project In such a case, mining operations in any of the mine lease areas in the cluster is allowed only if the environmental clearance has been obtained in respect of the cluster.

7. As per OM dated 24.12.2013 and NGT judgment dated 13.01.2015, The river sand mining projects with lease area less than 25 ha are categorized as 'B2' projects. These projects are also appraised based on the following

documents: (a) Form-1 (b)Pre-feasibility report (c) Approved Mining plan approved by state govt. In addition to the requirement of these documents, these projects are considered subject to the following stipulations: (a) The mining activity shall be done manually. The depth of mining shall be restricted to 3 m / water level, whichever is less. (b) For carrying out mining in proximity to any bridge and / or embankment, appropriate safety zone shall be worked out on case to case basis to the satisfaction of SEAC / SEIAA, taking into account the structural parameters, locational aspects, flow rate etc., and no mining shall be carried out in the safety zone so worked out. No in-stream mining shall be allowed. (c) The mining plan approved by the authorized agency of the State Government shall inter-alia include study to show that the annual replenishment of sand in the mining lease area is sufficient to sustain mining operations at levels prescribed in the mining plan and that the transport infrastructure is adequate to transport the mines material. In case of transportation by road the transport vehicles will be covered with the tarpaulin to minimize dust/ sand particle emissions. (d)EC will be valid for mine lease period subject to a ceiling of 5 years. Provided, in case the mining lease area is likely to result into a cluster situation i.e. if the periphery of one lease area is less than 1 km from the periphery of another lease area and total lease area equals to or exceeds 25 ha., the activity shall become Category 'B1' Projects. In such a case, mining operation in any of the mine lease area in the cluster is allowed only if the environment clearance has been obtained in respect of the cluster.

- 8. Clause (e) of section 3 of the Mine & Minerals (Development & Regulation) Act, 1957, defines the minor mineral as ""minor minerals" means building stones, gravel, ordinary clay, ordinary sand other than sand used for prescribed purposes, and any other mineral which the Central Government may, by notification in the Official Gazette, declare to be a minor mineral"
- 9. In exercise of the power conferred by clause (e) of section 3 of the Mine & Minerals (Development & Regulation) Act, 1957 (67of 1957), the Central Government has declared the following 31 minerals to be minor minerals in addition to the minerals already declared by notification as minor minerals vide gazette notification S.O. 423(E) dated 10 Feb. 2015.

In view of above, committee recommends that:-

- A. It is appropriate to appraise all the pending cases of above 31 minerals which has been declared as minor mineral by Govt. of India vide Gazette notification S.O. 423(E) dated 10 Feb. 2015, as per the above mentioned guidelines issued by MoEF for appraisal of minor mineral mining projects vide OM dated 24.6.2013 and 24.12.2013 as B-2 category on case to case basis. However, based on site location, production quantity, area of lease and surrounding environmental sensitive issues, case can be considered as Category B-1 as done in other Case No.-3298/2015 of Shri O.G. Goyal, Executive Director & Nominated Owner, M/s Hira Power & Steels Ltd., 101-C, Parwani Complex, Civil Line, Raipur (CG)-492001 Prior Environment Clearance for approval of Dolomite Mine in an area of 13.25 ha. (6,00,000 TPA) at Village-Kakiya, Tehsil-Bichiya, District-Mandla (MP).
- B. In case of Case No.-3307/2015, Shri Laxman Tiwari, At & Post-Badwara Khurd, Teh.-Murwara, District-Katni (MP)-483504 Prior Environment Clearance for approval of Dolomite Mine in an area of 1.676 ha. (Expansion in production capacity from 2000 TPA to 12,839 TPA) at Khasra No.-400, Village-Salaiya, Tehsil-Murwara, District- Katni (MP) considering the lease area of <2.00 ha and production capacity to 12,839 TPA, committee stands by its earlier recommendation made in the 219th SEAC meeting 25/08/2015 and decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'A':
- 1. Production of Dolomite as per mine plan with quantity not exceeding 12,839 TPA."
- (4) PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) It was noted that the inter-state boundary, National Park/Sanctuary are not located within 10 Km. radius. Hence, the General Condition is not attracted.
- (6) It was noted that the mining plan is approved by the IBM (vide letter no. MP/Katni/Dolomite/M.Sch 33/13-14 dtd. 03.01.2014. As per mine plan the life of mine is 09 years.
- (7) The proposed plantation program was examined and it was found that 0.0360 ha area shall be covered under plantation and 200 saplings shall be planted at the end of lease period.
- (8) After detailed discussions and perusal of recommendations of 255<sup>th</sup> SEAC meeting dtd 02.01.2016, presentation made by the PP in SEIAA & SEAC, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:
  - PP shall fence the entire ML area and develop a green belt by planting at least 400 plants around it in two rows.

A total of 0.28 ha area shall be covered under afforestation.

- III. No crusher shall be installed at the mining site.
- IV. The 500 m long Village road along the ML area shall be maintained by PP, so as to minimize the emission of particulate matters and reduce the air pollution in the surrounding area. The plantation shall be carried out on either side of the road by PP.
- V. Mining shall not be carried out below the water table.
- Pumped out water of the mined out pits should be utilised for development of greenbelt.
- VII. Water samples of the existing pond, well, tube-well, handpump etc., within 500 m area of mining site should be tested annually via authorised water testing laboratory by PP.
- VIII. Shed alongwith the first-aid facility shall be developed for the workers at mining site.
  - IX. The PP shall undertake the following activities in nearby villages on priority in consultation with the respective Gram Panchayats and make separate budget provisions under the CSR for these activities:
    - a) Skill upgradation programme for the villagers of nearby villages.
    - Sanitation activities including construction of toilets in consultation with village Panchayat.
    - c) Installation of rainwater harvesting structure.

This case was discussed in 269th SEIAA meeting dtd. 06.12.2015 and it was recorded as:-

After detailed discussion and recommendations of 242<sup>nd</sup> SEAC meeting dtd. 07.11.2015, It was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC.

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall not exceed 6m. or water level whichever is less.
- (iii) The final decision of Hon'ble NGT (CZ) Bhopal and Hon'ble NGT Principal Bench, New Delhi in OA No. 49/2015 (Amarkant Mishra Vs State of MP & others), shall be obligatory on the part of PP.

Production of Sand not exceeding 35,640 cum/year as per mine plan."

From the above observation the case pertains to mining of sand accumulated on the banks and adjunct land due to high floods in river Narmada. SEAC has appraised this case as "Khodu Bharu Sand Mining" and not river mining. In river Narmada due to construction of successive dams and submergence thereof, NVDA has identified re-habilitation sites. NGT has also taken up the cases of submergence and re-habilitation as Original Application and Appeals. In a particular case regarding illegal mining OA No. 78/2015 "Medha Patkar V/s State of MP & Others" nominated Court Commissioners and they have submitted their report which is being heard and a final decision will be taken in near future.

It was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC

(i) PP shall not start mining activity before execution of lease agreement.

Hence, Prior Environmental Clearance is granted for Sand Quarry (Khodu Bharu) (Opencast Manual Method) in an area - 5.00 ha., for production capacity of 35,640 cum/year at Khasra No.- 55/1 at Vill.-Pandyaghat, Teh.-Maheshwar, District-Khargone (MP) for the lease period to M.P. State Mining Corporation Ltd., through Shri Rajeev Saxena, OIC, Sub Off.-Dhamnod, Teh.-Dharampuri, Dist-Dhar (MP)-454552.

This case was discussed in 269th SEIAA meeting dtd. 06.12.2015 and it was recorded as :-

After detailed discussion and recommendations of 242<sup>nd</sup> SEAC meeting dtd. 07.11.2015, It was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC.

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall not exceed 6m. or water level whichever is less.

(iii) The final decision of Hon'ble NGT (CZ) Bhopal and Hon'ble NGT Principal Bench, New Delhi in OA No. 49/2015 (Amarkant Mishra Vs State of MP & others), shall be obligatory on the part of PP.

Thereafter, the case was reviewed in 276<sup>th</sup> SEIAA meeting dtd. 28.12.2015 and returned to SEAC for clarification regarding the depth of pit. SEAC has now submitted the recommendations in 259<sup>th</sup> SEAC meeting dtd. 06.01.2016 which is reported as under:-

"The above case was placed before the committee and committee decided that it's being a case of Khodu Bharu Sand Mining Lease wherein sand gets accumulated during flood beyond the river bank and should not be treated as river sand mining thus the earlier recommendation made in 242" SEAC meeting dated 07/11/2015 may be modified and now read as follows:-.

"Committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure 'C':

Production of Sand not exceeding 28,000 cum/year as per mine plan."

From the above observation the case pertains to mining of sand accumulated on the banks and adjunct land due to high floods in river Narmada. SEAC has appraised this case as "Khodu Bharu Sand Mining" and not river mining. In river Narmada due to construction of successive dams and submergence thereof, NVDA has identified re-habilitation sites. NGT has also taken up the cases of submergence and re-habilitation as Original Application and Appeals. In a particular case regarding illegal mining OA No. 78/2015 "Medha Patkar V/s State of MP & Others" nominated Court Commissioners and they have submitted their report which is being heard and a final decision will be taken in near future.

It was decided to grant Prior Environmental Clearance subject to the following specific conditions in addition to the conditions imposed by SEAC

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall not exceed 6m. at the end of lease period and not beyond that.
- (iii) Proper demarcation of the site should be done in the presence of NVDA, Revenue and Mining Officials with proper boundary marks/stones. Periodic check and vigil should be maintained by Revenue and Mining Officials that the boundary marks/stones are not disturbed and no mining is done beyond the lease limit.
- (iv) PP should ensure that the top soil/mud should be used for consolidation of river banks and plantation on the banks.
- (vi) PP should ensure that the top soil/mud should be used for consolidation of river banks and plantation on the banks.
- (v) (vii) The final order and directives in the OA No. 78/2015 (Medha Patkar V/s State of MP & Others) shall be binding on the PP. Mining Officer, Badwani shall be responsible and accountable for the implementation of any directives to be given in the orders.
- (vi) (viii) The land settlement officer NVDA along with the Revenue, Mining and State Mining Corporation Officials shall demarcate the site and no mining will be permitted within 100m from the bank of rivers on north and west side.

(VIII) (P) PP will ensure that the banks are not damaged by the mining activity.

- 17. Case No. 498/2009 Prior Environment Clearance for Deori Limestone, Laterite, Ochre & White Clay mine in an area of 23.123 ha. for production capacity of 50000 TPA at Khasra Nos. (as per lease deed) at Village Deori, Tehsil-Maihar, Distt-Satna-M.P. by Shri Lalit Sehgal Rewa Road, Maihar, P. O. Satna (M.P).
  - (1) SEAC in its 76 th meeting dtd. 07.01.2011 recommended the case for grant of prior EC with 04 special conditions.
  - (2) The case was discussed in 253<sup>rd</sup> SEIAA meeting dtd 29.10.2015 and it was recorded that .......

"The case was discussed in 216" SEIAA meeting dtd. 07.07.2015, the information has been received and therefore PP is hereby invited for a detailed presentation"

Further the case was discussed in 272<sup>nd</sup> SEIAA meeting dtd 17.12.2015 and it was recorded that .......

"PP requested for other date for presentation"

- (3) Thereafter, PP/Consultant made a presentation on all aspects of the project and all conccerned issues were discussed in details.
- (4) It was noted that National Park/Sanctuary is not located within 10 km radius. Hence, the General Condition is not attracted.
- (5) Mining plan is approved by the IBM (vide letter no. MP /Satna /Limestone /MPLN/4-23/ 08-09 dtd. 25.03.2009).
- (6) The proposed plantation program was examined and it was found that 32406 trees shall be planted in an area of 15.24 ha at the end of lease period.
- (7) It was noted that the water requirement is 7.5 KLD (4.5 KLD Dust Suppression+ 1 KLD Green Belt + 2 KLD Drinking), which shall be met from mine pit and ground water.
- (8) It was noted that the Public Hearing was held on 12.08.2010 at Govt. Primary School, Vill. - Jirhat, Tehsil - Maihar, Distt-Satna (M.P.) under the Chairmanship of Upper Collector, Satna. The issues raised during public hearing were of general nature and nothing adverse was found regarding degradation of the environment.

- (9) After detailed discussions and perusal of recommendations of 76<sup>th</sup> SEAC meeting dtd. 07.01.2011, presentation made by the PP in SEIAA & SEAC, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:
  - PP shall ensure plantation of at least three years old local trees species in the periphery of the lease area before commencement of the mining activity.
  - ii. The mined out lease area after 5 year shall be backfilled by Over Burden material available at the site and thereafter plantation of at least three years old local tree species should be undertaken in the backfilled area.
  - iii. No crusher shall be established at the mining site.
  - iv. The PP shall ensure the provision of toilets with proper water facility for girl students in the Middle School, Deori under Prime Minister Clean India Mission.

Hence, Prior Environmental Clearance for Deori Limestone, Laterite, Ochre & White Clay mine in an area of 23.123 ha. (Opencast other than fully Mechanised Method) for Production Capacity of 50000 TPA at Khasra Nos. (as per lease deed) at Village Deori, Tehsil- Maihar, Distt-Satna-M.P, for the lease period to Shri Lalit Sehgal Rewa Road, Maihar, P. O. Satna (M.P).
