A. REGARDING ONLINE ACCEPTANCE AND REGISTRATION OF MINING OF MINOR MINERAL CASES UPTO 5HA.


In 305th SEIAA meeting dtd. 17.03.2016 it was decided to continue the present online acceptance and registration of cases of minor minerals upto 5ha. at SEIAA level till the process of including DEIAA as admin user and a new domain is created in the present software. However, it was felt that it may duplicate the working at SEIAA & DEIAA level and continuing with the registration at SEIAA level will undermine the progress of issuance of EC for minor minerals upto 5ha. Therefore, the decision taken in 305th SEIAA meeting is hereby modified and now the online acceptance and registration of the cases upto 5ha. at SEIAA level will be discontinued from 24.03.2016 and DEIAA is hereby directed to accept the Form-1M in hard copy with all the relevant documents from PP. The copy may be forwarded to all District Collectors for compliance and a copy be endorsed to Principal Secretary, Urban Development & Environment Deptt., Principal Secretary Mineral Resources Govt. of MP, Director Geology & Mining and all concerned.







- (iv) The entire area shall be fenced and three rows of plantation should be done towards the road side


