After detailed discussions and query raised in SEIAA meetings 148th dtd. 20.09.2013, 161st dtd. 16.09.2014 and 173th dtd. 09.01.2015, and SEAC recommended in 137th meeting dtd. 24.07.2013, the case was delisted in 173rd SEIAA meeting for certified compliance report of EC conditions by RO, MoEF&CC, Bhopal. Now PP has submitted the certified compliance report and therefore the case is hereby relisted.  Case No. 4390/2015 Prior Environment Clearance for Stone/Boulder Quarry in an area of 4.00 ha. (47,129 cum/year) at Village-Abidabad, Tehsil-Ichhawar, District-Sehore (MP) by Shri Ajay Mohan, 10, Vaishali Nagar, Kotra Sultanabad, District-Bhopal (MP)-462003.

After detailed discussions and query raised in 328th SEIAA meeting dtd. 06.05.2016 and recommendation in 10th SEAC-II meeting dtd. 25.02.2016, a complaint was received to Sarpanch of Village Abidabad which was sent to Collector, Sehore for his comments. The reply has now been received on 11.05.2016 in which it is clarified that the human settlement is more than 500 m. from the lease area and therefore it will not cause any adverse impact any on the health of the villagers, Collector, Sehore has overruled the complaint made by the Sarpanch and therefore has been decided to accept the recommendation of SEAC for granting Prior EC subject to the following specific conditions in addition to the conditions imposed by SEAC

- (i) PP shall not start mining activity before execution of lease agreement.
- (ii) The depth of the pit shall be as per the Approved Mining Plan.
- (iii) The entire area shall be fenced first before starting the mining activity and three rows of plantation should be done towards the road.

Hence, Prior Environmental Clearance is granted for Stone/Boulder Quarry in an area of 4.00 ha. (47,129 cum/year) at Village-Abidabad, Tehsil-Ichhawar, District-Sehore (M.P.) for the lease period to Shri Ajay Mohan, 10, Vaishali Nagar, Kotra Sultanabad, District-Bhopal (MP)-462003.
