Minutes of the 338th Meeting of SEIAA dated. 04.06.2016

"This is case of Stone Deposit. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at khasra No.2731/1, Vill.-Billaua, Tehsil-Dabra, District-Gwalior (MP) 1.10 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.Q2-64/09, dated: -13/08/15, has reported that there is no more mine operating or proposed within 500 meters around the said mine.


The case was earlier schedule for discussion in the 23rd SEAC II meeting dated 06/05/2016 wherein is recorded that Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP was also absent in the 04th SEAC II meeting dated 08/02/2016. Committee decided to give last chance to PP for making presentation in the subsequent meetings of SEAC after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.


PP vide their letter dated 10/05/2016 has requested that since their area is < 5.00 ha and does not lies in Biloua cluster, the case file may be transferred to DEIAA. The committee observed that mining officer vide letter no. Q2-64/09, dated: -13/08/15, has reported that there is no more mine operating or proposed within 500 meters around the said mine. **Thus committee recommends that case may be transferred to DEIAA for onward necessary action."** *o.k.*


- (B) It is found that Mining Officer, District-Gwalior (MP) vide letter No. QL – 64/09 dtd. 13.08.2015 has certified that there is no sanctioned mine within 500m. periphery of the above said mine. Hence, it does not form a cluster situation.
- (C) As per coordinates submitted by PP the mining site is located about 2 km away from the Village-Bilaua, Dist-Gwalior (MP).
- (D) As per Appendix-XI of EIA Notification dtd. 15.01.2016 issued by MoEF & CC, Gol vide No. SO.141(E) all the cases having lease area upto 5 ha. and cluster of >5ha. and <25 ha. with no individual lease >5ha. shall be appraised by respective DEAC/DEIAA. Accordingly this case may be appraised by DEAC/DEIAA, Gwalior (MP).
- (E) This case having lease area 1.10 ha. i.e. below 5.0 ha.. SEAC neither appraised the case nor make any final recommendation, hence, as per OM dtd. 15.03.2016 issued by MoEF & CC, Gol this case is not under jurisdiction of SEIAA and shall be appraised by respective DEAC/DEIAA.
- (F) It is found that in OA No. 57/2013 Shree 1008 Kunwar Raj Rajeshwari V/s Sunil Sharma & Ors. is under consideration in Hon'ble NGT (CZ) Bhopal regarding mining / crusher operation in Bilaua Cluster and its surrounding area. No final order has been passed by Hon'ble Tribunal in this OA till now.

In view of above it is decided that the Technical file of this case be sent to DEIAA, Gwalior with the direction that since the case is sub-judice in Hon'ble NGT any order passed by Hon'ble Tribunal in OA No. 57/2013 will be applicable and to be complied by the PP. Copy to Collector, Gwalior & PP.
