1. **Case No. 2310/14** Prior Environment Clearance for **Limestone mine (opencast other than fully mechanized method)** in an area 7.316 ha. for production capacity of 464847 TPA (As per SEAC recommendation) at Khasra No. 152, P154, P163, P164, P165, P166, P167 at Village – Piprahat, Tehsil – Maihar, Distt. Satna (MP) by M/s. KJS Cement Ltd., Shri A.K. Singh, A.V.P., NH-7, Rajnagar, PO Maihar, Distt. Satna (MP)-485771.

(1) This is a project pertaining to mining of **Limestone mine** in MLA of 7.316 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. and more than 250 m from the forest boundary. The interstate boundary is not applicable as mining site falls in Village – Piprahat, Tehsil – Maihar, Distt. Satna (MP), thus it is not attracted by the general conditions and falls under category '1 (a)' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted

that this is a proposed mine having valid lease for 20 years with production capacity of 464847 TPA (As per SEAC recommendation).

- (2) It was reported by the PP that the lease area was granted to M/s. KJS Cement Ltd., for 20 years. The Mining Plan with progressive mine closure plan has been approved by DGM, Bhopal (vide IBM L.No. MP/Satna/Limestone/M.Sch-11/2014-15/6577 dtd. 25.11.2014).
- (3) SEAC in its 56<sup>th</sup> SEAC-II meeting dtd. 08.11.2016 has recommended the case with 14 special conditions for issuance of EC.
- (4) The case was then discussed in 388<sup>th</sup> SEIAA meeting dtd. 22.11.2016 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) The proposed plantation program was examined and it was found that 5260 sapling of tree species covering an area of 2.622 ha shall be planted during the lease period.
- (6) It was noted that the water requirement is 23 KLD (15 KLD for Dust Suppression+ 4.0 KLD for Green Belt + 4.0 KLD for Domestic), which shall be met from Village Pond, Tube well and Mine sump.
- (7) It was also noted that the Public Hearing was carried out on 13.04.2016 at mine site, Vill.- Piprahat, Teh.-Maihar, District-Satna (MP).
- (8) After deliberation the case was discussed in depth and PP was asked to submit the following information :-
  - i. Plan for conserving over burden dumps and top-soil separately with proper details of backfilling and reclamation.
  - ii. Layout plan of green belt/plantation.
  - iii. Transportation route plan of mineral from mining lease area to highway showing on map. Alternative route of haulage within the mining site upto the main road avoiding 7.5 m. buffer zone.
  - iv. Clarify the distance of NP/Sanctuary/Eco Sensitive from DFO, Satna.
  - v. Clarify the lease period.
  - vi. Details of existing trees on the mining site with the name of the species, girth and height. This should be verified by the Mining Officer, Satna. Enlisting of existing trees within the buffer zone (7.5 m.).
  - vii. Ground water details with water table of the area from Central Ground Water Board.
  - viii. Submit commitment of constructing 5 km. WBM road from mining area to bhadanpur.
  - ix. Revised CSR/ EMP Budget.
  - x. CSR activities in consultation with Gram Panchayat/District Administration.

2. **Case No. 4905/2016** Prior Environmental Clearance **Laterite mine (Open cast other than fully mechanized method)** in an area of 13.861 ha for production capacity of 75000 TPA at khasra no 53/1, 53/2, 53/3, 53/4 & 53/5 at Village-Dhausada, Tehsil-Amarpatan, District-Satna (M.P.) by Shri Veer Singh, S/o Shri Harsh Singh, P.O. Rampur Baghelan & District Satna M.P. – 485115.

- (1) This is a project pertaining to mining of Laterite Deposit in MLA of 13.861 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary and interstate boundary etc. thus it is not attracted by the general conditions and falls under category 'B-2' (Minor Mineral) by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease of 20 years with production of 75000 TPA.
- (2) It was reported by the PP that the lease area was granted to Shri Veer Singh for 20 years from 13.12.2004. This is a case of new mining lease. The Mining Plan with progressive mine closure plan has been approved by IBM (vide letter No. MP/Satna/Laterite/M.sch-60/2014-15/673 dated 12.02.2015).
- (3) The case was recommended for prior EC in 57<sup>th</sup> SEAC-II meeting dtd 09.11.2016 with 16 special conditions.
- (4) The case was then discussed in 388<sup>nd</sup> SEIAA meeting dtd 23.11.2016 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) PP has submitted that the depth of mining would be 3 m. to 4.1 m. below ground level and not beyond that.
- (6) The proposed plantation program was examined and it was found that 13900 sapling of tree species covering an area of 6.905 ha shall be planted during the lease period.
- (7) It was noted that the water requirement is 10 cum/day (Dust suppression- 5.0 cum of road length 700m twice a day, Green Belt – 2.3 cum @ 3 lt per plant & Domestic use – 2.7 cum @ 45 lt/head), which shall be met by bore well near site services and quarry sump.
- (8) After detailed discussions and perusal of recommendations of 57<sup>th</sup> SEAC-II meeting dtd 09.11.2016, presentation made by the PP in SEIAA & SEAC, it was decided that to accept the recommendation of SEAC for grant of prior EC to the project **subject to the following specific conditions:-**
  - (i). Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
  - (ii). Plantation programme as mentioned in comprehensive EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
  - (iii). PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. The two row plantation shall be carried out in the greenbelt area in current year.

- (iv). Greenbelt of 2.095 ha will be reserved for peripheral plantation with proper fencing. It should be done in first year and proper arrangements of water should be made for the plantation purpose.
- (v). PP should construct garland drain of size 2m x 1.5m alongwith the 04 settling tanks of size 20m x 6m x 3m around the pit area and mining lease boundary. PP shall also ensure the proper cleaning and maintenance of garland drain and settling tank. PP should ensure zero discharge from the mined area.
- (vi). Before commencing the mining activity, site demarcation should be done leaving 100 m. on north west and south west side of mining lease area as a "no mining zone". The demarcation should be done by the Revenue Officials in the presence of Mining Officer, Satna. PP should develop no mining zone as a green buffer.
- (vii). Monthly air & water quality monitoring shall be carried out by PP in consultation with Regional Officer, MPPCB. ~~Rewa~~ Satna.
- (viii). Water tankers with fogging arrangement will be used for regular water sprinkling on the haul roads to ensure effective dust suppression
- (ix). Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- (x). No blasting shall be allowed on the mining site.
- (xi). Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provide for the labourers. The additional budgetary provision under CSR for the same which is one time capital cost besides the other budgetary provisions made.
- (xii). The road from mine to PWD road in north will be tarred for the movement of trucks at own cost by PP with a clear width of 6 m. black top and additional 1.5 m. berms on both side.
- (xiii). Dumpers will not be overloaded to prevent spillage on the road.
- (xiv). PP should ensure to initiate backfilling at the end of first year.
- (xv). PP should ensure that the depth of mining would be 3 m. to 4.1 m. below ground level and not beyond that.
- (xvi). Under CSR activity in addition to the proposed activities following activities should be added:
  - a) Construction of individual toilets in Village Amjhar and Dhausada under Swach Bharat Abhiyan.
  - b) Financial Assistance for Construction of separate toilets for boys and girls in schools in village Amjhar and Dhausada (two per year)
  - c) Promoting & installing the non conventional sources of Energy viz distribution of Solar cooker and supply of LED bulb 500 number every year in village Dhausada.
- (xvii). PP has proposed a budget provision Rs 2.6 lakhs for the CSR activities.





Thus Committee decided that since sufficient opportunities have been given to the PP for appraisal and consideration of the project wherein PP remain absent in the 58th and 61st SEAC meetings, the case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project."*

As per the above observation, it has been decided to delist the case on the condition that if the PP intends to present the case in SEAC, it will then be relisted for appraisal. Copy to PP and all concerned.


