



The committee after deliberations decided that the letter issued by the collector against the SEIAA's query is self explanatory and committee has already recommended the case for EC and standby its recommendation made in the 29th SEAC II meeting dated 03/06/2016.

As per the above observation, SEAC has no comments to make, which is undesirable as they should have analyzed critically the mining activity and the urban sprawl of Sihora town. Since the Joint Director, T&CP has reported that NOC was not taken from him before the mining lease has been granted. In his letter he has objected to the mining activity in close proximity to the Sihora town, in fact the Khasra no. of the mining lease are part of the Development Plan Sihora 2011. After detailed discussion it was decided to send the letters of Collector, Jabalpur and Joint Director, T&CP Jabalpur to Secretary, GoMP, Department of Mineral Resources for comments, whether in view of the issues raised by Joint Director, T&CP Jabalpur, will it be appropriate to undertake mining activity within the planning area of Sihora town. 

heard before the Hon'ble NGT (Principal Bench) New Delhi. He has also enclosed the legal opinion of the Additional Advocate General, GoMP. Additional Advocate General, GoMP is of the opinion that the matter before the Hon'ble NGT is pending decision on the large size of mining leases bifurcated into small pieces to bring them within the purview of notification dated 01.07.2016 and further directed that any order passed shall be subject to final order of the Tribunal. The MP State Mining Corporation has filed exhaustive affidavit explaining the reasons for bifurcation to the lesser area. He has further opined that no stay has been granted by Hon'ble NGT for the operation.

Legal opinion was also sought from the Standing Counsel appearing for SEIAA in this case. He has also opined that Hon'ble NGT has only mentioned that any order passed will be subject to final order of Tribunal, which means that SEIAA can issue Prior EC to the PPs subject to the final order of the Hon'ble NGT.

After detailed discussions, it has been decided to issue a corrigendum wherein the ECs issued in following 48 sand mining cases after the filing of the case OA No. 404/2016 modifying the status of the condition in consonance with the interim orders of the Hon'ble NGT and it should be read as "This EC will be subject to the Hon'ble NGT, Principal Bench, New Delhi final orders in OA No. 404/2016". 


