Hon'ble NGT (CZ) Bhopal have instructed MP-SEIAA and SEAC in its order dated 21-03-2017 in Appeal No. 19/2016 & 20/2016 to submit factual position regarding construction of a road bridge by the Works Department and it is recorded as below :-

*.....In the light of the above, we would direct the Respondent No. 1 & 3 to submit before us the specific dates with regard to the conceiving of the project for the construction of bridge, the date on which project was approved , site was finalised and work contract awarded.*

In response to the above directions of the Hon'ble NGT (CZ) Bhopal it has been decided to get the information regarding the construction of road bridge and its date of approval and award of work contract from the Collector, Tikamgarh and Mining Officer Tikamgarh. A copy of the Hon'ble NGT (CZ) Bhopal order should also be endorsed to the Collector and Mining Officer, Tikamgarh. Separately Director, Geology and Mining and ED, M.P. State Mining Corporation should also be sent the copy of the Hon'ble NGT order and obtain the factual position about the location of

the road bridge and its distance from the lease granted by them. Since SEAC is also one of the respondent in this case, a reply should be obtained from them also.

9. **Case No. 272/2009**, Prior Environmental Clearance for Deshgaon Basalt metal stone quarry in area of 18.84 ha for production capacity 19,800 cum per year at village Deshgaon, tehsil Khandwa, district East Nimar, MP by Shri Rakesh Kumar Bansal, Ram Krishna Road, tehsil & district Khandwa, MP.

Hon'ble NGT (CZ) Bhopal have directed MP-SEIAA in its order dated 10-03-2017 in OA No. 129/2016 to review the matter in respect of grant of EC dated 05.05.2012.

*.....Looking to all these facts and other relevant facts that needs to be considered we direct the SEIAA to review the matter with regard to the grant of EC while doing so, SEIAA shall give a hearing to respondent No. 10. If necessary, SEIAA may have a fresh inspection of the area in case respondent No. 10 so desires.*

*In the meanwhile, we direct that the respondent No. 10 is restrained from carrying out its operation till the decision is taken by the SEIAA. In the light of the above, we would further request SEIAA to take an early decision in the matter, preferably within four weeks from the receipt of the certified copies. It would be open for the respondent No. 10 to approach SEIAA with a copy of this order and other supporting documents and records of this case.*

In response to the above directions of the Hon'ble NGT (CZ) Bhopal it has been decided to inform the PP to attend this office on 29.04.2017 and represent the case alongwith all relevant documents regarding Khasra Panchsala, NOC from DFO regarding the distance of Forest Boundary from the lease area, location of HT line, distance of water retaining structure/water body from the leased area, distance of leased area from the state highway etc. It was also decided to send a copy of the judgment to the Collector, Khandwa and Mining Officer, Khandwa and obtain their comments on the issues raised in the OA No. 129/2016 and the directives of Hon'ble NGT (CZ) Bhopal thereon.



**Minutes of the 420<sup>th</sup> Meeting of SEIAA dated. 06.04.2017**


Hon'ble NGT (CZ) Bhopal have directed MP-SEIAA in its order dated 30-03-2017 in Appeal No. 08/2017 (CZ) Pradeep Kumar Dubey Vs. MP SEIAA & 5 Ors. in M.A.No. 89/2017 & 90/2017 and Appeal No. 09/2017, M.A. No. 91/2017 & 92/2017 and Appeal No. 10/2017, M.A.No. 93/2017 & 94/2017 to make a site inspection :-


*.....We direct that before filing the reply the Members of SEIAA, SEAC and also the revenue officials carry out an inspection of the area with regard to all the mining leases of the Respondent No. 5 in the presence of the Applicant and the village representatives and submit their report along with the statement regarding objections if any of the local residents*

As per the above directives of the Hon'ble NGT (CZ) Bhopal, the copy of the order dated 30.03.2017 be sent to Member Secretary, SEAC to organize a site visit of the Members of SEAC and to be accompanied by local officer of MPPCB. The applicant and the village representatives should be informed of the date and time of the site visit so that they could be present at the location. Since the matter is to be heard on 18.04.2017, the site visit should be done well before the stipulated hearing date.
