The case was discussed in 457<sup>th</sup> SEIAA meeting dtd. 17.11.17 and recorded that :-

- (1) The project is based on Batac Jig Technology. The project comprises of coal unloading, handling, crushing, screening, washing with water, dewatering and separation of fines from washed water and storing the clean coal and rejects.
- (2) The coal requirement of the project is 3584.9 TPD. Raw coal from Collieries shall be transported to the Plant site by road as the different Collieries of NCL are located near to the proposed plant site.
- (3) There is no National park / Sanctuaries (DFO letter dtd. 22.04.16), Eco-sensitive areas, critically polluted areas and inter-State boundaries (PWD letter dtd. 21.03.2016) within 05 km around the proposed site.
- (4) The proposed capacity of coal beneficiation is 0.95 Million Ton Per Annum, the project is covered under 2 (a) category B of the EIA Notification issued by the Ministry of Environment & Forests vice S.O.1533 (E), dtd. September 14, 2006 and its amendments.
- (5) ToR was issued on 27.06.16 & PP has submitted EIA report on 31.03.17.







- (6) The case was discussed in SEAC meetings 278<sup>th</sup> dtd. 14.06.2016, 289<sup>th</sup> dtd. 29.04.17 & 294<sup>th</sup> dtd 23.06.2017 and has recommended for grant of prior EC subject to 25 special conditions.
- (7) The case was discussed in depth and it is noted that:-
- (i). The total land area of the project is 4.744 ha (11.722 Acres) has already been allotted to the Proponent by Govt. of Madhya Pradesh. PP has submitted Khasra Panchsala (2013-14) and land order issued by Zila Udyog Vyapar Kendra Singrauli dtd. 10.02.2016 for the land area 4.774 ha.
  - (ii). Public Hearing was conducted in the Village-Noudiha, Tehsil- Chitrangi, District- Singrauli, Madhya Pradesh on 12.01.2017 under Chairmanship of Collector, Singrauli District, some issues were raised in the Public Hearing regarding damage of NH road, air pollution, employment for villagers etc. which were readdressed by PP and PP has earmarked adequate fund in the CSR budget to take care of these issues.
  - (iii). The total water requirement is 4555 KLD and fresh water requirement is 685 KLD (Coal Washing - 648 KLD + Dust Suppression and water for coal stock yard to keep 4% moisture-27 KLD domestic- 5 KLD + Plantation - 5KLD ). The source of water for the project will be Ground water for which PP has obtained Permission from CGWA dtd 22.05.2017.
  - (iv). The proposed project is based on **zero discharge concept**. The effluent will be treated in thickener slurry ponds. No effluent will be discharged into the river/streams/water bodies from the proposed project. Settling pond is proposed to storage and recycling of surface water for use in the plant area. Floor wash water from plant workshop will be treated in Oil & grease trap. Treated effluent will be used for dust suppression on coal stock yard. Sludge and scum from the Oil and grease tank will be collected in a leakage proof container and will be sold to the authorized recycling vendor along with spent oil & grease. Domestic waste water 5.0 KLD will be disposed of through septic tank followed by soak pit.
  - (v). The project is two cut washery project. Only washed and reject coal have significant calorific value will be provided to nearby various industries.
  - (vi). The power requirement of the project is 750 KVA which will be sources from the Madhya Pradesh Poorve Khetra Vidhyut Vitaran Company.
  - (vii). For air pollution control, PP has proposed to construct concrete roads, water sprinklers during coal unloading and stacking, closed conveyor belts, dry fog type dust suppression arrangements, enclosures/shirt boards in coal crushing and screening plants, Bag filters etc. Besides these PP has proposed thick green belt towards the side of habitations, 15 feet wind break wall around stock yard. & operating vehicles with PUC.
  - (viii). PP has proposed firefighting measure including medium velocity spray portable fire extinguishers, fire alarm system, fire detection, heat detection, and alarm system to detect fire/heat/smoke in the vulnerable areas of the plant. Hydrant system covering the entire plant including all important auxiliaries and buildings. The system will be complete with piping, valves instrumentation, hoses, nozzles and hydrants, valves etc. First Aid firefighting equipment suitable for emergency should be maintained as per statutory requirements per TAC Regulations. Fire hydrant line covering major areas would be laid. It would be maintained as 6 kg / sq. compressor.
  - (ix). PP has proposed to provide rooftop rainwater harvesting system for rain water harvesting.
  - (x). Green area proposed by PP is about 1.7 ha by planting 2550 no. of trees as per EPCB's guideline for Greenbelt Development, 2000.

  4. PP should ensure regular Stack monitoring & Ambient air quality monitoring and should be carried out as per the guidelines/norms of MPPCB/CPCB.
  5. In plant control measures for checking fugitive emission from all the vulnerable sources shall be provided. Fugitive emission shall be controlled by providing closed storage, closed handling & conveyance of chemicals/materials, multi cyclone separator/bag filters and water sprinkling system.
  6. Dust suppression system including water sprinkler system/ fogging arrangement shall be provided at loading and unloading areas to control dust emission.
  7. Fugitive emission in the work zone environment, product, raw material storage areas etc. shall be regularly monitored.
  8. High efficient four stage ventury scrubber should be provided
  9. PP should ensure handling, disposal and management of hazardous waste as per the related prescribed rules.
  10. PP should provide garland drain all along the periphery of the project area.
  11. PP should ensure the traffic movement plan, parking facilities and road width as proposed.
  12. PP should ensure harnessing of roof water through recharging pits.
  13. PP should ensure that the onsite & offsite risk management plans are approved by the Competent Authority before commencing the operation of unit.
  14. PP should ensure plantation in 1.7 ha by planting 2550 no. of trees of total area green belt all around the washery plant. Plantation in the project area of indigenous local varieties like Neem, Peepal, Kadam and Kachnaar.
  15. PP should ensure to implement the CSR activities as proposed in the letter of Collector, Singrauli & Gram Panchyat.



.....After deliberation the case was discussed in depth and PP was asked to submit the following information :


- Latest tree survey report of the existing mining lease area including height, girth and species.


