1. **Case No. 5606/2018** Prior Environment Clearance for Stone Quarry in an area of 8.0 Ha.. (98800 cum per annum) (Khasra no. 574) at Village- Kundla, Tehsil - Nagda, Dist. Ujjain (MP) by Mr. Ashvin Maru S/o Shri Satish Maru, Chota Bazar, Ward 13 Unhel, Tehsil - Nagda, Dist. Ujjain, MP – 456221.

This case was discussed in 481st SEIAA meeting dated 10.05.2018 and it was recorded that.....

After detailed discussion, it was decided that PP shall submit the following information: -

- I. Consent of Gram Panchayat / water supplier of nearby village for providing of water for mining activities.
 - II. Copy of Pachmnama of mining lease area during site inspection/ demarcation by the revenue authority.
 - III. Certificate of Revenue Authority mentioning that there is no any type of encroachment within the mining site.
 - IV. Revised palntation programme including plantation of local species specially Neem, Bargad, Peepal, Munga etc.
 - V. CSR activities in consultation with Gram Panchayat.

3. **Case No. – 1665/2013** Prior Environmental Clearance for **Manganese Ore Mine** (Opencast Manual/ mechanized Method) in an area of 6.229 ha for Production Capacity 5,000 MTPA at Khasra no.-982, 984/2, 985 at Vill.- Katangjhari, Teh.- Lalbarra, Dist.-Balaghat (M.P) by M/s Vidhi Alias Pvt. Ltd., Bhiktiyog Apartment, Nargundkar, Layout Khamala Road, Nagpur (MH)-440015..

The case was discussed in 479th SEIAA meeting dated 12-04- 2018 and it was recorded that

*PP has submitted the information vide letter dtd 03.04.2018. Therefore it has been decided to relist the case and again **PP was asked to submit the following information at the earliest :-***


- i. *Status of mined out area in lease area from Mining Officer, Balaghat.*
- ii. *Details of human settlements situated in the nearby area of mine site from Collector, Balaghat.*
- iii. *Consents of remaining land owner of hutments for carrying out mining activities.*
- iv. *Ground water details with water table of the area from Central Ground Water Board.*


PP has submitted the following required information on 16.05.2018:


1. Mining Officer, (Mining Division) office of Collector, Balaghat has mentioned vide letter No. 569 dtd. 25.04.2018 that 8500 sq m is mined out area in above lease area.
2. As per collector letter 4 temporary hutments are exists in NE Direction of mine within 50 m from the mining lease. PP has submitted affidavit in SEAC to left 50 m safe zone & 7.5 m barrier zone (57.5 m) shall be left.
3. Land owners of Khasra no 982, 984/2 have given their Consent for mining.
4. As per Central Ground Water Board Report, district water level in the range of 4.0 to 8.0 m bgl. In village Katangjhri, water table in open well is at 18 m bgl.

After detailed discussions and perusal of recommendations of 59th SEAC-II meeting dtd.11.11.2016, presentation made by the PP in SEIAA & SEAC, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:

- I. PP will carry out mining activities only on those lands bearing Khasra Nos. 982,984/2 in which PP has obtained consents of land owners and mining activities shall be initiated only after getting NOC/ consent of remaining Land owner as per Rules 22(3)(J) of Mineral Concession Rules- 1960 with regard to ADM Balaghat Order vide Order No. 13.07.2010 on Khasra Nos. 985.
- II. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with







installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.

- III. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- IV. PP shall demarcate 57.5 m as "no mining zone" in NE direction including 50 m safe zone from nearest human settlement and barrier zone of 7.5 m in the periphery of mining lease area. PP shall ensure to develop a green belt in this area.
- V. The plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- VI. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- VII. PP should ensure plantation of Drumstick, Neem Peepal, Bargad, Neem etc. plants on priority.
- VIII. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- IX. PP shall ensure to construct and maintain approach road and maintained the existing pakka road in consultation with District Administration. Plantation will be carried out on both side of approach road.
- X. The over burden and waste will be stacked for five years and then simultaneously backfilled in the mined out area where plantation will be raised on it.
- XI. No overburden will be dumped outside the mine lease area.
- XII. No blasting shall be permitted in the mining lease area.
- XIII. Regular air & water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB.
- XIV. PP shall ensure generation of employment opportunities nearby Village on priority bases.
- XV. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XVI. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- XVII. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields
- XVIII. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- XIX. PP shall ensure the proper water supply arrangements for plantation especially in summer season.

- XX. PP shall ensure proper implementation of plantation, dust suppression, approach road construction, maintenance of existing pakka road and constructed of garland drain with settling tank especially for prevention of pollution in nearby lake as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XXI. PP must ensure implementation of the following activities with separate budget provision should be kept under CSR :
- a) Installation of potable water tanks in primary school of Katangjhari village
 - b) Contribution for Infrastructure development –Roads & Drainage System.
 - c) Installation of 2 hand pumps in nearby villager.
 - d) Need based activities of Local authorities requirement.

The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Grampanchayat.

- XXII. PP should ensure to submit half yearly compliance report and CSR activity report with photographs of plantation in MP-SEIAA.

Hence, Prior Environmental Clearance is granted for Manganese Ore Mine (Opencast Manual/ mechanized Method) in an area of 6.229 ha for Production Capacity 5,000 MTPA at Khasra no.-982, 984/2, 985 at Vill.- Katangjhari, Teh.- Lalbarra, Dist.-Balaghat (M.P) for the lease period to M/s Vidhi Alias Pvt. Ltd., Bhiktiyog Apartment, Nargundkar, Layout Khamala Road, Nagpur (MH)-440015 subject to above specific conditions.

4. **Case No. 1938/2014** Prior Environment Clearance for approval of proposed project "Park Nav Uday Hospital & Medical College" at Village-Maharajpura, Tehsil & District-Gwalior (MP) by Mr. Vijay Bhateja, Vice President, Nav Uday Educational & Charitable Society, 29-A, PKT-1, Sector-7, Dwarka, New Delhi-110075

The case was discussed in 455th SEIAA meeting dtd. 08.11.2017 it was recorded that :-

"PP has submitted the desired information on 19.07.2017 as per 380th SEIAA meeting dtd. 03.11.2016. Therefore it has been decided to relist the case and PP may be called for clarification of the issues for which the quarries has raised in the said meetings".

PP was called for clarification however PP not attended any SEIAA meeting to clarify the matter even after passing more than 6 months. Since PP has not shown any intrest hence it is decided to delist the case which is liable for relisting if PP intends to clarify the case in SEIAA. Copy to PP and all concerned.



In view of above it is decided that PP may be invited for clarification.




In view of above it is decided to call PP for clarification as per CPCB guideline.
