


## Minutes of the 512<sup>th</sup> Meeting of SEIAA dated. 12.12.2018







1. **Case No. 5729/2018-** Prior Environmental Clearance for Pyrophyllite & Diaspore Mine (Open cast other than fully mechanized method) in an area of 10.0 Ha. for production capacity of 15,447 TPA at Khasra no. 687 at Village- Paretha, Tehsil - Nowgaon, District. Chattarpur (MP) by Shri Narendra Kumar Mishra S/o Shri Ashok Kumar Mishra, R/o Behind Circuit House Chattarpur, Dist. Chattarpur, MP - 471001.

- (1) This is a project pertaining to mining of Pyrophyllite & Diaspore Mine in MLA of 10.0 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-2' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine with production of 15,447 TPA.
- (2) It was reported by the PP that the lease area of 10.00 hectares was originally granted in favour of Shri Narendra Kumar Mishra S/o Shri Ashok Kumar Mishra, This is an Existing mine. The lease period is effective from 24-11-1993 to 23-11-2043 i.e. 50 years as per latest amendment in Mines and Minerals (Development & Regulation) Amendment Ordinance 2015 for 50 years lease period. The Mining Plan Approval letter Vide No. 9323/ एम०पी/ जी-3/ न. क. 46/2017, Date: 31.05.2018.
- (3) SEAC in its 332th SEAC meeting dtd 26.10.2018 has recommended the case with 32 special conditions for issuance of EC.
- (4) The case was then discussed in 509th SEIAA meeting dtd 16.11.2018 and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (5) The proposed plantation programme was examined and it was found that 3000 sapling of tree species covering an area of 3.0 ha shall be covered under plantation.
- (6) It was noted that as per Forest Conservator Letter no. 3496 dated. 07.11.2016, the National Park/Sanctuary are not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.
- (7) It was noted that the water requirement is 4.3 KLD (2KLD for Dust Suppression + 1.0 KLD for Domestic + 1.0 KLD for Green Belt + 0.3 KLD for Others ) which shall be met from tankers.

After deliberation, the case was discussed in depth and it was found that mining is proposed to be carried out on plateau area and human habitation is located on foot hill in close vicinity of project site. PP has proposed controlled blasting for mining of minerals. There is possibility of adverse impact on human habitation due to mining. Hence, it is decided to send the case file to SEAC for site visit to verify the factual status of the site and accordingly re-appraise the case.

2. **Case No. 5241/2016** - Prior Environmental Clearance for Manganese Mine (Open Cast Other than fully mechanized Method) in an area of 4.906 ha. for production capacity of 10800 TPA at Khasra No. 150/1 at Village Selwa, Tehsil Katangi, District Balaghat (M.P.) by Shri Sandesh Jain (Partner), M/s Metals & Minerals, MIG- II – 14, Opp. Jain Temple, Housing Board Colony, District Katni (M.P.) -483001.

The case was discussed in 506<sup>th</sup> SEIAA meeting dated 17.10.18 and it was recorded that

*"-----As per above decision, letter was written to Revenue Department and Mineral Resources Department to seek clarification. In response to SEIAA letter, Collector, Balaghat has intimated that land use of proposed mining lease area is recorded as as Bhoopal (Jal mad) as per Revenue record and title has not been changed so far. Besides this, Under Secretary, Mineral Resources Department vide letter No 3915/691/2018/12-2 dated 25.8.18 has informed that DGM letter dated 14.12.15 has been quashed by Hon'ble NGT(PB) vide order dated 4.05.16 in OA 34/2016. Hence, mineral excavation carried out from proposed mining lease area is violation of Prior EC as per EIA notification. Therefore, it is decided to close the case with direction to PP not to do mining activities in said land without obtaining prior EC. Copy to PP and all concerned".*

In view of above, PP vide letter dated 3.11.18 has represented to re-open the case by giving production details and revenue record. Considering the request, PP was invited for clarification and PP presented the case to justify their stand. However, this case is deferred for further clarifications.






PP has not submitted the desired information till date therefore it has been decided to delist the case which shall be liable for relisting once the information is received. Copy to PP and all concerned.
