Concerned Mining Officer vide letter no. 1604 Dated: 30/10/2015 has reported that there are no more mines operating or proposed within 1000 meters around the said mine.

Earlier this case was discussed in 40<sup>th</sup> SEAC-II meeting dated-25/07/2016 wherein it was observed that: *Neither the Project Proponent (PP) nor his representative was present to*

This is case of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra no.-825, Village-Khamroli, Tehsil-Sevda, District-Datia (MP) 22.600 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format in the form of combined NOC by OIC. Concerned Mining Officer vide letter no. 449 dated: 20/8/2015 has reported that there is 01 more mine operating or proposed within 1000 meters around the said mine with total area of 38.4 ha including this mine.

The case was earlier discussed in the 268th SEAC meeting dated: 16/01/2016 wherein it was observed that concerned Mining Officer vide letter no. 449 dated: 20/8/2015 has reported that there is 01 more mine operating or proposed within 1000 meters around the said mine with total area of 38.4 ha including this mine. It being a case of cluster where the total area is > 25 ha it was decided to consider this case as B-1 and committee recommended to issue standard TOR prescribed by MoEF&CC with following additional TORs:-

- 1. Detailed evacuation plan is to be discussed in the EIA report.
- 2. EIA/EMP is required to be prepared for entire cluster in order to cover all the possible externalities. The report should cover carrying capacity, transportation and other related issues for the cluster.
- 3. Photographs and maps depicting all the mines present in the cluster.
- 4. On a Google map, show all the mines in a cluster with all four co-ordinates of individual mines.
- 5. The date and duration of carrying out the base line data collection and monitoring be informed to the concerned Regional Officer of the M. P. Pollution Control Board.
- 6. Photographs of individual mine during EIA process with date.
- 7. Justify the production from each mine and also justify the duration when mining is possible.
- 8. If on the evacuation route there are human settlements justify how they will be protected or suggest alternate evacuation route.
- 9. Show on a map, where temporary storage facility of sand will be created along with environmental protection measures proposed for such storage facility.
- 10. Discuss and assess impacts of sand mining on pisciculture.
- 11. Discuss and assess impacts of sand mining on agricultural practices (such as growing of water melons etc) if taking place in the cluster area.
- 12. Discuss the measures that will be adopted for the bank erosion.
- 13. Indicate in EIA the structures such as bridges/barrages/dams close to individual leases in cluster and effects of mining on their structure stability with protection plan.
- 14. Provide the historical data of last 05 years about the sand already evacuated and the replenishment capacity of individual mine lease.

As per the above, the TOR was issued to the PP vide letter no. 260 date: 02/3/2016

MP State Mining Corporation Limited, Bhopal vide their letter no. 400 dated 09/08/2016 has also informed that it is a case of non-cluster as per GOI, MoEF&CC notification dated 01/07/2016 as this lease was sanctioned prior to the 09/09/2013. Concerned Mining Officer vide letter no. 914 dated 29/07/2016 has issued a certificate stating that above lease was sanctioned vide order no. F4-1/2010/12/01 dated 22/09/2010 and thus does not falls under the perview of cluster approach as per GOI, MoEF&CC notification dated 01/07/2016.

SEIAA vide letter no. 3173/SEIAA/16 dated 16/08/2016 and 3240/SEIAA/16 dated 26/08/2016 has also instructed to appraise such cases on priority as per GOI, MoEF&CC notification dated 01/07/2016 and thus committee decided that as per the above instructions of SEIAA, all such cases should be appraised on the priority on the basis the lease documents available in the file/representation submitted by the PP.

The case was presented today by the PP and their consultant wherein the submissions made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure  $\frac{B}{B}$ 

- 1. Production of Sand as per mine plan with quantity not exceeding 2,26,000 cum/year.
- 2. District Authority should record the deposition of sand in the lease area at an interval of 100 meters annually in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.
- 3. Evacuation of sand should not be allowed through the roads passing through the villages.
- 4. Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads.
- 5. If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.
- 6. The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- 7. No diversion of active channel should be allowed for mining.

This is case of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-825, Vill.-Khamroli, Tehsil-Sewada, District-Datia (MP) 15.800 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vides letter no.405-3, dated: 04/08/2015 has reported that there is 01 more mine operating or proposed within 1000 meters around the said mine with total area of 38.40 ha including this mine.

The case was presented by the PP and their consultant in  $257^{\text{th}}$  meeting dated-04/01/2016 and during presentation it was observed that concerned Mining Officer vides letter no.405-3, dated: 04/08/2015 has reported existence of 01 more mine operating or proposed within 1000 meters around the said mine with total area of 38.40 ha including this mine. It being a case of cluster where the total area is > 25 ha it was decided to consider this case as B-1 and committee recommended to issue standard TOR prescribed by MoEF&CC with following additional TORs:-

- 1. Detailed evacuation plan is to be discussed in the EIA report.
- 2. EIA/EMP is required to be prepared for entire cluster in order to cover all the possible externalities. The report should cover carrying capacity, transportation and other related issues for the cluster.
- 3. Photographs and maps depicting all the mines present in the cluster.
- 4. On a Google map, show all the mines in a cluster with all four co-ordinates of individual mines.
- 5. The date and duration of carrying out the base line data collection and monitoring be informed to the concerned Regional Officer of the M. P. Pollution Control Board.

MP State Mining Corporation Limited, Bhopal vide their letter no. 400 dated 09/08/2016 has also informed that it is a case of non-cluster as per GOI, MoEF&CC notification dated 01/07/2016 as this lease was sanctioned prior to the 09/09/2013. Concerned Mining Officer vide letter no. 913 dated 29/07/2016 has issued a certificate stating that above lease was sanctioned vide order no. F4-1/2010/12/01 dated 22/09/2010 and thus does not falls under the perview of cluster approach as per GOI, MoEF&CC notification dated 01/07/2016.

SEIAA vide letter no. 3173/SEIAA/16 dated 16/08/2016 and 3240/SEIAA/16 dated 26/08/2016 has also instructed to appraise such cases on priority as per GOI, MoEF&CC notification dated 01/07/2016 and thus committee decided that as per the above instructions of SEIAA, all such cases should be appraised on the priority on the basis the lease documents available in the file/representation submitted by the PP.

The case was presented by the PP and their consultant in the 52<sup>nd</sup> SEAC meeting dated 12/10/2016 and during presentation it was observed that as per the Google image of Dec 2015 based on the co-ordinates provided by the PP that approx. 40% of the lease area is submerged in water. Thus remaining 60% area is minable and 94,800 cum/year sand can be evacuated. It was also observed that a bridge like structure was observed which appear to be incomplete. PP submitted that it is a crossway which is kachha in nature. PP & OIC, State Mining Co-operation were present during discussion were asked to submit photographs and certificate of Tehsildar/competent authority for confirmation of their submission for further consideration of this project.

PP vide letter dated 14/10/2016 have submitted photographs and certificate issued by the Nayab Tehsildar issued vide letter no. 78/2016 dated 13/10/2016 stating that there is no bridge in the lease. Since there is no bridge in existence in the QL area as per the certificate of Tehsildar the issue regarding existence of bridge in the QL area is resolved. The other submissions made by PP were found satisfactory and acceptable and thus the committee

decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure  $\exists B\alpha$ 

- 1. Production of Sand as per mine plan with quantity not exceeding 94,800 cum/year.
- 2. District Authority should record the deposition of sand in the lease area at an interval of 100 meters annually in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.
- 3. Evacuation of sand should not be allowed through the roads passing through the villages.
- 4. Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads.
- 5. If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.
- 6. The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- 7. No diversion of active channel should be allowed for mining.

#### 31. Case No.-5274/2016 Shri Gurudayal Bhaduriya, Rai Khedi Road, Ward No. 6, Sai Prakash Ward, Pipariya, Distt. Hoshangabad – 462 135 (SIA/MP/MIN/56353/2016-EC) Prior Environment Clearance for Sand Deposit in an area of 8.522 ha. (42,610 cum/year) at Khasra No. 115 at Village-Dandiya Kishore, Tehsil - Pipariya, Dist. Hoshangabad (MP)

This is case of Sand Deposit. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 115 at Village-Dandiya Kishore, Tehsil - Pipariya, Dist. Hoshangabad (MP) 8.522 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-564 dated: 13/6/16 has reported that there is 01 more mine operating or proposed within 1000 meters around the said mine with total area of 10.522 ha including this mine.

The case was presented by the PP and their consultant in the  $47^{\text{th}}$  SEAC meeting dated 27/08/2016 wherein during presentation it was observed as per the Google image of April,

2013 a culvert is in existance towards the North side of lease area at a distance of approx. 45 meters thus additional 55 meters area should be left as non-mining area in the QL. The other submissions made by PP were found satisfactory and acceptable and thus the committee decided to recommend the case for grant of prior EC subject to the following special conditions in addition to the standard conditions at annexure  $\exists B\alpha$ 

- Production of Sand as per mine plan with quantity not exceeding 82,610 cum/year.
- District Authority should record the deposition of sand in the lease area at an interval of 50 meters annually in the last week of September and maintain the records in RL (Reduce Level) Measurement Book. Accordingly authority may allow lease holder to excavate the replenished quantity of sand in the subsequent year.
- Evacuation of sand should not be allowed through the roads passing through the villages.
- Heavy vehicles (Hywa) should not be allowed on Kachcha, narrow roads.
- If causeway (Rapta) is required to be constructed for mining. It should be removed completely before rainy season every year.
- The river bank from where access ramps are made should be restored and access should be closed every year before rainy season.
- No diversion of active channel should be allowed for mining.

SEIAA vide letter no. 3552/SEIAA/16 dated 15/09/2016 has sent back the file for clarification in production capacity which was placed before the committee. Committee on perusal of the documents observed that the as per the approved mine plan and from-1, the production capacity should be 42,610 cum/year and thus 82,610 cum/year is a typographical error. Thus committee clarifies that the production capacity now should be read as 42,610 cum/year (in place of 82,610 cum/year) and other conditions will remain the same.

#### 32. <u>Case No.-4679/2015 Shri Aditya Shukla S/o Shri Mohan Shukla R/o H.I.G. D-1,</u> <u>Housing Board Colony, P.O. & District-Katni (MP)-483501 Prior Environment</u> <u>Clearance for approval of Dolomite Mine in an area of 3.42 ha. (51,503 TPA) at</u> <u>Village-Malhan, Tehsil-Badwara, District-Katni (MP)</u>

This is case of Dolomite Mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Village-Malhan, Tehsil-Badwara, District-Katni (MP) in an area of 3.42 Ha. The project requires prior EC before commencement of any activity at site. Earlier the case discussed in the 47<sup>th</sup> SEAC II meeting dated 27/08/2016 and was recommended for transfer to DEIAA.

SEIAA vide letter no. 3902/SEIAA/16 dated 06/10/2016 has sent back the file to SEAC for re-appraisal as *"it was observed from the mine plan that this is a case of dolomite and bauxite mining and should have been treated as a major mineral case"*, and the same was placed before the committee. PP has also submitted a representation vide letter dated 10/10/2016. The committee again refered the mine plan and other documents submitted by the PP and observed that:

- 1. In form-1 (point no. 2.3), PP has applied only for the dolomite mineral for production capacity of 51,503 TPA. Similarly, the PFR is also prepared only for dolomite mineral.
- 2. In mine plan Chapter õRESERVE ASSESSMEN IN GEOLOGYö it is clearly mentioned that only dolomite was found to occur in the lease area and no existence of mineral bauxite has been noticed in the lease area.
- 3. In mine plan Chapter õRESERVEö, since 1999-00 only dolomite is excavated from the ML and mineral reserves are also shown for dolomite mineral. No proposal for excavation of bauxite has been shown in the approved mine plan.

The committee after deliberations decided that as per mine plan and form-1 submitted by PP, it a case of dolomite mining and may be transferred to DEIAA through SEIAA as per GOI, MoEF&CC notification dated 15/01/2016 as the lease area is of <5.00 ha and letter no. 2859 dated 06/08/2016 issued by Deputy Director, Mining, for collector, Katni stating that other 03 mines are non-operative from > 03 years and one mine with an area of 1.20 ha is also non-operative since lease 02 years.

Annexure- 'A'

#### Standard conditions applicable to Stone/Murrum and Soil quarries:

- 1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
- 3. Transportation of material shall be done in covered vehicles.
- 4. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
- 5. Curtaining of site shall be done using appropriate media.
- 6. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement.
- 7. Transportation shall not be carried out through forest area.
- 8. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
- 9. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
- 10. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded.
- 11. PP should also maintain a log book containing annual details of tree plantation and causality replacement.
- 12. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product mix in proposed mining unit shall require a fresh Environment Clearance.
- 13. Mining should be done as per the submitted land use plan submitted by PP.

#### Annexure- 'B'

#### Standard conditions applicable for the sand Mine Quarries\*

- 1. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- 3. Plantation shall be carried out on the banks for stabilization of the banks.
- 4. The mining activity shall be done manually.
- 5. No heavy vehicles shall be allowed to enter the river bed and the transportation of the sand from the excavation pits of the leased area to the loading point shall be through trollies (tractor trollies) and not by heavy vehicles. Only registered tractor trollies which are having the necessary registration and permission for the aforesaid purpose under the Motor Vehicle Act and also insurance coverage for the same shall alone be used for said purpose.
- 6. Transport vehicles will be covered with taurpoline to minimize dust/sand particle emissions.
- 7. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
- 8. No Mining shall be carried out during Monsoon season.
- 9. The depth of mining shall be restricted to 3m or water level, whichever is less.
- 10. No in-stream mining shall be allowed.
- 11. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
- 12. Established water conveyance channels should not be relocated, straightened, or modified.
- 13. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
- 14. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
- 15. PP shall take Socio-economic activities in the region through the 'Gram Panchayat'.
- 16. EC will be valid for mine lease period subject to a ceiling of 5 years.
- 17. Mining should be done as per the submitted land use plan submitted by PP.

Annexure- 'C'

#### Standard conditions applicable for the Khodu Bharu sand Mine Quarries\*

- 1. Mining should be done only to the extent of reclaiming the agricultural land.
- 2. Only deposited sand is to be removed and no mining/digging below the ground level is allowed.
- 3. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
- 4. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
- 5. The mining activity shall be done manually.
- 6. Heavy vehicles shall not be allowed for removal of sand.
- 7. The sand shall be transported by small trolleys up to the main transport vehicle.
- 8. Transport vehicles will be covered with taurpoline to minimize dust/sand particle emissions.
- 9. No Mining shall be carried out during Monsoon season.
- 10. PP shall take Socio-economic activity in the region through the 'Gram Panchayat'.
- 11. EC will be valid for mine lease period/mine plan subject to a ceiling of 5 years.
- 12. The mining shall be carried out strictly as per the approved mining plan.
